SUBJECT: Kindergarten and Seventh Grade Immunization Status Report 2014–2015

INFORMATION ONLY

Each October, all public and private schools with a kindergarten and/or seventh-grade class are required to submit reports indicating the immunization status of their kindergarten and/or seventh-grade students. This information is compiled and sent to the Immunization Section for tabulation. Enclosures 1 through 4 are summaries of kindergarten data, and enclosures 5 through 8 are summaries of seventh-grade data for the 2014–2015 school year. This information reflects immunization coverage for 228,982 kindergarten students and 223,418 seventh-grade students.

Purpose:

- To decrease the occurrence of vaccine-preventable diseases by increasing immunization coverage levels among school-age children.
- To emphasize the importance of immunizations to all our community partners, including public, private and parochial schools, especially in light of the recent nationwide measles outbreak.
- To ensure the enforcement of Chapter 64D-3.046, *Florida Administrative Code*, and section 1003.22, *Florida Statutes (F.S.)*, regarding immunization. Florida law states students may not attend school without proper documentation. Schools permitting said students are in violation of the state law, and should exclude said students from school until adequate documentation is provided. (Exceptions: The school may issue temporary exemptions for up to 30 days for (1) students transferring intrastate or interstate, (2) a homeless child; (3) juvenile justice system entry; and (4) children of military families as defined in Section 1000.36, *F.S.*)
- To identify those counties needing assistance in raising their immunization coverage levels in kindergarten and seventh grade to Florida's goal of 95 percent. The national goal for kindergarten and seventh grade is 95 percent and 90 percent, respectively.

Results – Kindergarten:

Statewide, 93.3 percent of kindergarten students were reported as receiving all immunizations (listed below) required for school entry/attendance:

- Four or five doses of diphtheria, tetanus, pertussis (DTaP) vaccine
- Three, four or five doses of polio vaccine
- Two doses of measles, mumps and rubella (MMR) vaccine
- Three doses of hepatitis B vaccine
- Two doses of varicella vaccine

Of Florida's 67 counties, 40, or 59.7 percent, achieved or exceeded the 95 percent state goal of kindergarten students receiving all required immunizations upon school entry/attendance. Statewide, 254 students, or 0.1 percent had inadequate immunizations and/or documentation of immunizations. Students with exemptions from immunization accounted for 6.6 percent of the total kindergarten population, as reflected below:

- 6,643 temporary medical exemptions, or 2.9 percent
- 745 permanent medical exemptions, or 0.3 percent
- 4,113 religious exemptions, or 1.8 percent
- 3,686 30-day exemptions, or 1.6 percent

Results – Seventh Grade:

Statewide, 95.7 percent of seventh-grade students were reported as receiving all immunizations required for school entry/attendance, including but not limited to:

- Completion of the hepatitis B series
- Two doses of measles, mumps and rubella (preferably as MMR)
- One dose of varicella
- One dose of tetanus-diphtheria-pertussis (Tdap)

Fifty-nine of 67 counties, or 88.1 percent, achieved or exceeded the 95 percent state goal of seventh-grade students receiving all required immunizations. Statewide, 408 students, or 0.2 percent, had inadequate immunizations and/or documentation of immunizations. Students with exemptions from immunization accounted for 4.1 percent of the total seventh-grade population, as reflected below:

- 4,035 temporary medical exemptions, or 1.8 percent
- 592 permanent medical exemptions, or 0.3 percent
- 2,533 religious exemptions, or 1.1 percent
- 1,998 30-day exemptions, or 0.9 percent

The percent of kindergarten temporary medical exemptions, statewide, is at an all-time low with 2.9 percent. For the second consecutive year, seventh grade's temporary medical exemption rate is below two percent. Florida is making great strides in decreasing temporary medical exemption rates.

It is important to remember 30-day exemptions should only be issued to students with qualifying exceptions as noted in *Purpose* (bullet 2) on Page One. Inadequately immunized, non-transfer students

should be permitted school entry or attendance only after presenting proper documentation of vaccination. The school health nurse or authorized school official is responsible for follow-up of children with temporary medical and 30-day exemptions, and ensuring children complete the immunization series.

Collaboration between the school's health nurse and administration to update electronically submitted immunization data is encouraged. Using a reminder system to recall students in need of immunization has shown to increase coverage rates; Tdap and hepatitis B in particular. Continue to partner with schools, school districts, managed care organizations and private healthcare providers to promote the *Standards for Child and Adolescent Immunization Practices*.

We also encourage you to contact your local area field staff representative to assist with identifying areas of need and developing strategies for increasing your county's school immunization rates. Collaborative efforts will help us reach our state school coverage goal and enable us to achieve our common goal of providing the best protection possible against vaccine-preventable diseases.

The Immunization Section would like to thank our community partners, especially the Florida Department of Education, school districts and the local schools for their efforts regarding the compulsory school immunization law thereby assisting in the decrease of vaccine-preventable diseases.
