Clinic Immunization Coverage Levels (2009)

FOR INFORMATION ONLY

In February 2009, the annual county health department (CHD) assessment of immunization coverage levels for one- and two-year-old children receiving services in their facilities was completed. This assessment identifies areas where CHDs can focus their efforts to improve immunization coverage levels for children 12 to 35 months of age, thereby meeting the 90% national and statewide immunization coverage goal.

The Florida State Health Online Tracking System (SHOTS) provided the data for this assessment, which consists of all active records of children 12 to 23 months of age and children 24 to 35 months of age, respectively, with a common review date of January 6, 2009. The results are based on recommendations of the Advisory Committee on Immunization Practices (ACIP), which require that:

- All children between 24 and 35 months of age complete the 4:3:1:3:3:1
 (4 DTaP, 3 Polio, 1 MMR, 3 Hib, 3 Hep B, and 1 Varicella) immunization series by 24 months of age.
- All children between 12 and 23 months of age complete the 3:2:2:2 (3 DTaP, 2 Polio, 2 Hib, and 2 Hepatitis B) immunization series by 12 months of age.

The results show (in Attachments 1 and 2) that 87% of CHD clients completed the 4:3:1:3:3:1 series by 24 months of age, which is a 5% increase from last year. In addition to the increased overall state coverage rate, 25 counties achieved coverage levels over 90%, with six of these CHDs attaining 100% immunization coverage levels.

Beginning this survey year, coverage rates based on the 4:3:1:3:3:1:3 (4 DTaP, 3 Polio, 1 MMR, 3 Hib, 3 Hep B, 1 Varicella, and 3 PCV) immunization series were also measured. These results show that 86% of CHD clients completed this series by 24 months of age. CHDs are to be commended for their hard work in protecting Florida's children against vaccine-preventable diseases, and for achieving levels exceeding our 90% national and statewide goal.

While the immunization coverage levels for two-year-olds have increased from last year's rate, CHDs must continue to focus their efforts on children 12 to 23 months of age. The assessment results for this age group, as portrayed in Attachment 2, shows that 82% completed the 3:2:2:2 series by 12 months of age.

This data shows that failure to administer the fourth dose of DTaP is one of the main reasons we have not achieved the 90% coverage objective in Florida. The assessment results also identify other areas where CHDs can focus efforts to improve coverage levels. Both clinic and countywide results (Attachments 3 and 4) should serve as a critical component of ongoing quality assurance reviews. CHD staff should routinely generate assessment reports via the Florida SHOTS to assess immunization coverage levels and evaluate service delivery.

Assessments provide data about vaccine delivery practices and vaccine coverage that both motivate and assist staff with developing and implementing best practices. In addition, Standard 16 of the *Standards for Child and Adolescent Immunization Practices* promotes semi-annual audits to assess immunization coverage levels and a review of immunization records in the provider's patient population.

To exceed the Department's immunization coverage goal of 90% among our one- and twoyear-old children consistently, and in working toward meeting future coverage goals, CHDs must focus their efforts and resources in the following key areas:

- Fully implement the CHD Guidebook's immunization internal operating policies and technical assistance guidelines
- Develop effective strategies for achieving high, sustainable vaccine coverage levels
- Assess the impact of intervention and service delivery practices
- Use all clinic encounters to assess immunization status and provide appropriate immunizations

Additionally, we encourage you to contact your Bureau of Immunization Field Staff to assist with identifying areas of need and develop strategies for increasing your immunization rates.
