"Pipeworx", "Septicworx", and "Bio Drain of Florida"

Dear Dr. Reuter:

This letter is to acknowledge receipt of information concerning the products "The Septic Tank", "BioBen", BioSmart", "Pipeworx", "Septicworx", and "Bio Drain of Florida" for statewide use in Florida. No product sold in the state for use in onsite sewage treatment and disposal systems may contain any substances in concentrations or amounts that would interfere with or prevent the successful operation of such system, or that would cause discharges from such systems to violate applicable water quality standards, section 381.0065(4)(m), Florida Statutes.

The staff has reviewed the information and verified that the additional products have the same formulation as the authorized "BioOne®". Since the department had determined in a previous evaluation that reformulated "BioOne®" was in compliance with s. 381.0065(4)(m), F.S. and that the new labeled products have the same ingredients, formulation, and application rate as the reformulated "BioOne®" product, the department has no objection to the use of the products "The Septic Tank", "BioBen", BioSmart", "Pipeworx", "Septicworx", and "Bio Drain of Florida" in accordance with manufacturer's specifications. Please be advised that all rules pertaining to the use of the product shall be observed and that there shall be no advertising of the product as state approved



This letter of product compliance is limited to Department of Health jurisdictional circumstances as defined in Chapter 64E-6, Florida Administrative Code and Chapter 381 0065, Florida Statutes.
