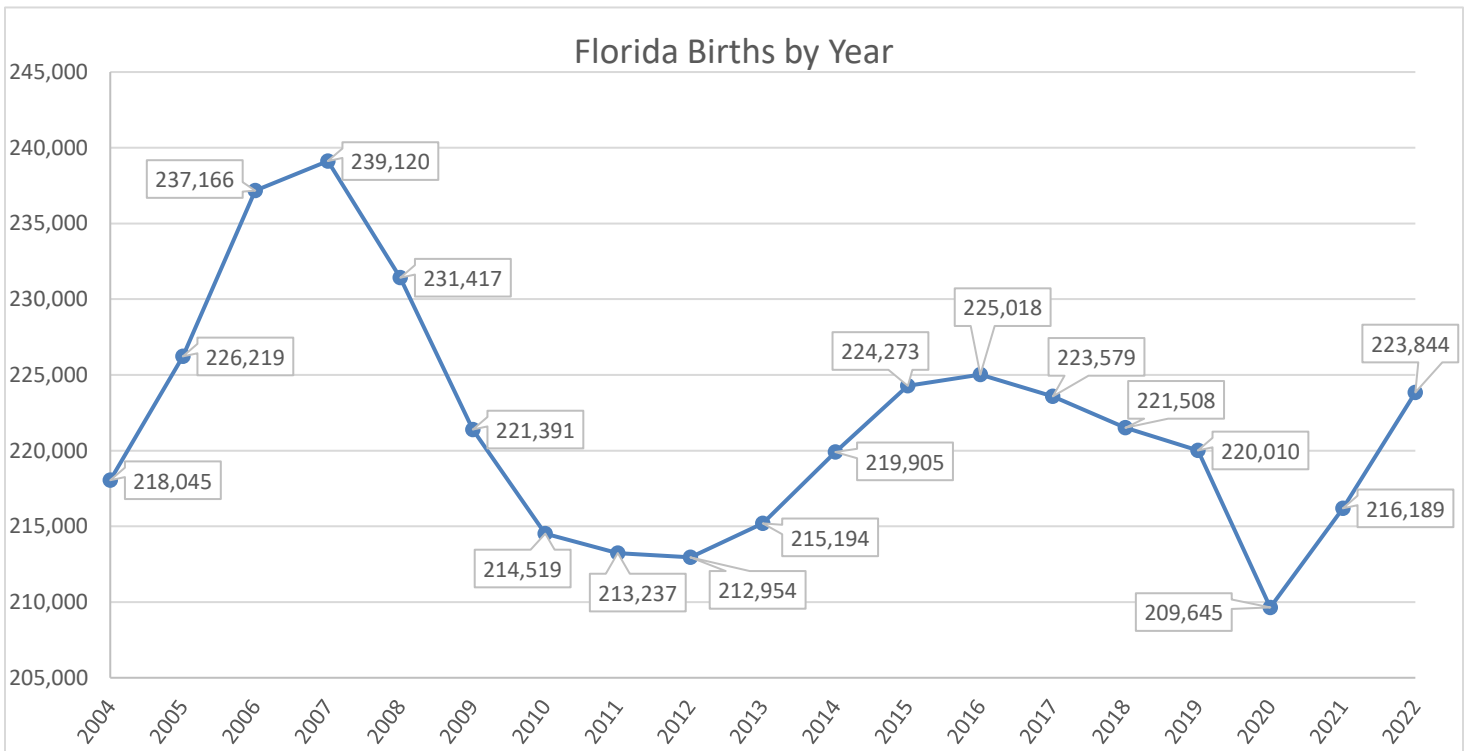


Newborn Screening

The Newborn Screening (NBS) Laboratory in Jacksonville receives about 275,000 specimens annually from babies born in Florida to test for genetic disorders using tandem mass spectrometry, high performance liquid chromatography, fluorometric analyzers and DNA mutation analyses. Early detection is the primary objective of newborn screening in Florida's effort to ensure that all newborns are screened. BPHL-Jacksonville has implemented procedures for immediate detection and timely reporting of presumptive abnormal results to Children's Medical Services, hospitals, physicians and birthing centers. NBS testing helps to ensure affected babies receive immediate follow-up and adequate medical care. Most results are reported within 24 to 48 hours of receipt. The NBS laboratory operates 6 days a week, 52 weeks a year. The NBS Laboratory tests for 35 core conditions and 22 secondary conditions (a total of 58 conditions, 53 of which are included in the Recommended Uniform Screening Panel approved by the US Secretary of the Department of Health and Human Services)
