**Tallahassee, Fla.**—The Florida Department of Health Division of Medical Quality Assurance issued 24 Emergency Suspension Orders (ESOs) and Emergency Restriction Orders (EROs) in May 2016 for serious violations, which could include the commission of crimes, violations of standards of care, drug use, impairment, drug diversion, sexual misconduct or student loan defaults.
