

Florida Arbovirus Surveillance Week 19: May 9-15, 2021

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), and St. Louis encephalitis virus (SLEV), as well as exotic viruses such as dengue virus (DENV), chikungunya virus (CHIKV), Zika virus (ZIKV), and California encephalitis group viruses (CEV). Malaria, a parasitic mosquito-borne disease is also included. During the period of May 9-15, 2021, the following arboviral activity was recorded in Florida.

WNV activity: No human cases of WNV infection were reported this week. No horses with WNV infection were reported this week. No sentinel chickens tested positive for antibodies to WNV this week. In 2021, positive samples from two sentinel chickens have been reported from two counties.

SLEV activity: No human cases of SLEV infection were reported this week. No sentinel chickens tested positive for antibodies to SLEV this week. In 2021, positive samples from two sentinel chickens have been reported from one county.

EEEV activity: No human cases of EEEV infection were reported this week. No horses with EEEV infection were reported this week. Thirteen sentinel chickens tested positive for antibodies to EEEV this week in Citrus, Indian River, Pasco, Volusia and Walton counties. In 2021, positive samples from three horses and 47 sentinel chickens have been reported from nine counties.

International Travel-Associated Dengue Fever Cases No cases of dengue fever were reported this week in persons that had international travel. In 2021, three travel-associated dengue fever case have been reported.

Dengue Fever Cases Acquired in Florida: No cases of locally acquired dengue fever were reported this week. In 2021, no cases of locally acquired dengue fever have been reported.

International Travel-Associated Chikungunya Fever Cases: No cases of chikungunya fever were reported this week in persons that had international travel. In 2021, no travel-associated chikungunya fever cases have been reported.

Chikungunya Fever Cases Acquired in Florida: No cases of locally acquired chikungunya fever were reported this week. In 2021, no cases of locally acquired chikungunya fever have been reported.

International Travel-Associated Zika Fever Cases: No cases of Zika fever were reported this week in persons that had international travel. In 2021, no travel-associated Zika fever cases have been reported.

Zika Fever Cases Acquired in Florida: No cases of locally acquired Zika fever were reported this week. In 2021, no cases of locally acquired Zika fever have been reported.

Advisories/Alerts: Citrus County is currently under a mosquito-borne illness advisory. Broward County is currently under a mosquito-borne illness alert. No other counties are currently under mosquito-borne illness advisory or alert. A Level 1 Travel Health Notice has been issued for Central and South America, Mexico, the Caribbean, Asia, the Pacific Islands, Africa, and the Middle East related to the transmission of dengue virus, and for Burundi related to malaria transmission. A Level 2 Travel Health Alert has been issued for Nigeria related to the transmission of yellow fever virus. 2021 Human Case Summary*

International Travel-Associated Dengue Fever Cases: Three cases with onset in 2021 have been reported in individuals with travel history to a dengue endemic area in the two weeks prior to onset. Counties reporting cases were: Miami-Dade (1) and Palm Beach (2): Please see the table below for a breakdown of case by country of origin and serotype.

International Travel-Associated Malaria Cases: Three cases of malaria with onset in 2021 have been reported. Countries of origin were: Ethiopia, Sierra Leone and Venezuela. Counties reporting cases were: Miami-Dade, Duval and Seminole. One case involved a non-Florida Resident.


Two cases (67%) were diagnosed with *Plasmodium falciparum*. One case (33%) was diagnosed with *Plasmodium vivax*.


*Veterinary cases are reported by date of onset. Only mammalian veterinary cases are included in the graphs.

Veterinary EEEV Disease in Florida, May 2020-2021




Sentinel Chickens*


Thirteen sentinel chickens tested positive for antibodies to EEEV this week in Citrus, Indian River, Pasco, Volusia and Walton counties.

Dead Birds


The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, eight reports representing a total of 17 dead birds, including one raptor, were received from eight counties.


In 2021, 215 reports representing a total of 517 dead birds (18 crows, 5 jays, 49 raptors, 47 doves) were received from 42 of Florida's 67 counties.

Case tallies included in the weekly Florida arbovirus surveillance report include confirmed and probable cases for EEE, WNV infection, SLE, dengue, chikungunya, and malaria by date of onset. Suspect cases are not included. Activity is mapped by county of exposure rather than county of residence. Case definitions being used in Florida are consistent with national criteria provided by the Council of State and Territorial Epidemiologists (CSTE) and may be viewed at: https://www.floridahealth.gov/diseases-and-conditions/disease-reporting-and-management/disease-reporting-and-surveillance/index.html. Case tallies reported by CDC do not include suspect cases and cases are reported by patient state of residence rather than where the exposure occurred. Data is provided by county health departments, Department of Health Bureau of Public Health Laboratories, Department of Agriculture and Consumer Services, mosquito control agencies, Florida Fish and Wildlife Conservation Commission, medical providers and veterinarians. Equine cases are provided by the Department of Agriculture and Consumer Services.
