

Florida Arbovirus Surveillance Week 43: October 24-30, 2021

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), and St. Louis encephalitis virus (SLEV), as well as exotic viruses such as dengue virus (DENV), chikungunya virus (CHIKV), Zika virus (ZIKV) and California encephalitis group viruses (CEV). Malaria, a parasitic mosquito-borne disease is also included. During the period of October 24-30, 2021, the following arboviral activity was recorded in Florida.

WNV activity: No human cases of WNV infection were reported this week. No horses with WNV infection were reported this week. Fourteen sentinel chickens tested positive for antibodies to WNV this week in Alachua, Duval, Lee, Martin, Nassau, Sarasota, and Walton counties. In 2021, positive samples from four humans, two horses, 123 sentinel chickens, and eight mosquito pools have been reported from 20 counties.

SLEV activity: No human cases of SLEV infection were reported this week. Two sentinel chickens tested positive for antibodies to SLEV this week in Lee County. In 2021, positive samples from 12 sentinel chickens and one mosquito pool have been reported from six counties.

Flavivirus (WNV or SLEV)* activity: Eight sentinel chickens tested positive for antibodies to a flavivirus this week in Lee, Nassau, Martin, St. Lucie, St. Johns, and Walton counties. In 2021, positive samples from 75 sentinel chickens have been reported from 16 counties.

EEEV activity: No human cases of EEEV infection were reported this week. One horse with EEEV infection was reported this week in Lake County. Two sentinel chickens tested positive for antibodies to EEEV this week in Orange County. In 2021, positive samples from 18 horses, 178 sentinel chickens, and one emu have been reported from 30 counties.

International Travel-Associated Dengue Fever Cases One case of dengue fever was reported this week in a person that had international travel. In 2021, 11 travel-associated dengue fever cases have been reported.

Dengue Fever Cases Acquired in Florida: No cases of locally acquired dengue fever were reported this week. In 2021, no cases of locally acquired dengue fever have been reported.

International Travel-Associated Chikungunya Fever Cases: No cases of chikungunya fever were reported this week in persons that had international travel. In 2021, one travel-associated chikungunya fever case has been reported.

Chikungunya Fever Cases Acquired in Florida: No cases of locally acquired chikungunya fever were reported this week. In 2021, no cases of locally acquired chikungunya fever have been reported.

International Travel-Associated Zika Fever Cases: No cases of Zika fever were reported this week in persons that had international travel. In 2021, no travel-associated Zika fever cases have been reported.

Zika Fever Cases Acquired in Florida: No cases of locally acquired Zika fever were reported this week. In 2021, no cases of locally acquired Zika fever have been reported.

Advisories/Alerts: Bay, Citrus, Jefferson, Nassau, Orange, Palm Beach, Pasco and Walton counties are currently under a mosquito-borne illness advisory. Collier County is currently under a mosquito-borne illness alert. No other counties are currently under mosquito-borne illness advisory or alert. A Level 1 Travel Health Notice has been issued for Central and South America, Mexico, the Caribbean, Asia, the Pacific Islands,

Africa, and the Middle East related to the transmission of dengue virus, for Burundi related to malaria transmission and for Chad related to Leishmaniasis. A Level 2 Travel Health Alert has been issued for Nigeria related to the transmission of yellow fever virus. 2021 Human Case Summary

West Nile Virus Illnesses Acquired in Florida: Four human cases of WNV illness acquired in Florida have been reported in 2021: three in Collier County (August) and one in Miami-Dade (July) County.

International Travel-Associated Chikungunya Fever Cases: One case of chikungunya fever with onset in 2021 has been reported in an individual with travel history to a chikungunya endemic country in the two weeks prior to onset. Country of origin was: Brazil. Country reporting the case was: Broward.

International Travel-Associated Dengue Fever Cases: Eleven cases with onset in 2021 have been reported in individuals with travel history to a dengue endemic area in the two weeks prior to onset. Counties reporting cases were: Broward, Hernando (2), Hillsborough, Miami-Dade (3), Monroe, and Palm Beach (3): One case was reported in a non-Florida resident. In 2021, eight cases of dengue reported in Florida have been serotyped by PCR. Please see the table below for a breakdown of case by country of origin and serotype.


International Travel-Associated Malaria Cases: Thirty-five cases of malaria with onset in 2021 have been reported. Countries of origin were: Cameroon (4), Côte D'Ivoire, Ethiopia, Ghana (6), Kenya, Liberia (3), Mali, Mozambique, Nigeria (7), Sierra Leone (5), Tanzania, Togo, Uganda (2) and Venezuela. Counties reporting cases were: Alachua (2), Brevard (2), Broward (5), Duval (5), Miami-Dade (5), Orange (2), Osceola (2), Palm Beach (3), Pinellas (2), Polk (3), Seminole (3) and St. Johns. Four cases were reported in non-Florida residents.

Thirty-two cases (91%) were diagnosed with *Plasmodium falciparum*. One case (3%) was diagnosed with *Plasmodium ovale*. One case (3%) was diagnosed with *Plasmodium vivax*.


Veterinary Cases**

^{**}Veterinary cases are reported by date of onset. Only mammalian veterinary cases are included in the graphs.


Sentinel Chickens

The table below is for the reporting of confirmatory laboratory results from this week. Some of the samples were collected at earlier dates. The date of collection is recorded for samples collected on that day along with the total number of positives and the corresponding seroconversion rate for the week the sample was collected.


Fourteen sentinel chickens tested positive for antibodies to WNV this week in Alachua, Duval, Lee, Martin, Nassau, Sarasota, and Walton counties. Two sentinel chickens tested positive for antibodies to SLEV this week in Lee County. Two sentinel chickens tested positive for antibodies to EEEV this week in Orange County. Eight sentinel chickens tested positive for antibodies to a flavivirus this week in Lee, Nassau, Martin, St. Lucie, St. Johns, and Walton counties.

Dead Birds


The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, three reports representing a total of eight dead birds, including six doves, were received from three counties.


In 2021, 456 reports representing a total of 1,096 dead birds (64 crows, 28 jays, 91 raptors, 140 doves) were received from 50 of Florida's 67 counties.

^{*}Seventy-five chickens have tested positive for flavivirus antibodies and require additional specialized testing to distinguish between WNV and SLEV antibodies. Testing is currently delayed due to supply chain issues. The final determination of these birds will be updated as more information becomes available. In Florida, both WNV and SLEV have similar disease vectors and epidemiology. Seroconversion rates for flavivirus are included in the table.

Case tallies included in the weekly Florida arbovirus surveillance report include confirmed and probable cases for EEE, WNV infection, SLE, dengue, chikungunya, and malaria by date of onset. Suspect cases are not included. Activity is mapped by county of exposure rather than county of residence. Case definitions being used in Florida are consistent with national criteria provided by the Council of State and Territorial Epidemiologists (CSTE) and may be viewed at: https://www.floridahealth.gov/diseases-and-conditions/disease-reporting-and-management/disease-reporting-and-surveillance/index.html. Case tallies reported by CDC do not include suspect cases and cases are reported by patient state of residence rather than where the exposure occurred. Data is provided by county health departments, Department of Health Bureau of Public Health Laboratories, Department of Agriculture and Consumer Services, mosquito control agencies, Florida Fish and Wildlife Conservation Commission, medical providers and veterinarians. Equine cases are provided by the Department of Agriculture and Consumer Services.
