

The Department of Health HIV/AIDS Section and members from the Florida Comprehensive Planning Network Medication Access Committee and Community HIV/AIDS Group developed the Provider Capacity Survey to determine how HIV care providers in our communities will respond to injectable antiretroviral (ARV) therapy as a new therapeutic option. Ryan White Part A and B lead agencies distributed the survey to providers.

We obtained 74 completed surveys: 42 from Ryan White Part A recipients and 32 from Ryan White Part B recipients. Following are the results from these surveys.

Summary: Most respondents are practitioners or medical staff, associated with the health department or a federally qualified health care center, and associated with a Ryan White provider. Over 50 percent of respondents provide care for 21–500 people with HIV. A significant majority of respondents indicate readiness to provide injectable ARV therapy. About half of the respondents anticipate 25 percent or more of their patients would benefit from long-acting injectable ARVS, and about half of respondents would start the use of these medications either immediately or within 3–6 months of availability. Most respondents reported clients already expressing an interest in long-acting injectable ARVs.













































#### Do you see other potential limitations with the provision of long acting injectable ARVs?
