



## Florida Arbovirus Surveillance Week 10: March 1-7, 2020

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), and St. Louis encephalitis virus (SLEV), as well as exotic viruses such as dengue virus (DENV), chikungunya virus (CHIKV), Zika virus (ZIKV), and California encephalitis group viruses (CEV). Malaria, a parasitic mosquito-borne disease is also included. During the period of March 1-7, 2020, the following arboviral activity was recorded in Florida.

**WNV activity:** No human cases of WNV infection were reported this week. No horses with WNV infection were reported this week. No sentinel chickens tested positive for antibodies to WNV this week. In 2020, 30 sentinel chickens have been reported from nine counties.

**SLEV activity:** No human cases of SLEV infection were reported this week. No sentinel chickens tested positive for antibodies to SLEV this week. In 2020, no positive samples have been reported.

**EEEV activity:** No human cases of EEEV infection were reported this week. No horses with EEEV infection were reported this week. Three sentinel chickens tested positive for antibodies to EEEV this week in Orange and Volusia counties. In 2020, 10 sentinel chickens, one horse, and one mosquito pool have been reported from five counties.

**International Travel-Associated Dengue Fever Cases:** No cases of dengue fever were reported this week in persons that had international travel. In 2020, seventeen travel-associated cases have been reported.

**Dengue Fever Cases Acquired in Florida:** One case of locally acquired dengue fever was reported this week in Monroe County. In 2020, one case of locally acquired dengue fever has been reported.

**International Travel-Associated Chikungunya Fever Cases:** No cases of chikungunya fever were reported this week in persons that had international travel. In 2020, no travel-associated chikungunya fever cases have been reported.

**Chikungunya Fever Cases Acquired in Florida:** No cases of locally acquired chikungunya fever were reported this week. In 2020, no cases of locally acquired chikungunya fever have been reported.

**International Travel-Associated Zika Fever Cases:** No cases of Zika fever were reported this week in persons that had international travel. In 2020, no travel-associated Zika fever cases have been reported.

**Zika Fever Cases Acquired in Florida:** No cases of locally acquired Zika fever were reported this week. In 2020, no cases of locally acquired Zika fever have been reported.

**Advisories/Alerts:** Monroe County is currently under a mosquito-borne illness advisory. Miami-Dade County is currently under a mosquito-borne illness alert. No other counties are currently under mosquito-borne illness advisory or alert.

There is a Level 2 Travel Health Notice for Nigeria related to the transmission of yellow fever virus. There are also Level 1 Travel Health Notices for Central and South America, Mexico, the Caribbean, Asia, the Pacific Islands, Africa, and the Middle East related to the transmission of dengue virus, for Burundi related to Malaria transmission, and for Ethiopia related to chikungunya transmission. ## 2020 Human Case Summary\*

### International Travel-Associated Dengue Fever Cases

Seventeen cases of dengue fever with onset in 2020 have been reported in individuals with travel history to a dengue endemic area in the two weeks prior to onset. Counties reporting cases were: Brevard, Broward (5), Franklin, Hillsborough (3), Miami-Dade (5), Seminole, and St. Lucie. Two cases were reported in non-Florida residents. In 2020, sixteen cases of dengue reported in Florida have been serotyped by PCR. Please see the table below for a breakdown of cases by country of origin and serotype.

**Dengue Fever Cases Acquired in Florida:** In 2020, one case of locally acquired dengue fever has been reported in Monroe County, with onset in February. The case was reported in a non-Florida resident.

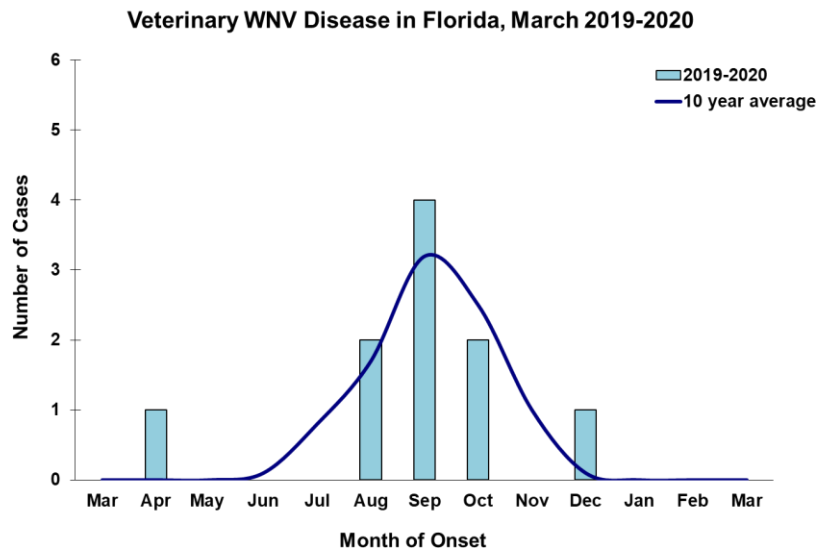
**International Travel-Associated Malaria Cases:** Four cases of malaria with onset in 2020 have been reported. Countries of origin were: Cameroon, Dominican Republic, Nicaragua, and Nigeria. Counties reporting cases were: Miami-Dade (2), Orange, and Polk. One case was reported in a non-Florida resident.

Three cases (75%) were diagnosed with *Plasmodium falciparum*. One case (25%) was diagnosed with *Plasmodium vivax*.

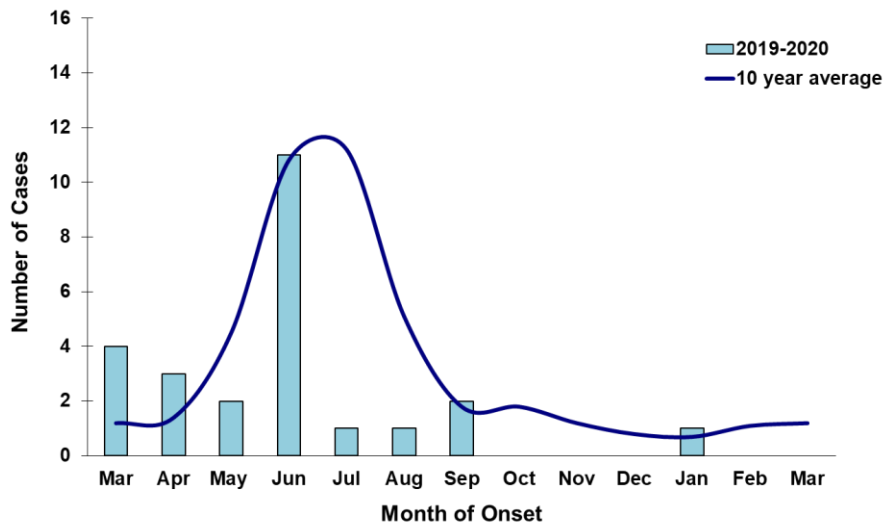
## Veterinary Cases\*

### Veterinary EEEV Disease in Florida, March 2019-2020



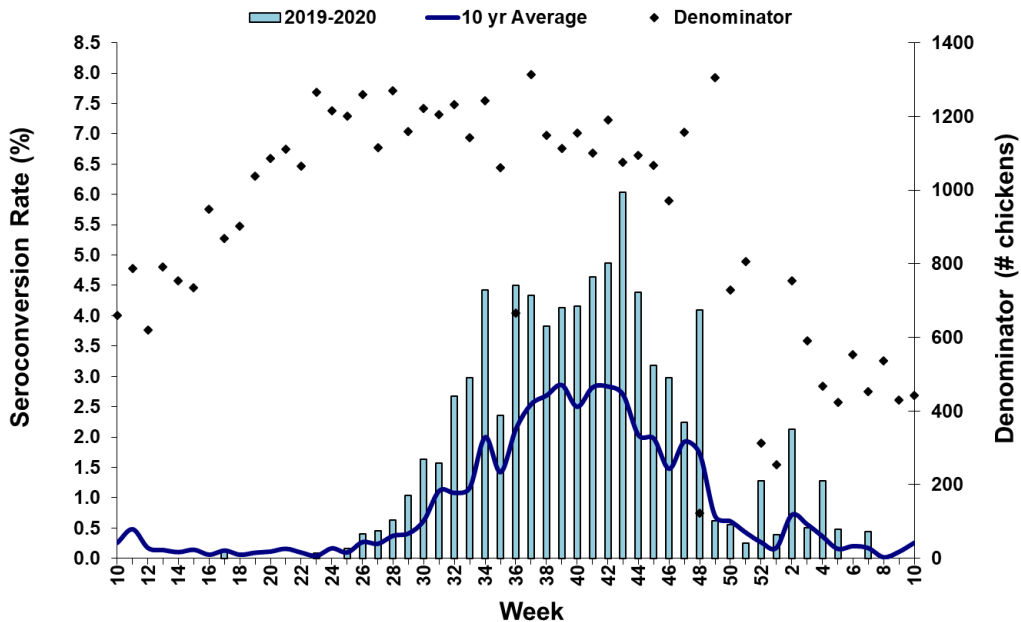
### Sentinel Chickens\*

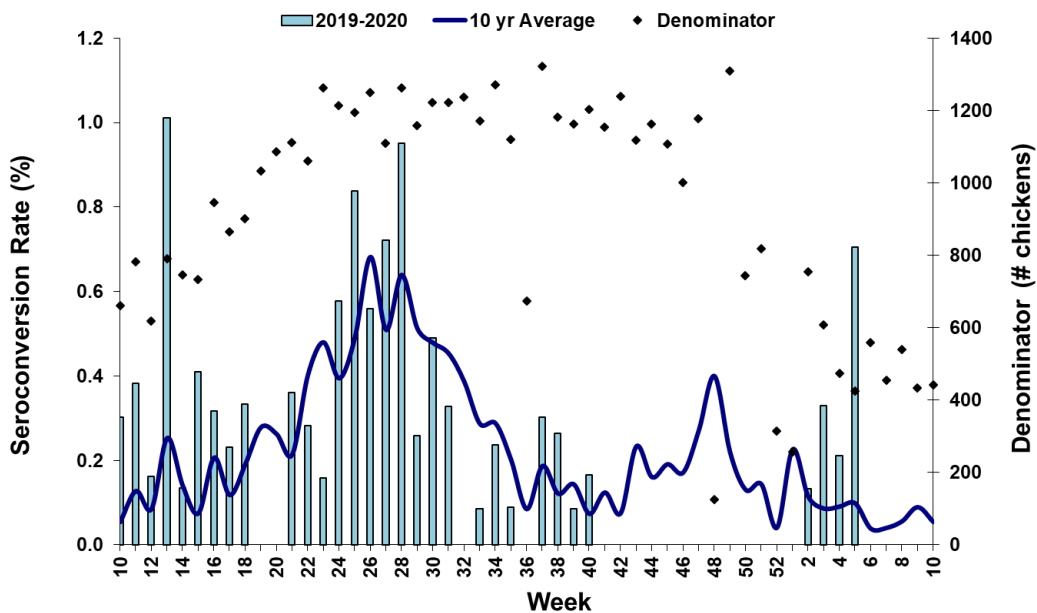

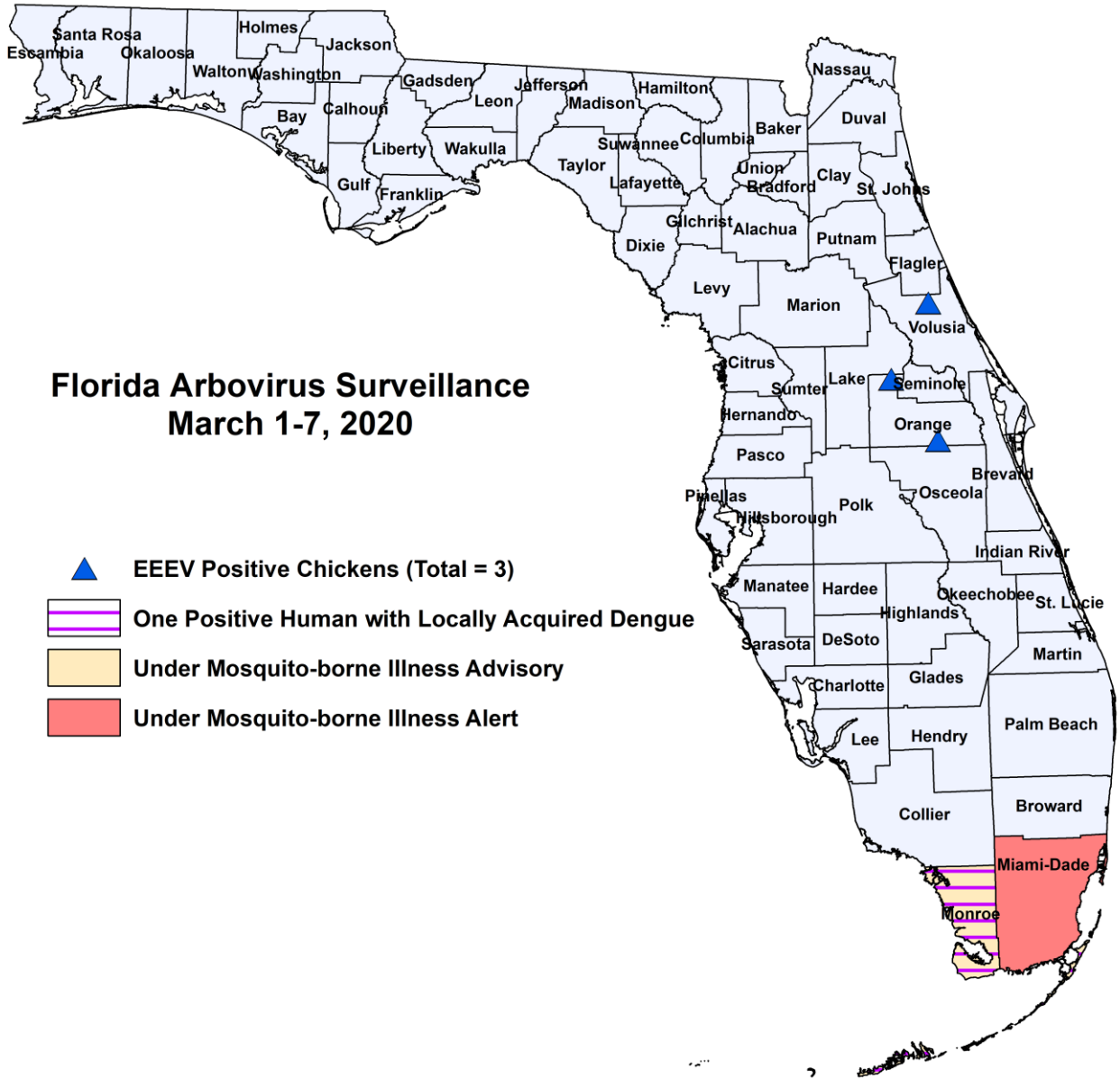
### Dead Birds

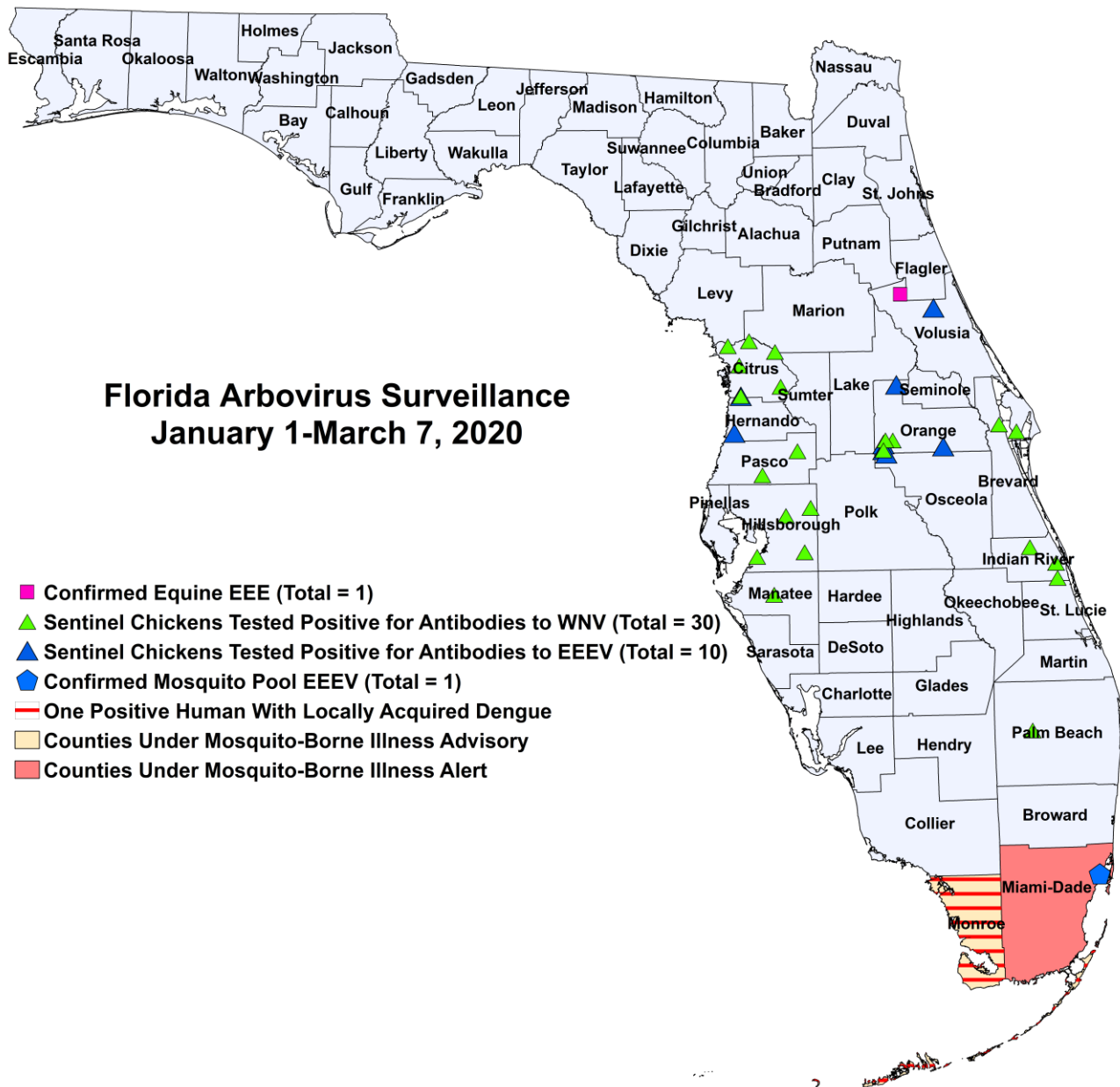
The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, six reports representing a total of 36 dead birds, including one crow, one raptor, and six doves, were received from six counties.

In 2020, 78 reports representing a total of 218 dead birds (17 crows, 1 jay, 18 raptors, 6 doves) were received from 27 of Florida's 67 counties.

Case tallies included in the weekly Florida arbovirus surveillance report include confirmed and probable cases for EEE, WNV infection, SLE, dengue, chikungunya, and malaria by date of onset. Suspect cases are not included. Activity is mapped by county of exposure rather than county of residence. Case definitions being used in Florida are consistent with national criteria provided by the Council of State and Territorial Epidemiologists (CSTE) and may be viewed at: [www.floridahealth.gov/diseases-and-conditions/disease-reporting-and-management/disease-reporting-and-surveillance/index.html](http://www.floridahealth.gov/diseases-and-conditions/disease-reporting-and-management/disease-reporting-and-surveillance/index.html). Case tallies reported by CDC do not include suspect cases and cases are reported by patient state of residence rather than where the exposure occurred. Data is provided by county health departments, Department of Health Bureau of Public Health Laboratories, Department of Agriculture and Consumer Services, mosquito control agencies, Florida Fish and Wildlife Conservation Commission, medical providers and veterinarians. Equine cases are provided by the Department of Agriculture and Consumer Services.
