DO NOT EAT THE FISH!





St. Johns River Fish Advisory Near the Kerr-McGee Hazardous Waste Site Jacksonville, Florida August 2018



What do I need to know?

Fish tissues sampled on April 2017 upon a request by the Florida Department of Environment Protection along the west bank of the St. John's River (near the Kerr-McGee hazardous waste site at 1611 Tallyrand Avenue) were contaminated with:

- pesticides,
- polychlorinated biphenyls (PCBs), and
- mercury.

What do I need to be concerned about?

Consumption of contaminated fish may harm your health.

What can I do to protect myself?




Figure 1: Fish advisory area along St. Johns River, north of Matthews Bridge to south of E 21 St (Center Point Terminal Co.).

A "**Do Not Eat Fish**" advisory is recommended and signs applied within the area of the St. Johns River from just north of the Route 115 Bridge or Mathews Bridge (upstream of the Site) to south of E 21 St (Center Point Terminal Co.) [See Figure 1 next page].

What will the Department of Health do?

- Follow up with the recommendation.
- Collect and document health concerns of nearby residents and other community members.
- Address public comments in a final report.
- Will inform you when the fish advisory is lifted.

The Department is now seeking public review and comment of the toxicology report. Comments are due by September 30, 2018.
