Failure to satify the department that:

Any perceived hardship that you might experience as a result of the obligation to meet the variance provisions comes about as a direct result of your own action.

Your decision to place the turnaround driveway and install the system 49.5 feet from the private drinking water well is a hardship of your own making.

Each of the above facts and conclusions, standing alone, is sufficient grounds for denial of your variance request. The variance proposal would create a likelihood that the onsite system discharge may adversely

affect the health of the applicant.

It is not unreasonable for you to modify your onsite sewage treatment and disposal system to meet the variance provisions granted on October 11, 2016.
