SHO: Field visit confirmed that drainfield is below the EWSWT.

The drainfield currently sits in the water table during the wet season and during times when the water table is high. At those times, the present system discharges sewage effluent directly into the groundwater.

This variance proposal would significantly degrade the groundwater. It is not unreasonable to require you to modify your onsite system to meet the minimum standards for sewage treatment under Florida

Administrative Code.
