Ms. Alfonso did apply to reinstate her license in June of 2011 and submitted at that time court documentation, which upon review by the Council's attorney, was found to be prohibitive to licensure under Section 456.0635, F.S. Upon notification of this finding to Ms. Alfonso, she

- 19 Ms. Alfonso has submitted a new application for licensure along with correspondence from her
- 20 legal representative, Mr. Joel A. Bellow, Esquire, in which it is asserted that, under the new
- changes to Section 456.0635, F.S. (pursuant to the passage of HB 653(2012)), the applicant is
- 22 now eligible for licensure.

Provided for the Council's review was Ms. Alfonso's current and previous applications and courtdocumentation.

- 1 Following discussion, the Council requested that Ms. Alfonso provide personal statements and
- 2 letters of recommendation from persons with whom she is associated, the outcome of drug
- 3 court and any documents detailing the time spent during and after her drug charges.
- 4 **MOTION:** Dr. Max Wilson moved to table further consideration of the application. Ms. Susan 5 Manwaring seconded the motion, which carried 4/0.
- 6 Ms. Alfonso stated that she was willing to re-take the examination again and also waived the 90
- days for action on her application to allow time for the Council to review the additional 7 8 documentation requested.
