### B. Rulemaking To Implement Law

Rulemaking is necessary and mandatory to implement the newly enacted amendment to §465.189, *Florida Statutes*. To implement the legislative policy, the Board must engage rulemaking to adopt an application form for Registered Pharmacy Interns to utilize who wish to be certified to administer vaccines. §§120.54(1) and (16), Fla. Stat. (2015). The Board must also engage in mandatory rulemaking to approve the 20 hours of continuing education classes that the Registered Pharmacy Intern must take to be certified to administer vaccines. §465.189(6), Fla. Stat. (2015).
