## FEDERATION OF STATE MEDICAL BOARDS RELEASES ITS ANNUAL SUMMARY OF BOARDS ACTIONS

The Federation of State Medical Boards released its Annual Summary of Board Actions, a compilation of disciplinary actions taken by its member boards. The Federation is a national non-profit organization representing 70 medical boards within the United States and its territories. It assists state medical boards in protecting the public's health, safety and welfare through promotion of high standards for physician licensure and regulation.

The report also includes physician populations, standard of proof required for taking disciplinary actions, and a Composite Action Index (CAI) for each member board. This index is a weighted average of actions taken by medical boards. All actions affecting a physician's license are considered, however, more serious discipline such as a revocation or suspension, are weighted more heavily. The report provides a barometer of disciplinary activity to help states track disciplinary trends within their state over time. FSMB states it is not intended that this report be used to rank states against each other because states operate with different financial resources, levels of autonomy, legal constraints, and staffing levels.

The Composite Action Index for Florida improved from 4.90 in 2008 to 5.40 in 2009. The Department of Health improved this index by

filling 4 vacancies in their prosecution unit with experienced litigation attorneys; establishing a triage team to handle priority one cases; hiring a section manager and developing team leaders who are responsible for the performance of individual attorneys and serve as legal experts to assist with processing cases. Further the unit removed all but medical cases from the medical section team and established a more robust quality review of all settlement agreements to insure consistency with board guidelines and board past actions and improve rate of board adoption of proposed settlements. These and other improvements are resulting in more efficient and timely processing of disciplinary cases presented to the Board.

Board Chairman Onelia Lage, M.D., stated "The Board of Medicine is pleased with the efforts made by our prosecution team to bolster staffing and quality review and believe that these efforts will results in sustained improvement in the numbers of cases brought to the board."

#### Florida Doh Joint Investigation Leads To Multiple Arrests In Miami-Dade County

The Florida Department of Health (DOH) South Florida Unlicensed Activity Unit (ULA) announced today that it has assisted the Miami Dade Police Department's Strategic & Specialized Investigations Bureau – Organized Crime Section (SSIB-OCS), with the March 2, 2010 arrests of eleven suspects in connection with racketeering, money laundering, prostitution and the unlicensed practice of massage therapy.

The year-long SSIB-OCS investigation focused on six unlicensed massage establishments owned by one of the arrestees, Michael Angelini. The police became aware while the businesses advertised massage services, for an additional fee, customers could also obtain sexual services at the locations.

On March 2, 2010 a massive simultaneous undercover operation was conducted at each of the unlicensed establishments. The establishments were located throughout Miami-Dade County. The locations were known by the following names; "Body Spa One" 108 South Miami Avenue, "Miami Lakes Spa" 4715 N.W. 157th Street, "Airport Spa" 1212 N.W. 72nd Avenue, "Nature's Own" 7309 West Flagler, "Miller Tropical Spa" 5600 S.W. 135th Avenue, and "Body Fragrance Spa" 13550 S.W. 88th Street. During the operation, undercover detectives entered each establishment seeking a massage. After paying for a massage, each detective was offered a sex act in exchange for an additional payment. Along with Angelini, the individuals charged in connection with unlicensed massage (in addition to racketeering and/ or prostitution) were identified as Derek Greenberg, Sabrina Maya, Michelle Bonilla. The remaining eight suspects are facing charges that relate to racketeering, money laundering and prostitution. None of the subjects have ever been licensed to perform massage therapy in Florida.

DOH has several resources to combat unlicensed activity:

Complaints may be filed anonymously by completing and mailing the complaint form on the DOH Web site or calling 1-877-HALT-ULA or 1-877-425-8852 (Option #3).

The Florida Department of Health's (DOH) unlicensed activity program protects Florida residents and visitors from the potentially serious and dangerous consequences of receiving medical and health care services from an unlicensed person. The Division of Medical Quality Assurance (MQA) investigates and refers for prosecution all unlicensed health care activity complaints and allegations. The unlicensed activity unit works in conjunction with law enforcement and the state attorney's offices to prosecute individuals practicing without a license. In many instances, unlicensed activity is a

felony level criminal offense. More importantly, receiving health care from unlicensed people is dangerous and could result in further injury, disease or even death.

The mission of DOH and MQA is to promote, protect and improve the health of all people in Florida. Working in conjunction with 22 boards and six councils, MQA regulates seven types of facilities and 200-plus license types in more than 40 healthcare professions. MQA evaluates the credentials of all applicants for licensure, issues licenses, analyzes and investigates complaints, inspects facilities, assists in prosecuting practice act violations, combats unlicensed activity and provides credential and discipline history about licensees to the public.
