We anticipate that the funding will be reduced by 32-35% next year and we are working on a formula for funding coalitions next year. Once we come up with a draft we will send out to the Healthcare Coalition Task Force (HCCTF) for review. Commander Paul Link reminded the Department of Health that funding would be risk based.   |  |
