

Florida Injury Prevention Advisory Council (FIPAC) Meeting Tampa, FL – April 9, 2013 – 10:00am-5:00pm EST Summary Minutes

1) Welcome and Introductions

- a. Lisa VanderWerf-Hourigan opened the meeting by welcoming everyone. Attachment 1 is the attendee list.
- b. FIPAC members introduced themselves and shared a unique injury-related event, program, or initiative in their local areas.
- c. Ms. VanderWerf-Hourigan described the purpose the meeting—to create the 2014-2018 Florida Injury Prevention Strategic Plan through collaborative and data-driven decisions.

2) History and SWOT Analyses

- a. Ms. VanderWerf-Hourigan highlighted the history of the IPP, including the creation of the 2003-2008 and 2009-2013 strategic plans, CDC grant, gaining statutory authority as a program, and recent developments, such as the 2013 IPP Mini-Grant Program.
- b. Ms. VanderWerf-Hourigan shared the IPP staff Strengths, Weaknesses, Threats, and Opportunities (SWOT) analysis with FIPAC. A brief summary:
 - i. Strengths: Data, fact sheets, vacancies filled (minus admin support).
 - ii. Weaknesses: Lack of institutional knowledge, cross-training, admin support, Lisa VanderWerf-Hourigan as Interim Director of Trauma Program.
 - iii. Opportunities: New strategic plan, injury prevention at trauma centers, new data.
 - iv. Threats: Funding cuts, politics, Lisa VanderWerf-Hourigan in DROP, Reikan Lin assignment ends July 2014.
- c. Ms. VanderWerf-Hourigan facilitated a SWOT analysis of FIPAC. Attachment 2 is the full FIPAC SWOT Analysis.

3) Data Presentation

a. Karen Card, epidemiologist at the Department of Health (DOH), Bureau of Emergency Medical Oversight, delivered an injury data presentation via web conference.

4) Mission & Vision Statement

- a. Ms. VanderWerf-Hourigan initiated discussion on creating new mission and vision statements by presenting the following DOH and FIPAC statements:
 - i. <u>DOH vision</u>: To be the healthiest state in the nation.
 - ii. <u>DOH mission</u>: To protect, promote, and improve the health of all people in *Florida through integrated state, county, and community efforts.*
 - iii. <u>Current FIPAC vision</u>: Florida: An injury-free state.
 - iv. <u>Current FIPAC mission</u>: To reduce Florida's injury burden through leadership, education, and policy.
- b. Ms. VanderWerf-Hourigan opened discussion on a new vision statement.
 - i. After discussion, the group decided to maintain the current vision statement, "*Florida: An injury free state.*"



- c. Ms. VanderWerf-Hourigan opened discussion on a new mission statement.
 - i. After extensive discussion, the group decided on "To reduce injury in Florida through leadership, education, and policy."

5) Goal Creation

- a. Ms. VanderWerf-Hourigan opened discussion on new goals for the 2014-2018 Florida Injury Prevention Strategic Plan by going over the current goals:
 - i. Goal 1: Infrastructure
 - ii. Goal 2: Collaboration
 - iii. Goal 3: Senior Falls Prevention
 - iv. Goal 4: Child Drowning Prevention
 - v. Goal 5: Training (Currently combined with Goal 2)
- b. The group agreed that the current goals are still relevant and began to draft updated goals:
 - i. Goal 1: Infrastructure still relevant and necessary for FIPAC function.
 - ii. Goal 2: Collaboration a goal team is still needed to capture injury mechanisms that are not under a separate goal team.
 - iii. Goal 3: Senior Falls Prevention according to the data presentation, this is still a public health priority.
 - iv. Goal 4: Child Drowning Prevention according to the data presentation, this is still a public health priority, but this goal may be expanded to reach out to the 5-9 age group in addition to ages 1-4.
 - v. Goal 5: Distracted Driving distracted driving has been operating as a policy subcommittee and will now operate as a separate goal team.
- c. Preliminary draft goals were recorded for discussion for the second day of the meeting on April 10, 2013.

6) Closing

a. Ms. VanderWerf-Hourigan closed the first day of the meeting by summarizing the SWOT analysis of FIPAC, the new mission and vision statement, and the potential goals of the 2014-2018 Florida Injury Prevention Strategic Plan.

Florida Injury Prevention Advisory Council (FIPAC) Meeting Tampa, FL – April 10, 2013 – 8:00am-1:30pm EST Summary Minutes

1) Welcome and Recap

- a. Lisa VanderWerf-Hourigan opened the meeting by welcoming everyone.
- b. Ms. VanderWerf-Hourigan recapped discussion leading to the 5 potential new goals for the 2014-2018 Florida Injury Prevention Strategic Plan.
- c. Ms. VanderWerf-Hourigan described the basics of goal creation and highlighted the requirements of the CDC Core VIPP grant, the primary funding source for IPP and FIPAC.
 - i. The grant requires 4 priority areas (injury-specific public health issues), one of can be flexible year to year to meet changing demands.

2) Creating Goal Team Statements

- a. Ms. VanderWerf-Hourigan facilitated the creation of goal team statements for drafted goals. The following are <u>draft versions</u> of the proposed goals and are subject to change.
 - i. <u>Goal 1</u>: Establish a sustainable infrastructure that provides leadership, funding, data, communication, training, policy, and evaluation for injury prevention.
 - 1. Added communication (a major theme in the SWOT analysis) and training (from the current Goal 5).
 - ii. <u>Goal 2</u>: Support statewide educational and awareness opportunities focused on data driven causes of injury.
 - The CDC Core VIPP grant allows for a priority area to be flexible from year to year. The group decided to identify a particular area to focus on educational and awareness initiatives based on data. This goal would include the "catch-all" topic areas that are not existing goal teams.
 - iii. <u>Goal 3</u>: Establish a collaborative effort to provide statewide direction and focus for fall-related injury prevention for Florida's older adults.
 - 1. The term "older adults" will be used in place of the term "seniors" to reflect the current CDC usage.
 - iv. <u>Goal 4</u>: Establish a collaborative effort to provide statewide direction and focus for early childhood water safety and drowning prevention in Florida.
 - v. <u>Goal 5</u>: Establish a collaborative effort to support statewide direction and focus to prevent motor vehicle crash-related injuries from distracted driving.
 - 1. New goal uses similar language and includes "motor vehicle crash-related injuries" to specify an injury mechanism. The focus is on distracted driving leading to this type of injury.

3) Goal Team Breakout Sessions

- a. FIPAC members joined their respective goal teams for approximately one hour to discuss updates and closing out the current strategic plan:
 - i. Goal 2 & 5 with Jan Davis, Grant Manager
 - ii. Goal 3 with Reikan Lin, Public Health Associate



- iii. Goal 4 with Elizabeth White, WaterproofFL Coordinator
- b. Ms. VanderWerf-Hourigan invited each Goal Team to summarize some focus areas for the remainder of the current strategic plan:
 - i. Goal Team 2 & 5 will continue to work on a statewide injury prevention resource list and provide/distribute the Injury Prevention 101 course as needed.
 - ii. Goal Team 3 will focus on enhancing surveillance (quantitative focus) of older adult falls prevention strategies, including evidence-based interventions and the annual broadcast.
 - iii. Goal Team 4 will begin to strategize for the inclusion of the 5-9 for the next strategic plan.

4) Closing

- a. Ms. VanderWerf-Hourigan closed the second day of the meeting by summarizing the drafting of the 2014-2018 Florida Injury Prevention Strategic Plan, discussing next steps, answering questions, and conducting an evaluation of the meeting.
 - i. Future meetings may use electronic materials/alternatives in place of physical binders used at FIPAC.
 - ii. The group discussed the possibility of aligning the 2014-2018 Florida Injury Prevention Strategic Plan with the CDC Core VIPP grant year.
 - 1. If this is possible, then there may be meeting in July 2013 to close out the current plan.
