Dr. Celeste Philip, chairing the meeting on behalf of Dr. John Armstrong, called the meeting to order at 10:02 a.m. and welcomed all to the call. Shannon Hughes did the roll call, meeting attendance is noted above.

Marshall Deason had an addition for the January 26, 2015 meeting minutes regarding tobacco funding being used for work on e-cigarettes. At the January meeting Dr. Philip asked Mr. Deason to submit to the General Counsel information he had on the law relating to e-cigarettes. The General Counsel's office was to provide a written justification for their position on e-cigarette work to the Tobacco Advisory Council (TAC). He requested that the letter he submitted be circulated to the other members of the Council.

Dr. Philip provided an update on leadership changes within the Department of Health (DOH) and the General Counsel's office and several discussions related to addressing e-cigarettes as part of the Bureau of Tobacco Free Florida's (BTFF) work. More information related to this topic will be distributed before the start of the new fiscal year.

Ralph DeVitto motioned for approval of the minutes, pending the changes to the "E-cigarette discussion" section, and William Long seconded the motion. There was no further discussion, the motion was approved.

Disposition: Meredith Hennon will amend the January 26, 2015 minutes and redistribute them to the Council. Marshall Deason's letter to the General Counsel will be distributed by email.

Awarding of Research Grants

Sarah Hofmeister, from the Public Health Research section, gave an overview of two funding programs within DOH – James and Esther King Biomedical Research Program and Bankhead-Coley Cancer Research Program. All applications are peer-reviewed and require a letter of support from BTFF. She provided a brief synopsis of each of the grants funded. There was a discussion about the presentation, applications, funding, and unmet needs for research funding in Florida.

Fiscal Year 15-16 Evaluation Plan

Carol Schmitt, also from RTI International, provided a status update of the upcoming State and Community Interventions evaluation and evaluation questions provided by BTFF staff.

Media update: THE FACTS NOW

Sorraya Guillaume, from Alma DDB, and Naylet Aguayo, from Golin, provided an overview and update on The Facts Now prevention campaign, shared a video on the campaign, and a recap of what the media team learned this quarter. There was a discussion on impression measurement, specific strategies for harder to reach populations, and long-term goals.

2015-2020 Strategic Plan

Gregg Smith, from BTFF, provided the Council with a status update of the 2015-2020 Strategic Planning noting that all comments were considered and changes were made to the plan. The draft will be distributed again with an accompanying narrative of all the major changes. Upon the plan's approval from the Council, BTFF and partners will move forward with developing the action plan.
