Cory Richter spoke on a new committee working to use crash data garnered from vehicles. This data will be used for new trauma review criteria and morbidity outcome reports. Once completed and implemented, new training will be provided showing examples of crash reviews to determine ISS scores for patients as they arrive at Trauma Centers. Further, there have ongoing discussions about putting on star on all vehicles. Cory will pass it on as it progresses.

No additional information regarding drug shortages. The use of expired drugs was approved by DOH state EMS office, but still needs validation by FDA. Online of ordering of controlled substances can be done thru the DEA site. For further information, contact Chief Richter.
