#### III. Overview of Brain and Spinal Cord Injury Program

  - Allocations There are Two major sources of funding for the Brain and Spinal Cord Injury Program.
    - Trust Fund Funded through revenues of traffic or boating.
    - General Revenue

Revenues are deposited into the trust fund monthly, as reported by each county circuit court. The General Appropriation Act represents the spending authority that is allocated to each state agency and their program levels. The spending authority tells each state agency how much they can spend in the given fiscal year. The GAA indicates the amount the state agency can spend, the revenues are collected and deposited in trust funds, which represent the actual cash that the agency can spend up to the limit that is defined by the GAA.

  - Justin explained how his group met with over 50 physical therapy students from Nova Southeastern University and 100 students from USFS medical school in July and August. He explained how the program is looking at increasing the traumatic brain injury resources and components on the BSCIP website.

## V. BSCIP Key Projects

- Central Registry Portal Ed Mills, RIMS Project Manager
  - Ed Mills explained the new portal update for Central Registry. Referrals for Central Registry are received primarily via fax from hospitals and facilities. BSCIP is working with the vendor Digital Innovation, to have the referrals input electronically to the Central Registry Portal. Ed discussed phase one of the Central Registry Portal testing and how the program will identify hospitals to test the program. Phase two will uploaded the referrals electronically into RIMS automatically. Phase three, has the hospitals create the referrals on their side and within their software.
- Annual Refresher Trainings Robert Pfister, BSCIP Unit Administrator
  - Robert discussed refresher training for January. The trainings will cover state statutes, policies, and procedures staff should follow to ensure the program is providing the best services. The trainings are different from the Department of Health trainings. The refresher training will focus on the Brain and Spinal Cord Injury policies, procedures, and operating procedures.

- Robert discussed how the program is compiling information about FSCIRC on the BSCIPTraNet.
- Vendor Directory Teresa George, BSCIP Program Policy and Compliance Administrator
  - Teresa discussed the vendor directory and the deficiencies within the regions.
     Teresa stated one of her goals this year is to develop a recruitment team to address vendor directory deficiencies. The program also has a weekly indicator report to indicate new vendors and inactive vendors.

 Robert discussed the use of telehealth during COVID and the importance of the availability of telehealth for clients. Receiving telehealth is better than receiving no services at all. The program created a report to track telehealth indicated on care plans.

  - O Robert discussed FAAST, a company in the SW region of Florida, requesting to install a smart home system for an individual with spinal cord injuries. He explained how FAAST requested viable candidates currently enrolled in the program with specific demographics needed for the project. Robert explained how Rosalind is preparing the applications for qualifying clients to submit to FAAST for consideration. He explained how the smart home system is an integrated system for automated electronics to make the house more accessible for the independence of a person.

#### VIII. Med Waiver Clients Update – Kimberly Robinson, BSCIP Section Administrator

 Kimberly discussed the data that ACHA provided of clients previously enrolled in the Medicaid Wavier Program. She explained any other data request would need to be made thru a public request directly to AHCA.

#### IX. FL Health Charts Update – Ed Mills, RIMS Project Manager

Ed discussed how the program provided data for the FL Health Charts. BSCIP had to
replicate the data that was given over to the Division of Public Health Statistics due to
the absence of the Data Analysts. BSCIP started fresh and implemented ways come up
with the data needed for this report. BSCIP sent information regarding in-service client
injuries for adult and pediatric cases. BSCIP now has a step by step process
documented to ensure all the required data for reporting is captured.
