	-Marion asked if there were any dollar figures added to the bill? Or is the bill still unfunded? The concern is that adding funding to the bill may make it harder to pass. Dewayne does not recall any funding being added to the bill and noted that there is still time to make revisions before it is officially filed. CHW committee does not want any funding attached to it.
	-Carolyn asked when the bill will be viewable to the public and where the public can go to view the bill? Dewayne indicated that the bill will be on Representative Reed's Florida House page under sponsored bills. He expects to have it live on the website by February.
	-Thanks again to Dewayne for joining the call, Dewayne indicated that he is available to contact to answer further questions.
 Legislative delegation updates Update on the December meetings attended by Maisha and Denise Update on the Pinellas delegation meeting 	-Maisha Standifer reported presenting at the Hillsborough county delegation meeting on 12/17, she had 3 minutes to present and indicated that she used Denise's template presentation and it worked great. She got good feedback and the majority of delegates were there from the area. There were no questions asked and she disseminated the information packets Senator Joyner was not at the meeting but Representative Reed was present. She noted that perhaps Sean could make sure to visit Senator Joyner while he is in Tallahassee.
Other updates?	-Carolyn asked about everyone receiving a copy Denise's presentation? Maisha indicated that Denise sent it out by email and that she would find the email and forward it to the group.
	-Lolita and Denise were at Pinellas meeting. Their presentation was late in the meeting but it went well. Denise responded to one question, which Lolita could not recall what it was. Lolita spoke with Representative Kathleen Peters at the meeting. Representative Peters used to work with an organization called the Front Porch that Lolita also works with so they have an established relationship and she thinks Representative Peters will support the bill. Lolita will call her Representative Peter's office and schedule a time to meet with her to formally ask for her support.

8.	Update on the CHW DVD	 -Carolyn Tucker-Production is going very well. They finished the 20-minute version and now working on shortening it. Currently it is at 11 minutes having a hard time getting it to 10 minutes. Is 11 minutes acceptable? Group did not indicate any objections to the 11-minute length. -Regarding dissemination of the video. They can upload it to their website and to YouTube. -It will be done by January 20th. Carolyn will submit the video to Marion and Susan once it is finalized on 1/20, and after they look at it, asked if she should send it to members of the group before publically disseminating it? Members would like to see it first because they are in the video but would not anticipate asking for any changes. -Sean would like to be able to show it when he is in Tallahassee, and can do so on his iPad from YouTube-wanted to know if the video will be available on YouTube by 1/23. The earliest day for Marion to review it is 1/22 and she doesn't think committee needs to see it before it goes public so she thinks that Carolyn's team should feel free to put it on YouTube by 1/22.
