Introduction

This annual review report is a summary of work, progress, and accomplishments for the 2018-2023 Lafayette County Community Health Improvement Plan (CHIP). The 2018-2023 Lafayette County Community Health Improvement Plan resulted from primary and secondary data collected through the MAPP process in the 2018 Community Health Assessment (CHA). The CHA was a collaborative community effort led by WellFlorida and the Florida Department of Health in Lafayette County. The activities and collaborative efforts of the Florida Department of Health in Lafayette County and community partners will be reflected within the report. This document will serve as a progress review of the strategies that were developed and the activities that have been implemented. While the CHIP is a community-driven and collectively owned health improvement plan, the Florida Department of Health in Lafayette County is charged with providing administrative support, tracking and collecting data, identifying existing evidence-based and evidence-informed programs that may be appropriate, and preparing the annual review report.

The group of community partners involved in the implementation and revision of the CHIP are known as “Lafayette Forward”, which was re-branded in February 2019 from the Lafayette Health Improvement Partnership. This is a multi-disciplinary group representing state, county, and local government, private industry, faith-based organizations, education, and the public at large. This group met on a bi-monthly basis (every other month) to discuss and work to implement the CHIP and workplan. The “Lafayette Forward” community partners are committed to improving the health and wellness of their community and have continued to contribute their valuable time, skills, and resources to improving the quality of life in Lafayette County.

Overview of CHIP and Annual Review Meeting

The Department of Health in Lafayette County contracted with WellFlorida Council to conduct a Community Health Assessment. The Community Health Assessment process was launched in August of 2017, continuing a strong commitment to better understanding the health status and health needs of the community. This assessment was complete in February 2018.

Led by the Florida Department of Health in Lafayette County and members of the Lafayette Health Improvement Partnership (LHIP), the strong commitment to better understand the health status and health needs of the community followed by impactful action and accountability are the hallmarks of the Lafayette CHIP process which was completed in July 2018. Enhancements to the 2019 CHIP include an emphasis on the social determinants of health and health equity with concerted efforts to involve, include and understand diverse perspectives; inclusion of policy and environmental change strategies; and direct involvement of key community partners and citizens in identifying, formulating and implementing solutions.

As part of the CHIP process we recognized the new dynamic's affecting our county. Our community partners felt a name change from Lafayette Health Improvement Partnership (LHIP) to Lafayette Forward would better reflect our missions, our goals, and our objectives.

This report is based on the 2018-2023 CHIP, revised in May 2019.

Summary of CHIP Annual Review Meeting

The Annual review meeting was held on January 28, 2019. In this meeting, community partners reviewed Priorities, Goals, Strategies, and Objectives established in the 2018-2023 CHIP for Lafayette County. The status and plans for each were discussed to identify strengths and barriers to success. This meeting provided a good overview of where the Lafayette Health Improvement Partnership is, and the direction it is going. Many community partners presented items they have that are related to the CHIP and will work in 2020 to add and track those objectives as appropriate.

Progress on each of the Strategic Priority Areas are below with additional detail and notes on the status of each objective.

2019 Progress and 2020 Revisions

Strategic Issue Area #1: Maternal and Child Health

Using the 2018 Community Health Assessment, the community identified that there were barriers to accessing care and education for women and teens. Without proper access and education, the residents of Lafayette County do not have autonomy over their own health, and this can have long lasting effects on individuals and the community.

Goal 1.1: Improve the Health of Women and Babies

Strategy 1.1.1: *Remove barriers to education/information, services, and support for women and families.*

Objective: Educating the population about what services are available enable the population to have more power and autonomy in their health decision making process and reducing disparities amongst populations.

Our progress in 2019 on policy change at public schools, awareness/education campaigns is listed below:

- ✓ Objective 1- Task force has been formed. We are continuing to recruit and expand membership and work with School Health program to reach identified target market.
 - Target has been met with the forming of the Task Force.

- ✓ Objective 2- Task Force will assist in creating campaign on responsible parenting and sexual behaviors targeting middle and high school students. DOH-Lafayette has a Free Teen Clinic to serve teens only. This clinic does free health education and screening, gives free birth control, and also does free sexually transmitted disease testing and treatment.
 - Target was monitored on the number of ad responses to ads.

Strategic Issue Area #2: Healthy Behaviors

Our behaviors, our choices, have the greatest impact on our health. These choices are influenced by the places people live, learn, work, and play. By creating social and physical environments that promote good health, good decisions, and a safe environment, the overall health of the community will improve as well as reducing the financial impact of emergency services used due injury and illness, to include mental illness and substance use.

Goal 2.1: Reduce Substance Abuse

Strategy 2.1.1 *Improve access to services and resources, provide health education, institute policy change for funding to support expanded services.*

Objective: Having regular access to mental health care is a key component to substance use prevention. With proper access to mental health care, cognitive and behavioral interventions can be used to equip Lafayette residents with positive coping skills, thus reducing the chance of self-medicating using substances. Educating children and young adults on the long-term effects and potential legal repercussions of substance use provides a comprehensive approach to substance use prevention.

Progress in 2019

Our progress in 2019 on Improving access to services, providing health education, instituting policy changes for funding to support expanded services is listed below:

- ✓ Objective 1- DOH-Lafayette has partnered with Meridian Behavioral Health to offer space at DOH-Lafayette giving Lafayette citizens access to mental health care. There is no mental health facility located in Lafayette County. Meridian Behavioral Health has a (CAT) Community Action Team in place to access the mental health needs of the County.
 - Target was to increase mental health staff in Lafayette County, and this was implemented with Meridian Behavioral Health utilizing office space in DOH-Lafayette.

- ✓ Objective 2- DOH-Lafayette is in the process of participating with Lafayette County Sheriff's Office in Lafayette Teen Health Fair in April 2019. This will be the first of the three events to be scheduled.
 - Target was to partner with local law enforcement to provide education on drug and substance abuse to middle school/teen students in Lafayette County Schools and DOH-Lafayette is in the process of participating with local law enforcement on this. DOH-Lafayette also established banners on drug usage.



Goal 2.2: Prevent Unintentional Injuries

Strategy 2.2.1: Provide education and awareness campaigns, support enforcement activities.

Objective: Injuries can not only harm the individual but can lead to lasting harm within a community. Injuries can lead to avoidable use of emergency medical services (including ambulance and emergency department resources), which then will strain those resources that are needed for other emergencies. There is also a financial component of injuries. The trips to the emergency department, loss of time at work, and so on lead to heavy financial burden on both the individual and the community.

Car Seat Recommendations: Choosing the Right Seat

REAR-FACING CAR SEAT

Keep your child rear-facing as long as possible. The back height in the seat should be at least as tall as your child's head and shoulders. Once your child's head and shoulders reach the top of the seat, it's time to move them forward-facing.

It's best to use a rear-facing car seat until your child is 2 years old, or until they reach the weight or height limit of the seat.



FORWARD-FACING CAR SEAT

Keep your child forward-facing until they are at least 4 years old. The child should be in a seat with a high back and a five-point harness. Once your child's head and shoulders reach the top of the seat, it's time to move them to a booster seat.

It's best to use a forward-facing car seat until your child is 4 years old, or until they reach the weight or height limit of the seat.



BOOSTER SEAT

Keep your child in a booster seat until they are at least 8 years old. The child should be in a seat with a high back and a three-point seat belt. Once your child's head and shoulders reach the top of the seat, it's time to move them to a seat belt.

It's best to use a booster seat until your child is 8 years old, or until they reach the weight or height limit of the seat.



SEAT BELT

Keep your child in a seat belt until they are at least 13 years old. The child should be in a seat with a high back and a three-point seat belt. Once your child's head and shoulders reach the top of the seat, it's time to move them to a seat belt.

It's best to use a seat belt until your child is 13 years old, or until they reach the weight or height limit of the seat.

Car crashes are a leading killer of children ages 1 to 12.

In crashes from 2014-2018, 3,394 children under 18, 1,616 ages 1-12, and 1,778 ages 13-17 were killed, and an estimated 399,000 children under 18 were injured.


That's more than the population of 4 European nations.

In 2018, 662 children under 18 in cars, SUVs, vans, and pickup trucks were killed in crashes.

Of those killed, more than 1 in 3 were unstrapped.

One seat reduces the risk of death in a crash by 71% if buckled up correctly.

Correct use of a booster seat reduces the risk of death in a crash by 54% if buckled up correctly.

Strategic Issue Area #3: Chronic Health Conditions

Heart disease, cancer, stroke, or diabetes, and other chronic diseases are the leading causes of death and disability in America, and they are also a leading driver of health care costs. Most chronic diseases can be prevented by eating well, being physically active, and getting regular health screenings and self-management education.

Goal 3.1: Promote Healthy Weight for Lafayette County Residents

Strategy 3.1.1: *Institute primary prevention approaches to healthy lifestyles including education and access to services and resources.*

Objective: Obesity and diabetes can have severe impacts on individuals and communities. These range from other related chronic diseases to time lost at work due to medical issues, to use of emergency services due to lack of monitoring conditions. Providing education, resources, and opportunities for physical activity can reduce the incidence of chronic disease.

Some chronic diseases, such as obesity and diabetes, can even be reversed through diet, exercise, and self-monitoring. The more individuals have autonomy over their own health, the more they can participate and be active in the community.

Progress in 2019

Our progress in 2019 on providing education on disease management, provide support and resources is listed below.

- ✓ Objective 1- Meridian is offering counseling services inside DOH-Lafayette. Our Community partner- UF-IFAS is providing health education classes.
 - Target was to offer counseling services as well as health education classes and that is currently being done.
- ✓ Objective 2- DOH-Lafayette Health Educator is doing heart healthy programs in our community to promote healthy hearts. We also disturbed blood pressure cuffs through a joint effort with The United Way and Lafayette EMS to support self- monitoring practices.

- Target was to increase counseling services and health education classes and we are currently providing health education classes and counseling services at DOH-Lafayette.

- D. Harper from DCF discussed 4DX initiative. 4 Disciplines of execution. Decrease the number of families in crisis by 2021. The need is for more referrals in the small communities by email.
- Erin P. from Healthy Start/Well Florida highlighted breastfeeding, car seats and safe sleep practice efforts for children. The display crib was in the Lafayette Library for two months and is now at the DOH-Lafayette. Will provide education material for crib display. New descriptive poster coming soon. (A)lone, (B)ack, (C)rib. K. Waldron stated there has been an increase in infant mortality due to unsafe sleep.
- Dennis from the Florida State Parks stated their focus is the Water Spring initiative, natural resources and trying to reach out to the community. K. Waldron stated that the DOH partners with the Florida Trail Association for Healthy Hikes once a quarter and it is an inexpensive way to help our community be active in their own back yard.
- M. McAfee from UF/IFAS is ready to partner with the DOH-Lafayette on picking a site for a community garden. The Lafayette IFAS/Family Nutrition Program has partnered with the Lafayette Boys and Girls Club and the Lafayette second grade students for a community garden.
- J. Clore from PFSF stated they have different ways to partner with their organizations. Council meetings, Adoption and their Wish Upon A Star benefit: to provide the needs of over 1,200 local abused or neglected children during the holiday season. The Suwannee, Hamilton and Lafayette Community Council meetings are at St. Luke's Church in Live Oak. They allocate \$5,000 toward utilities, clothes and individual assistance through the fiscal year, July 1st-June 30th. PFSF sponsors the World's Greatest Baby Showers for moms in our communities. November is National Adoption Month and PFSF is recruiting adoption families by taking PRIDE classes. Classes are about 8-9 weeks for about 1 to 1.5 hours, usually on a Thursday or Saturday. J. Clore handed out The Adoption Process flier, Children's Partnership Councils flier and the Wish Upon A Star flier. PFSF is requesting support for their Holiday Support Drive.
