## PASCO COUNTY COMMUNITY HEALTH IMPROVEMENT PLAN

In Pasco County, many local communities and agencies are coming together to improve health. Local and state level data that reflect the health of the community has been shared and reviewed. Recent community meetings have identified some focus areas to address collectively. Communities, stakeholders, and partners can use this plan to build on work being done for a more collective impact on the health of Pasco residents.

To improve health, Pasco's Community Health Improvement Plan will focus on the following areas: 1) Health and Well-Being; 2) Healthy Babies; 3) Infectious Disease; and 4) Access to Care.

### FOCUS AREAS

#### ACCESS TO CARE

Limited access to health care services, may contribute to poor health outcomes and high health care costs. Many socioeconomic and social determinates influence health outcomes. The public health system should:

- Improve availability of services
- Reduce barriers to services
- Inform, educate, and empower residents to make health care decisions

#### HEALTH AND WELL-BEING

Obesity, sedentary lifestyle, tobacco, and poor nutrition are risk factors for numerous chronic diseases and they exacerbate others, including heart disease, cancers, diabetes, and chronic lower respiratory disease. The public health system should:

- Promote healthy living
- Prevent chronic disease and conditions
- Advocate and educate for healthier communities

#### HEALTH BABIES

Infant mortality is a key measure of population health. A child's health is affected by biological influences, including nutrition, illness, and each parent's health and environmental influences. The public health system should:

- Promote health before pregnancy
- Reduce disparities
- Improve pregnancy planning

#### INFECTIOUS DISEASE

Prevention and control of infectious disease remains a public health concern. Strong disease surveillance, detection and investigation can protect the public from infectious diseases and save lives during outbreaks and other unusual health events. The public health system should:

- Promote collaboration and information sharing
- Support surveillance and response activities
- Expand access to evidence-based information

## KEY HEALTH ISSUES

The Florida Department of Health in Pasco facilitated 4 Collective Impact meetings between September 2016 and March 2017. The group discussed key health issues which: infectious diseases and related issues, overall health and well-being, health needs of vulnerable populations, access to health care services, family welfare, tobacco use, human trafficking, mental health, and adult substance abuse and drug overdose. Group members then collapsed and prioritized these key health issues while keeping focus on mental health issues that impact all areas. The next pages lay out the group's recommendations and action steps for health and well-being, healthy babies, infectious disease prevention and access to care.

### *FOCUS AREA: ACCESS TO CARE*

#### **AC1: PASCO COUNTY LOCAL KIDCARE COALITION**

**Goal AC1:** Decrease the number of uninsured children through increasing awareness and education about children's health coverage, how to apply, and resources for families

**Strategy:** Collaborate with partner agencies to raise awareness and skills among community partners and consumers on opportunities for accessing children's health care coverage.

**Objectives:**

AC1.1 By September 30, 2017, complete at least one train the trainer session to educate people on kidcare program

AC1.2 By September 30, 2017, create a referral form for school nurses to connect parents to Premier CHC for quicker and easier appointments

AC1.3 By Decemeber 31, 2017, complete outreach and communications plan for 2018

#### **AC2: HOMELESS EMERGENCY SHELTER**

**Goal AC2:** Reduce the homeless population in West Pasco County

**Strategy:** Access community members seeking shelter and assist them with services that will aid them in gaining employment, housing, and healthcare

**Objectives:**

AC2.1 By December 31, 2017, acquire the property at 8239 Youth Lane, Port Richey, Florida 34668

#### **AC3: MENTAL HEALTH DIVERSION**

**Goal AC3:** Develop a strategic plan for diverting adult females with substance use and/or co-occurring disorders, who are at risk of entering the criminal justice system, to appropriate behavioral health/community based care

**Strategy:** Collaborate with Pasco agencies to identify, divert, and assist the target popluation with alternate solutions to jail

**Objectives:**

AC3.1 By December 31, 2017, establish a formal memorandum of understanding between one Pasco agency and BayCare Behavioral Health

#### **AC4: PASCO HERNANDO ORAL HEALTH COALITION**

**Goal AC4:** Increase oral health care

**Strategy:** Create an oral health coalition that promotes oral health improvement through prevention education and increasing flouride in water

**Objectives:**

AC4.1 By June 30, 2018, establish an official Pasco Hernando Oral Health Coalition

*FOCUS AREA: HEALTH AND WELL-BEING*

**HW1: DIABETES AWARENESS AND EDUCATION**

**Goal HW1:** Increase community members' knowledge and ability to access formal diabetes education

**Strategy:** Collaborate with partner agencies and organizations to identify and map Diabetes prevention and education services around Pasco County

**Objectives:**

HW1.1 By December 31, 2017, at least 3 partners will distribute information on available diabetes services in Pasco County

**HW2: AFTER-HOURS ACCESS TO SCHOOL GROUNDS**

**Goal HW2:** Increase physical activity amongst persons living in a two-mile radius of schools by providing extended school grounds access by executing a joint use agreement of properties

**Strategy:** Collaborate with partner agencies and organizations to identify a pilot school to foster joint use agreement

**Objectives:**

HW2.1 By June 30, 2018, two schools in Pasco County will have a written policy allowing the community to use school grounds after school business hours

HW2.2 By April 30, 2018, attend four events and share information regarding after hour's access to school grounds

**HW3: HEALTHY CONCESSION STANDS**

**Goal HW3:** Increase access to healthier food and beverage options at concession stands located in Pasco Parks by requiring cosponsored youth organizations participate in the Fun Bites initiative.

**Strategy:** Collaborate with partner agencies and organizations to introduce Fun Bites to concession stand located in Pasco County Schools and Parks

**Objectives:**

HW3.1 By June 30, 2018, Parks, Recreation, and Natural Resources – Pasco County will have a policy that requires vendors to offer healthier snack options that follow the fun bites guidelines

HW3.2 By March 31, 2018, implement Fun Bites at two difference locations and promote changes to youth sports league audience

*FOCUS AREA: INFECTIOUS DISEASE PREVENTION*

**ID1: INFECTIOUS DISEASE PREVENTION COALITION**

**Goal ID1:** REDUCTION IN THE OVERALL BURDEN OF INFECTIOUS DISEASE IN PASCO COUNTY

**Strategy:** The Infectious Disease Prevention Coalition seeks to reduce morbidity and mortality due to infectious diseases by utilizing a multi-pronged approach that will include (but are not limited to): awareness and outreach efforts, immunization programs, and dissemination of educational materials

**Objectives:**

ID1.1 By December 15, 2017, develop sub-committee action plans

**HB1: HEALTHY BABIES INFANT MORTALITY**

**Goal HB1:** Improve pregnancy planning and spacing, and prevent unintended pregnancies

**Strategy:** Partner with agencies to increase preconceptual and interconceptual education for childbearing aged women in Pasco County

**Objectives:**

HB1.1 By September 30, 2017, identify a curriculum model and order educational materials addressing family planning education

HB1.2 By December 2018, one hundred clients will participate in the show your love curriculum
