# Quantifying Racial and **Ethnic Disparities Amongst Emergency** Department Users: A look at Volusia County

### Introduction

Racial and ethnic disparities are a major Healthy People 2020 (HP2020) foundation health measure and according to HP2020, if "a health outcome is seen to a greater or lesser extent between populations, there is disparity." Disparities exist amongst geographic distributions as well as by race/ethnicity and have been both documented and studied for several decades (Alter et al., 1999).



### A National Problem

Nationally, trends of persons who identify as Black alone or Hispanic have disproportionately utilized emergency departments because of a lack of a primary care physician or adequate health insurance coverage (Pines et al., 2009, Pines et al. 2008).



### **Volusia County**

According to the 2014, 5-year American Community Survey (ACS2014), Volusia County's racial and ethnic distribution consists of 74.4% White alone, 10.3% Black alone, and 11.6% Hispanic Alone.



### Methodology

 Descriptive Volusia County population demographics compared with the utilization records of Volusia County Emergency Department Data

Then Age-adjust ED Utilizations records with Race/Ethnicity and compare to identify disparities





### Conclusions

- Emergency Department utilization has increased from 2010-2014 among all Volusia County Residents
- ► The proportion of Black Emergency Department users is not congruent with the proportion Black residents in Volusia County, thus a disparity exists
- ► The Age-adjusted rate of Emergency Department utilization among Black Residents of Volusia County has consistently been nearly double the rate of Hispanic and White Residents.



#### Conclusions

While the overall Age-adjusted rate of Emergency Department utilization in Volusia County has increased (5.1%) from 2010-2014, Hispanic utilization in the same time period has experienced the largest rise, more than tripling the county rate (16.2%)
