During the period January 1, 2018 to March 31, 2018 5,432 pharmacies out of 6,651 (82 percent) pharmacies were found to be in compliance with reporting requirements.


Among all licensed health care practitioners, pharmacists have the highest registration rate, 59.7 percent. Additionally, pharmacists have the highest utilization rate, 91.4 percent, and have queried the database 22,709,730 times.

Among all prescribers, osteopathic physicians have the highest registration rate, 40.8 percent. Overall 29.2 percent of all licensed health care practitioners have registered to use the database. In addition, 79.7 percent of all healthcare practitioners registered to use the database have queried 42,537,334 times.
