

## E-FORCSE MEANINGFUL USE ATTESTATION— Submission of Dispensing Information

Florida's Prescription Drug Monitoring Program, E-FORCSE, maintained by the Florida Department of Health (FDOH) has identified itself as a specialized registry for Meaningful Use (MU) Stage 2. EPs may continue to utilize E-FORCSE for MU Stage 3, however, the registry is now classified as a public health registry. Below is an explanation designed to help Eligible professionals (EPs) get started and prepared for Meaningful Use (MU) Stage 3 Public Health Reporting attestation regarding submission of patient specific controlled substance dispensing information.

- 1 Open an Internet browser window and type <u>https://pmpclearinghouse.net</u> into the address bar.
- 2 Enter your User Name and Password in the authentication window and click Login.
- 3 Click File Submissions from the top menu.
- 4 Click Advanced Options and enter the Submission Begin Date and Submission End Date.
