



Florida Arbovirus Surveillance Week 16: April 14-20, 2019

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), and St. Louis encephalitis virus (SLEV), as well as exotic viruses such as dengue virus (DENV), chikungunya virus (CHIKV) and California encephalitis group viruses (CEV). Malaria, a parasitic mosquito-borne disease is also included. During the period of April 14-20, 2019, the following arboviral activity was recorded in Florida.

WNV activity: No human cases of WNV infection were reported this week. No horses with WNV infection were reported this week. No sentinel chickens tested positive for antibodies to WNV this week in. In 2019, one horse and 12 sentinel chickens have been reported from eight counties.

SLEV activity: No human cases of SLEV infection were reported this week. No sentinel chickens tested positive for antibodies to SLEV this week. In 2019, no positive samples have been reported.

EEEV activity: No human cases of EEEV infection were reported this week. No horses with EEEV infection were reported this week. Two sentinel chickens tested positive for antibodies to EEEV this week in Seminole and St. Johns counties. In 2019, eight horses, one emu, and 20 sentinel chickens have been reported from 11 counties.

International Travel-Associated Dengue Fever Cases: No cases of dengue fever were reported this week in persons that had international travel. In 2019, 22 travel-associated cases have been reported.

Dengue Fever Cases Acquired in Florida: No cases of locally acquired dengue fever were reported this week. In 2019, no cases of locally acquired dengue fever have been reported.

International Travel-Associated Chikungunya Fever Cases: No cases of chikungunya fever were reported this week in persons that had international travel. In 2019, two travel-associated cases have been reported.

Chikungunya Fever Cases Acquired in Florida: No cases of locally acquired chikungunya fever were reported this week. In 2019, no cases of locally acquired chikungunya fever have been reported.

International Travel-Associated Zika Fever Cases: No cases of Zika fever were reported this week in persons that had international travel. In 2019, 13 travel-associated cases have been reported.

Zika Fever Cases Acquired in Florida: No cases of locally acquired Zika fever were reported this week. In 2019, no cases of locally acquired Zika fever have been reported.

Advisories/Alerts: Bay, Calhoun, and Walton counties are currently under a mosquito-borne illness advisory. No other counties are currently under mosquito-borne illness advisory or alert.

2019 Human Case Summary*

International Travel-Associated Chikungunya Fever Cases: Two cases of chikungunya fever with onset in 2019 have been reported in individuals with travel history to a chikungunya endemic country in the two weeks prior to onset. Countries of origin were: Brazil and Thailand. Counties reporting cases were: Orange and Palm Beach.

International Travel-Associated Dengue Fever Cases: Twenty-two cases of dengue fever with onset in 2019 have been reported in individuals with travel history to a dengue endemic country in the two weeks prior to onset. Countries of origin were: Colombia, Cuba (14), Jamaica (4), Mexico, and Venezuela (2). Counties reporting cases were: Broward (4), Hillsborough, Lake, Miami-Dade (14), Orange, and Palm Beach. One case was reported in a non-Florida resident. In 2019, 19 cases of dengue reported in Florida have been serotyped by PCR. Additional serotyping and strain typing are being conducted.


International Travel-Associated Zika Fever Cases: In 2019, 13 cases of Zika fever have been reported in individuals with travel history to a country or area experiencing Zika virus activity. Countries of origin were: Brazil, Guatemala (3), Haiti (5), Jamaica, Nicaragua, Philippines, and Venezuela. Counties reporting cases were: Broward, Collier, Indian River, Miami-Dade (7), and Orange (3). One case was reported in a non-Florida resident. Florida is monitoring a total of nine pregnant women in 2019.

International Travel-Associated Malaria Cases: Eight cases of malaria with onset in 2019 have been reported. Countries of origin were: Angola, Congo, Democratic Republic of the Congo (2), Ivory Coast, Kenya, and Nigeria (2). Counties reporting cases were: Hillsborough (2), Miami-Dade (2), Orange, Pasco, and Pinellas (2). All eight cases were diagnosed with *Plasmodium falciparum*.


Veterinary Cases*

Veterinary WNV Disease in Florida, April 2018-2019




Sentinel Chickens*


Two sentinel chickens tested positive for antibodies to EEEV this week in Seminole and St. Johns counties.


Dead Birds


The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, six reports representing a total of eight dead birds, including two crows, one raptor, and one dove, were received from six counties.

In 2019, 139 reports representing a total of 216 dead birds (6 crows, 2 jays, 39 raptors, and 8 doves) were received from 36 of Florida's 67 counties. Please note that FWC collects reports of birds that have died from a variety of causes, not only arboviruses. Dead birds should be reported to www.myfwc.com/bird/.

Case tallies included in the weekly Florida arbovirus surveillance report include confirmed and probable cases for EEE, WNV infection, SLE, dengue, chikungunya, and malaria by date of onset. Suspect cases are not included. Activity is mapped by county of exposure rather than county of residence. Case definitions being used in Florida are consistent with national criteria provided by the Council of State and Territorial Epidemiologists (CSTE) and may be viewed at: www.floridahealth.gov/diseases-and-conditions/disease-reporting-and-management/disease-reporting-and-surveillance/index.html. Case tallies reported by CDC do not include suspect cases and cases are reported by patient state of residence rather than where the exposure occurred. Data is provided by county health departments, Department of Health Bureau of Public Health Laboratories, Department of Agriculture and Consumer Services, mosquito control agencies, Florida Fish and Wildlife Conservation Commission, medical providers and veterinarians. Equine cases are provided by the Department of Agriculture and Consumer Services.
