



Florida Arbovirus Surveillance Week 24: June 7-13, 2020

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), and St. Louis encephalitis virus (SLEV), as well as exotic viruses such as dengue virus (DENV), chikungunya virus (CHIKV), Zika virus (ZIKV), and California encephalitis group viruses (CEV). Malaria, a parasitic mosquito-borne disease is also included. During the period of June 7-13, 2020, the following arboviral activity was recorded in Florida.

WNV activity: Two asymptomatic blood donors were identified as WNV-positive this week in Miami-Dade County. One horse with WNV infection was reported this week in Holmes County. One crow with WNV infection was reported this week in Miami-Dade County. No sentinel chickens tested positive for antibodies to WNV this week. In 2020, four blood donors, one horse, one crow, and 34 sentinel chickens have been reported from 10 counties.

SLEV activity: No human cases of SLEV infection were reported this week. No sentinel chickens tested positive for antibodies to SLEV this week. In 2020, no positive samples have been reported.

EEEV activity: No human cases of EEEV infection were reported this week. Two horses with EEEV infection were reported this week in Holmes County. No sentinel chickens tested positive for antibodies to EEEV this week. In 2020, 12 sentinel chickens, five horses, one duck, and one mosquito pool have been reported from eight counties.

International Travel-Associated Dengue Fever Cases: One case of dengue fever was reported this week in a person that had international travel. In 2020, 29 travel-associated cases have been reported.

Dengue Fever Cases Acquired in Florida: No cases of locally acquired dengue fever were reported this week. In 2020, two cases of locally acquired dengue fever have been reported from two counties.

International Travel-Associated Chikungunya Fever Cases: No cases of chikungunya fever were reported this week in persons that had international travel. In 2020, no travel-associated chikungunya fever cases have been reported.

Chikungunya Fever Cases Acquired in Florida: No cases of locally acquired chikungunya fever were reported this week. In 2020, no cases of locally acquired chikungunya fever have been reported.

International Travel-Associated Zika Fever Cases: No cases of Zika fever were reported this week in persons that had international travel. In 2020, no travel-associated Zika fever cases have been reported.

Zika Fever Cases Acquired in Florida: No cases of locally acquired Zika fever were reported this week. In 2020, no cases of locally acquired Zika fever have been reported.

Advisories/Alerts: Monroe County is currently under a mosquito-borne illness advisory. Miami-Dade County is currently under a mosquito-borne illness alert. No other counties are currently under mosquito-borne illness advisory or alert.

There is a Level 2 Travel Health Notice for Nigeria related to the transmission of yellow fever virus. A Level 1 Travel Health Notice has been issued for Ethiopia related to the transmission of yellow fever and chikungunya viruses. There are also Level 1 Travel Health Notices for Central and South America, Mexico, the Caribbean, Asia, the Pacific Islands, Africa, and the Middle East related to the transmission of dengue virus, and for

2020 Human Case Summary*

West Nile Virus Illnesses Acquired in Florida: Four asymptomatic positive blood donors have been reported in 2020 from Miami-Dade County (May and June).

International Travel-Associated Dengue Fever Cases: Twenty-nine cases of dengue fever with onset in 2020 have been reported in individuals with travel history to a dengue endemic area in the two weeks prior to onset. Counties reporting cases were: Brevard, Broward (5), Clay, Collier, Duval, Franklin, Hillsborough (3), Miami-Dade (11), Orange, Palm Beach, Sarasota, Seminole, and St. Lucie. Four cases were reported in non-Florida residents. In 2020, 18 cases of dengue reported in Florida have been serotyped by PCR. Please see the table below for a breakdown of cases by country of origin and serotype.

Dengue Fever Cases Acquired in Florida: In 2020, two cases of locally acquired dengue fever have been reported in Miami-Dade and Monroe counties, with onsets in February and March. One case was reported in a non-Florida resident.

International Travel-Associated Malaria Cases: Eight cases of malaria with onset in 2020 have been reported. Countries of origin were: Cameroon, Dominican Republic, Kenya (2), Nicaragua, Nigeria, Uganda, and Venezuela. Counties reporting cases were: Broward (2), Miami-Dade (2), Orange, Osceola, Palm Beach, and Polk. Two cases were reported in non-Florida residents.


Five cases (63%) were diagnosed with *Plasmodium falciparum*. Two cases (25%) were diagnosed with *Plasmodium vivax*. The *Plasmodium* species for one case (12%) was unknown due to low parasitemia.

Veterinary Cases*


*Veterinary cases are reported by date of onset. Only mammalian veterinary cases are included in the graphs.

Veterinary EEEV Disease in Florida, June 2019-2020




Sentinel Chickens*


The table below is for the reporting of confirmatory laboratory results from this week. Some of the samples were collected at earlier dates. The date of collection is recorded for samples collected on that day along with the total number of positives and the corresponding seroconversion rate for the week the sample was collected.

Sentinel chicken testing has been reinstated. This week, chickens were screened for previous arbovirus exposure prior to using them for current arbovirus surveillance efforts.

Dead Birds


The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, 10 reports representing a total of 16 dead birds, including five raptors, were received from eight counties.


In 2020, 210 reports representing a total of 524 dead birds (36 crows, 19 jays, 59 raptors, 24 doves) were received from 39 of Florida's 67 counties.

Case tallies included in the weekly Florida arbovirus surveillance report include confirmed and probable cases for EEE, WNV infection, SLE, dengue, chikungunya, and malaria by date of onset. Suspect cases are not included. Activity is mapped by county of exposure rather than county of residence. Case definitions being used in Florida are consistent with national criteria provided by the Council of State and Territorial Epidemiologists (CSTE) and may be viewed at: www.floridahealth.gov/diseases-and-conditions/disease-reporting-and-management/disease-reporting-and-surveillance/index.html. Case tallies reported by CDC do not include suspect cases and cases are reported by patient state of residence rather than where the exposure occurred. Data is provided by county health departments, Department of Health Bureau of Public Health Laboratories, Department of Agriculture and Consumer Services, mosquito control agencies, Florida Fish and Wildlife Conservation Commission, medical providers and veterinarians. Equine cases are provided by the Department of Agriculture and Consumer Services.
