



## Florida Arbovirus Surveillance Week 34: August 16-22, 2020

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), and St. Louis encephalitis virus (SLEV), as well as exotic viruses such as dengue virus (DENV), chikungunya virus (CHIKV), Zika virus (ZIKV), and California encephalitis group viruses (CEV). Malaria, a parasitic mosquito-borne disease is also included. During the period of August 16-22, 2020, the following arboviral activity was recorded in Florida.

**WNV activity:** Thirteen human cases of WNV infection were reported this week in Broward and Miami-Dade counties. Five horses with WNV infection were reported this week in Broward, Lee, and Manatee counties. Five sentinel chickens tested positive for antibodies to WNV this week in Martin and St. Lucie counties. In 2020, positive samples from 17 humans, 31 asymptomatic blood donors, six horses, four crows, 11 blue jays, two ibises, 12 mosquito pools, and 73 sentinel chickens have been reported from 18 counties.

**SLEV activity:** No human cases of SLEV infection were reported this week. No sentinel chickens tested positive for antibodies to SLEV this week. In 2020, no positive samples have been reported.

**EEEV activity:** No human cases of EEEV infection were reported this week. No horses with EEEV infection were reported this week. One sentinel chicken tested positive for antibodies to EEEV this week in Walton County. Two sparrows with EEEV infection were reported this week in Nassau County. In 2020, positive samples from 25 sentinel chickens, 16 horses, one duck, two sparrows, and one mosquito pool have been reported from 16 counties.

**International Travel-Associated Dengue Fever Cases:** No cases of dengue fever were reported this week in persons that had international travel. In 2020, 32 travel-associated cases have been reported.

**Dengue Fever Cases Acquired in Florida:** Five cases of locally acquired dengue fever were reported in Monroe County this week. These were identified through retrospective case finding efforts to better characterize activity early in the outbreak. In 2020, 53 cases of locally acquired dengue fever have been reported.

**International Travel-Associated Chikungunya Fever Cases:** No cases of chikungunya fever were reported this week in persons that had international travel. In 2020, no travel-associated chikungunya fever cases have been reported.

**Chikungunya Fever Cases Acquired in Florida:** No cases of locally acquired chikungunya fever were reported this week. In 2020, no cases of locally acquired chikungunya fever have been reported.

**International Travel-Associated Zika Fever Cases:** No cases of Zika fever were reported this week in persons that had international travel. In 2020, no travel-associated Zika fever cases have been reported.

**Zika Fever Cases Acquired in Florida:** No cases of locally acquired Zika fever were reported this week. In 2020, no cases of locally acquired Zika fever have been reported.

**Advisories/Alerts:** Bradford, Holmes, Lee, and Martin counties are currently under a mosquito-borne illness advisory. Broward, Miami-Dade, Monroe, and Palm Beach counties are currently under a mosquito-borne illness alert. No other counties are currently under mosquito-borne illness advisory or alert.

A Level 1 Travel Health Notice has been issued for Central and South America, Mexico, the Caribbean, Asia, the Pacific Islands, Africa, and the Middle East related to the transmission of dengue virus, for Ethiopia related to chikungunya virus transmission, and for Burundi related to malaria transmission. ## 2020 Human Case Summary\*

**West Nile Virus Illnesses Acquired in Florida:** Seventeen human cases of WNV illness acquired in Florida have been reported in 2020: 13 in Miami-Dade County (June, July), two in Palm Beach County (July), and two in Broward County (July). Thirty-one asymptomatic positive blood donors have been reported in 2020 from Miami-Dade County (May, June, July, and August).

**International Travel-Associated Dengue Fever Cases:** Thirty-two cases of dengue fever with onset in 2020 have been reported in individuals with travel history to a dengue endemic area in the two weeks prior to onset. Counties reporting cases were: Brevard (2), Broward (5), Clay, Collier, Duval, Franklin, Hillsborough (3), Miami-Dade (13), Orange, Palm Beach, Sarasota, Seminole, and St. Lucie. Five cases were reported in non-Florida residents. In 2020, 20 cases of dengue reported in Florida have been serotyped by PCR. **Dengue Fever Cases Acquired in Florida:** In 2020, 53 cases of locally acquired dengue fever have been reported in Miami-Dade and Monroe (52) counties, with onsets in February, March, April, May, June, July, and August. One case was reported in a non-Florida resident.

**International Travel-Associated Malaria Cases:** Nine cases of malaria with onset in 2020 have been reported. Countries of origin were: Cameroon, Dominican Republic, Kenya (2), Nicaragua, Nigeria, Sierra Leone, Uganda, and Venezuela. Counties reporting cases were: Broward (3), Miami-Dade (2), Orange, Osceola, Palm Beach, and Polk. Two cases were reported in non-Florida residents.


Five cases (56%) were diagnosed with *Plasmodium falciparum*. Two cases (22%) were diagnosed with *Plasmodium vivax*. One case (11%) was diagnosed with *Plasmodium ovale*. The *Plasmodium* species for one case (11%) was unknown due to low parasitemia.



**Veterinary EEEV Disease in Florida, August 2019-2020**




## Sentinel Chickens\*



## Dead Birds


The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, seven reports representing a total of 21 dead birds, including one raptor, were received from four counties.


In 2020, 278 reports representing a total of 739 dead birds (41 crows, 35 jays, 69 raptors, 34 doves) were received from 40 of Florida's 67 counties.

Case tallies included in the weekly Florida arbovirus surveillance report include confirmed and probable cases for EEE, WNV infection, SLE, dengue, chikungunya, and malaria by date of onset. Suspect cases are not included. Activity is mapped by county of exposure rather than county of residence. Case definitions being used in Florida are consistent with national criteria provided by the Council of State and Territorial Epidemiologists (CSTE) and may be viewed at: [www.floridahealth.gov/diseases-and-conditions/disease-reporting-and-management/disease-reporting-and-surveillance/index.html](http://www.floridahealth.gov/diseases-and-conditions/disease-reporting-and-management/disease-reporting-and-surveillance/index.html). Case tallies reported by CDC do not include suspect cases and cases are reported by patient state of residence rather than where the exposure occurred. Data is provided by county health departments, Department of Health Bureau of Public Health Laboratories, Department of Agriculture and Consumer Services, mosquito control agencies, Florida Fish and Wildlife Conservation Commission, medical providers and veterinarians. Equine cases are provided by the Department of Agriculture and Consumer Services.
