



Florida Arbovirus Surveillance Week 24: June 12-18, 2022

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), and St. Louis encephalitis virus (SLEV), as well as exotic viruses such as dengue virus (DENV), chikungunya virus (CHIKV), Zika virus (ZIKV) and California encephalitis group viruses (CEV). Malaria, a parasitic mosquito-borne disease is also included. During the period of June 12-18, 2022, the following arboviral activity was recorded in Florida.

WNV activity: No human cases of WNV infection were reported this week. No horses with WNV infection were reported this week. No sentinel chickens tested positive for antibodies to WNV this week. In 2022, positive samples from five sentinel chickens have been reported from two counties.

SLEV activity: No human cases of SLEV infection were reported this week. No sentinel chickens tested positive for antibodies to SLEV this week. In 2022, one positive sample has been reported from one county.

Flavivirus (WNV or SLEV)* activity: No sentinel chickens tested positive for antibodies to a flavivirus this week. In 2022, positive samples from two sentinel chickens have been reported from two counties.

EEEV activity: No human cases of EEEV infection were reported this week. No horses with EEEV infection were reported this week. Two sentinel chickens tested positive for antibodies to EEEV this week in Citrus and Orange counties. In 2022, positive samples from 24 sentinel chickens and three horses have been reported from 12 counties.

International Travel-Associated Dengue Fever: One case of dengue fever was reported this week in a person that had international travel. In 2022, 32 travel-associated dengue fever cases have been reported.

Dengue Fever Cases Acquired in Florida: No cases of locally acquired dengue fever were reported this week. In 2022, no cases of locally acquired dengue fever have been reported.

International Travel-Associated Chikungunya Fever Cases: No cases of chikungunya fever were reported this week in persons that had international travel. In 2022, no travel-associated chikungunya fever cases have been reported.

Chikungunya Fever Cases Acquired in Florida: No cases of locally acquired chikungunya fever were reported this week. In 2022, no cases of locally acquired chikungunya fever have been reported.

International Travel-Associated Zika Fever Cases: No cases of Zika fever were reported this week in persons that had international travel. In 2022, no travel-associated Zika fever cases have been reported.

Zika Fever Cases Acquired in Florida: No cases of locally acquired Zika fever were reported this week. In 2022, no cases of locally acquired Zika fever have been reported.

Advisories/Alerts: Osceola County is currently under a mosquito-borne illness advisory. No other counties are currently under a mosquito-borne illness advisory or alert.

There are currently multiple travel health notices from the Centers for Disease Control and Prevention related to mosquito-borne diseases.

2022 Human Case Summary

International Travel-Associated Dengue Fever Cases: Thirty-two cases with onset in 2022 have been reported in individuals with travel history to a dengue endemic area in the two weeks prior to onset. Counties reporting cases were: Brevard, Broward, Hillsborough (2), Hendry, Lee, Manatee, Miami-Dade (20), Orange (2), Palm Beach, Pinellas, and Polk. Four cases were reported in non-Florida residents. In 2022, 29 cases of dengue reported in Florida have been serotyped by PCR. Please see the table below for a breakdown of case by country of origin and serotype.

International Travel-Associated Malaria Cases: Twenty-three cases of malaria with onset in 2022 have been reported. Countries of origin were: Brazil (3), Ethiopia, Equatorial Guinea, Kenya, Nicaragua (3), Nigeria (8), Sierra Leone (2), Sudan, Uganda (2), and Zambia. Counties reporting cases were: Broward (3), Duval (3), Flagler, Hillsborough (3), Lee (3), Leon, Miami-Dade (2), Orange (2), Palm Beach (2), Pasco, Santa Rosa, and St. Johns. Four cases were reported in non-Florida residents.


Thirteen cases (57%) were diagnosed with *Plasmodium falciparum*. Eight cases (35%) were diagnosed with *Plasmodium vivax*. Two cases (9%) were diagnosed with *Plasmodium malariae*.


**Veterinary cases are reported by date of onset. Only mammalian veterinary cases are included in the graphs.

Veterinary EEEV Disease in Florida, June 2021-2022




Sentinel Chickens


Two sentinel chickens tested positive for antibodies to EEEV this week in Citrus and Orange counties.

Dead Birds

The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, 29 reports representing a total of 106 dead birds, including 5 crows, 8 raptors, and 3 doves, were received from 17 counties.


In 2022, 865 reports representing a total of 2162 dead birds (92 crows, 25 jays, 130 raptors, 55 doves) were received from 54 of Florida's 67 counties.

*Two chickens in 2022 have tested positive for flavivirus antibodies and require additional specialized testing to distinguish between WNV and SLEV antibodies. Testing is currently delayed due to supply chain issues. The final determination of these birds will be updated as more information becomes available. In Florida, both WNV and SLEV have similar disease vectors and epidemiology. Seroconversion rates for flavivirus are included in the table.

Case tallies included in the weekly Florida arbovirus surveillance report include confirmed and probable cases for EEE, WNV infection, SLE, dengue, chikungunya, and malaria by date of onset. Suspect cases are not included. Activity is mapped by county of exposure rather than county of residence. Case definitions being used in Florida are consistent with national criteria provided by the Council of State and Territorial Epidemiologists (CSTE) and may be viewed at: www.floridahealth.gov/diseases-and-conditions/disease-reporting-and-management/disease-reporting-and-surveillance/index.html. Case tallies reported by CDC do not include suspect cases and cases are reported by patient state of residence rather than where the exposure occurred. Data is provided by county health departments, Department of Health Bureau of Public Health Laboratories, Department of Agriculture and Consumer Services, mosquito control agencies, Florida Fish and Wildlife Conservation Commission, medical providers and veterinarians. Equine cases are provided by the Department of Agriculture and Consumer Services.
