



Florida Arbovirus Surveillance Week 26: June 25-July 1, 2023

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), and St. Louis encephalitis virus (SLEV), as well as exotic viruses such as dengue virus (DENV), chikungunya virus (CHIKV), Zika virus (ZIKV) and California encephalitis group viruses (CEV). Malaria, a parasitic mosquito-borne disease is also included. During the period of June 25-July 1, 2023, the following arboviral activity was recorded in Florida.

WNV activity: No human cases of WNV infection were reported this week. No horses with WNV infection were reported this week. No sentinel chickens tested positive for antibodies to WNV this week. No mosquito pools tested positive for WNV this week. In 2023, positive samples from six sentinel chickens and one horse have been reported from five counties.

SLEV activity: No human cases of SLEV infection were reported this week. No sentinel chickens tested positive for antibodies to SLEV this week. In 2023, no sentinel chickens tested positive for SLEV.

EEEV activity: No human cases of EEEV infection were reported this week. One horse with EEEV infection was reported this week in Jefferson County. Eleven sentinel chickens tested positive for antibodies to EEEV this week in Nassau, St. Johns, and Walton counties. In 2023, positive samples from 61 sentinel chickens and six horses have been reported from 13 counties.

International Travel-Associated Dengue: One case of dengue was reported this week in a person that had international travel. In 2023, 101 travel-associated dengue cases have been reported.

Dengue Cases Acquired in Florida: No cases of locally acquired dengue were reported this week in Miami-Dade County. In 2023, two cases of locally acquired dengue have been reported.

International Travel-Associated Chikungunya Fever Cases: One case of chikungunya fever was reported this week in a person that had international travel. In 2023, one case of travel-associated chikungunya fever has been reported.

Chikungunya Fever Cases Acquired in Florida: No cases of locally acquired chikungunya fever were reported this week. In 2023, no cases of locally acquired chikungunya fever have been reported.

International Travel-Associated Zika Fever Cases: No cases of Zika fever were reported this week in persons that had international travel. In 2023, no travel-associated Zika fever cases have been reported.

Zika Fever Cases Acquired in Florida: No cases of locally acquired Zika fever were reported this week. In 2023, no cases of locally acquired Zika fever have been reported.

Malaria Cases Acquired in Florida: Two cases of locally acquired malaria were reported this week in Sarasota County. In 2023, six cases of locally acquired malaria have been reported.

Advisories/Alerts: Orange, Polk, and Walton counties are currently under a mosquito-borne illness advisory. Manatee, Miami-Dade, and Sarasota counties are currently under a mosquito-borne illness alert. No other counties are currently under a mosquito-borne illness advisory or alert.

There are currently multiple travel health notices from the Centers for Disease Control and Prevention related to mosquito-borne diseases.

2023 Human Case Summary

2023 International Travel-Associated Chikungunya cases: One case with onset in 2023 has been reported in an individual with travel history to a chikungunya-endemic area in the two weeks prior to onset. County reporting case was: Lee. Country of origin was: Brazil.

2023 International Travel-Associated Dengue Cases: One hundred and one cases with onset in 2023 have been reported in individuals with travel history to a dengue-endemic area in the two weeks prior to onset. Counties reporting cases were: Brevard, Broward (8), Collier (2), Duval, Escambia, Hendry, Hillsborough (7), Lee, Manatee, Miami-Dade (64), Monroe, Nassau, Orange (3), Osceola, Palm Beach (2), Pasco, Sarasota, St. Lucie (2), and Volusia (2). Five cases were reported in non-Florida residents. One case met the criteria for severe dengue (dengue shock syndrome [DSS] or dengue hemorrhagic fever [DHF]). Those at greater risk for DSS and DHF include persons with previous dengue infection, pregnant women, infants, the elderly, and those with co-morbidities. However, severe illness can also occur in those without any of these risk factors. In 2023, 85 cases of dengue reported in Florida have been serotyped by PCR. Please see the table below for a breakdown of cases by country of origin and serotype.

2023 Dengue Cases Acquired in Florida: In 2023, two cases of locally acquired dengue have been reported in Miami-Dade County, with onsets in January and March. Two cases have been serotyped by PCR. Serotypes reported were DENV-3 (2).



2023 International Travel-Associated Malaria Cases: Twenty-three cases of malaria with onset in 2023 have been reported. Countries of origin were: Burundi, Côte D'Ivoire, Democratic Republic of the Congo (2), Equatorial Guinea, Ghana (2), Kenya, multiple countries (4), Nicaragua (2), Nigeria (2), Pakistan, Sierra Leone (2), Sudan, and Uganda (3). Counties reporting cases were: Broward (4), Duval, Hillsborough (4), Lee, Leon (2), Miami-Dade (5), Orange, Osceola, Pinellas (3), and Sarasota. Seven cases were reported in non-Florida residents.

Thirteen cases (56%) were diagnosed with *Plasmodium falciparum*. Eight cases (35%) were diagnosed with *Plasmodium vivax*. Two cases (9%) were diagnosed with *Plasmodium malariae*.

2023 Malaria Cases Acquired in Florida: In 2023, six cases of locally acquired malaria have been reported in Sarasota County, with onsets in May and June (5). The *Plasmodium* species reported were *Plasmodium vivax*.

Veterinary Cases**

**Veterinary cases are reported by date of onset. Only mammalian veterinary cases are included in the graphs. One horse with EEEV infection was reported this week in Jefferson County.




Sentinel Chickens


Eleven sentinel chickens tested positive for antibodies to EEEV this week in Nassau, St. Johns, and Walton counties.

Dead Birds


The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, 26 reports representing a total of 54 dead birds, including one crow, one jay, three raptors, and 17 doves, were received from 15 counties.


In 2023, 565 reports representing a total of 1260 dead birds (46 crows, 46 jays, 101 raptors, 89 doves) were received from 48 of Florida's 67 counties.

Case tallies included in the weekly Florida arbovirus surveillance report include confirmed and probable cases for EEE, WNV infection, SLE, dengue, chikungunya, and malaria by date of onset. Suspect cases are not included. Activity is mapped by county of exposure rather than county of residence. Case definitions being used in Florida are consistent with national criteria provided by the Council of State and Territorial Epidemiologists (CSTE) and may be viewed at: www.floridahealth.gov/diseases-and-conditions/disease-reporting-and-management/disease-reporting-and-surveillance/index.html. Case tallies reported by CDC do not include suspect cases and cases are reported by patient state of residence rather than where the exposure occurred. Data is provided by county health departments, Department of Health Bureau of Public Health Laboratories, Department of Agriculture and Consumer Services, mosquito control agencies, Florida Fish and Wildlife Conservation Commission, medical providers and veterinarians. Equine cases are provided by the Department of Agriculture and Consumer Services.
