

**Florida Arbovirus Surveillance**  
**Week 10: March 7-13, 2010**

Arbovirus surveillance in Florida includes endemic viruses West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), St. Louis encephalitis virus (SLEV), and Highlands J virus (HJV) and imported viruses such as Dengue virus (DENV) and California encephalitis group viruses (CEV). During the period March 7-13, 2010, the following arboviral activity was recorded in Florida:

**EEEV activity:** No EEEV activity was reported this week. In 2010, positive samples from four sentinel chickens and three live wild birds have been received from five of Florida’s 67 counties.

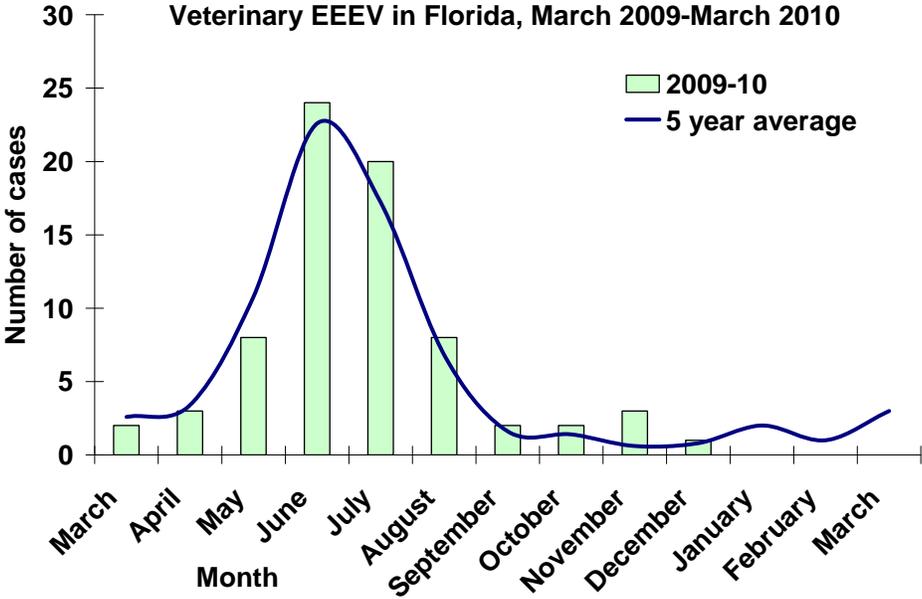
**WNV activity:** One sentinel chicken in Palm Beach County tested positive for antibodies to WNV. In 2010, positive samples from ten sentinel chickens have been received from four counties.

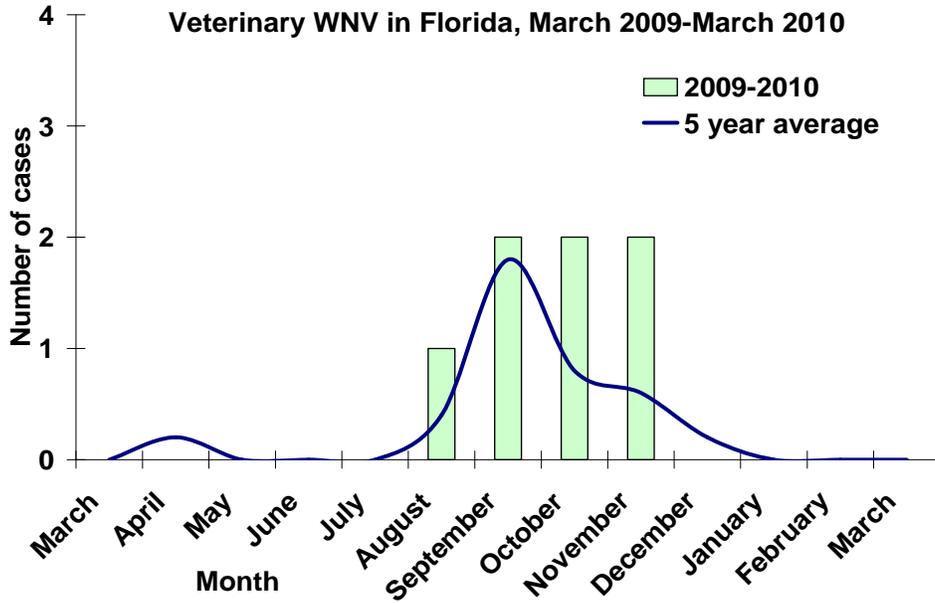
**HJV activity:** No HJV activity has been reported in 2010.

**Advisories/Alerts:** No counties are currently under mosquito-borne illness advisory or alert.

**Veterinary Cases**

No positive horses were reported this week.







## Sentinel Chickens

There was one seroconversion to WNV in a sentinel chickens from Palm Beach County. Seroconversion rates are calculated by week and include previously reported results.


### Live Wild Birds


No positive live wild birds were reported this week.

### Dead Birds

The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, four reports representing 26 dead birds were received from two counties. None were identified as crows, jays, or raptors. In 2010, 59 reports representing a total of 236 dead birds (1 crow, 1 jay, 10 raptors, 224 others) have been received from 29 of Florida's 67 counties. Please note that FWC collects reports of birds that have died from a variety of causes, not only arboviruses. Dead birds should be reported to [www.myfwc.com/bird/](http://www.myfwc.com/bird/).
