



Florida Arbovirus Surveillance

Week 14: April 3-9, 2016

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), and St. Louis encephalitis virus (SLEV), as well as exotic viruses such as dengue virus (DENV), chikungunya virus (CHIKV) and California encephalitis group viruses (CEV). Malaria, a non-viral mosquito-borne disease is also included. During the period of April 3-9, 2016 the following arboviral activity was recorded in Florida.

WNV activity: No human cases of WNV infection were reported this week. No horses with WNV infection were reported this week. No sentinel chickens tested positive for antibodies to WNV this week. In 2016, positive samples from 28 sentinel chickens have been received from seven counties.

SLEV activity: No human cases of SLEV infection were reported this week. No sentinel chickens tested positive for antibodies to SLEV this week. In 2016, there have been no positive samples reported.

EEEV activity: No human cases of EEEV infection were reported this week. No horses with EEEV infection were reported this week. No sentinel chickens tested positive for antibodies to EEEV this week. In 2016, positive samples from 12 sentinel chickens have been received from three counties.

International Travel-Associated Dengue Fever Cases: Two cases of dengue fever were reported this week in persons that had international travel. In 2016, 23 travel-associated cases have been reported.

Dengue Fever Cases Acquired in Florida: No cases of locally acquired dengue fever were reported this week. In 2016, no cases of locally acquired dengue fever have been reported.

International Travel-Associated Chikungunya Fever Cases: No cases of chikungunya fever were reported this week in persons that had international travel. In 2016, three travel-associated cases have been reported.

Chikungunya Fever Cases Acquired in Florida: No cases of locally acquired chikungunya fever were reported this week. In 2016, no cases of locally acquired chikungunya fever have been reported.

International Travel-Associated Zika Fever Cases: Six cases of Zika fever were reported this week in persons that had international travel. In 2016, 85 travel-associated cases have been reported. No cases of locally acquired Zika fever have been reported.

Advisories/Alerts: Fifteen counties are currently under a declared public health emergency due to the identification of travel-associated Zika infections: Alachua, Brevard, Broward, Clay, Collier, Hillsborough, Lee, Miami-Dade, Orange, Osceola, Palm Beach, Polk, St. Johns, Santa Rosa, and Seminole Counties. There is a Level 2 (Alert) Travel Health Notice from the CDC for multiple countries in the Caribbean, Central and South America, Mexico, Cape Verde, and Pacific Islands related to Zika virus transmission and a possible association with poor pregnancy outcomes. Pregnant women should consider postponing travel to these areas. There is a Level 1 (Watch) Travel Health Notice from the CDC for multiple countries in the Caribbean, Central and South America, and Mexico, related to the transmission of chikungunya virus. 2016 Human Case Summary*

International Travel-Associated Chikungunya Fever Cases: Three cases of chikungunya with onset in 2016 have been reported in individuals with travel history to a chikungunya endemic country in the two weeks prior to onset. Countries of origin were Bahamas/Mexico and Bolivia (2). Counties reporting cases were Broward, Duval, and Hillsborough.

International Travel-Associated Dengue Fever Cases: Twenty-three cases of dengue with onset in 2016 have been reported in individuals with travel history to a dengue endemic country in the two weeks prior to onset. Countries of origin were: Brazil (3), Colombia, Costa Rica (2), Cuba (6), Dominican Republic, El Salvador, St. Barthelemy, Haiti (3), Jamaica, Mexico, and Venezuela (3). Counties reporting cases were: Alachua (2), Broward (5), Clay, Hillsborough (2), Miami-Dade (6), Orange (3), Palm Beach, Sarasota, and Seminole (2). Two cases were reported in non-Florida residents. In 2016, 18 of the 23 cases of dengue reported in Florida have been serotyped by PCR. Additional serotyping and strain typing are being conducted.

International Travel-Associated Zika Fever Cases: Eighty-five cases of Zika fever have been reported in individuals with travel history to a country or area experiencing Zika virus activity. Countries of origin were: Belize (2), Brazil (5), Brazil/Bolivia/Peru, Colombia (21), Costa Rica, Dominican Republic (5), El Salvador (4), Guyana (3), Haiti (13), Honduras (6), Honduras/Guatemala, Martinique, Nicaragua (4), Puerto Rico (5), Suriname, and Venezuela (11). Counties reporting cases were: Alachua (4), Brevard (2), Broward (13), Clay, Collier, Hillsborough (3), Lee (4), Miami-Dade (33), Orange (5), Osceola (4), Palm Beach (4), Polk (3), St. Johns, Santa Rosa, and Seminole. Three cases were reported in non-Florida residents. One Polk County case was acquired through sexual transmission. Five of the 85 cases involve pregnant women whose counties of residence are not included in the individual county totals to protect privacy.



International Travel-Associated Malaria Cases: Eight cases of malaria with onset in 2016 have been reported. Countries of origin were: Angola, Cameroon (2), Kenya, Sierra Leone, Sudan, Uganda, and Venezuela. Counties reporting cases were: Broward (2), Flagler, Hillsborough, Orange (2), Palm Beach, and Sarasota Counties. One case was reported in a non-Florida resident.

Six cases (75%) were diagnosed with *Plasmodium falciparum*. One case (13%) was diagnosed with *Plasmodium vivax*. One case (13%) was diagnosed with *Plasmodium malariae*.

No horses with EEEV or WNV infection were reported this week.




Sentinel Chickens*


No sentinel chickens tested positive for antibodies to SLEV, WNV, EEEV or HJV this week.


Dead Birds


The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, 8 reports representing a total of 9 dead birds, including 3 crows, and 1 raptor were received from 5 counties.

In 2016, 187 reports representing a total of 612 dead birds (36 crows, 0 jay, 37 raptors, and 5 doves) were received from 44 of Florida's 67 counties. Please note that FWC collects reports of birds that have died from a variety of causes, not only arboviruses. Dead birds should be reported to www.myfwc.com/bird/.

**Case tallies included in the weekly Florida arbovirus surveillance report include confirmed and probable cases for EEE, WNV infection, SLE, dengue, chikungunya, and malaria by date of onset. Suspect cases are not included. Activity is mapped by county of exposure rather than county of residence. Case definitions being used in Florida are consistent with national criteria provided by the Council of State and Territorial Epidemiologists (CSTE) and may be viewed at: <http://www.floridahealth.gov/diseases-and-conditions/disease-reporting-and-management/disease-reporting-and-surveillance/index.html>. Case tallies reported by CDC do not include suspect cases and cases are reported by patient state of residence rather than where the exposure occurred. Data is provided by county health departments, Department of Health Bureau of Public Health Laboratories, Department of Agriculture and Consumer Services, mosquito control agencies, Florida Fish and Wildlife Conservation Commission, medical providers and veterinarians. Equine cases are provided by the Department of Agriculture and Consumer Services.
