



## Florida Arbovirus Surveillance Week 24: June 9 - 15, 2013

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), St. Louis encephalitis virus (SLEV), and Highlands J virus (HJV) and exotic viruses such as dengue virus (DENV) and California encephalitis group viruses (CEV). Malaria, a non-viral mosquito-borne disease is also included. During the period of June 9 -15, 2013 the following arboviral activity was recorded in Florida:

**DENV activity:** No locally acquired dengue cases have been reported in 2013.

**EEEV activity:** No human cases of EEEV infection were reported this week. Two horses with EEEV infection were reported this week in Gilchrist/Columbia\* and Hamilton Counties. Six sentinel chickens tested positive for antibodies to EEEV this week in Leon, Orange, St. Johns and Walton Counties. In 2013, positive samples from two humans, three birds, nine equines, and 35 sentinel chickens have been received from 17 counties.

**WNV activity:** No human cases of WNV infection have been reported in 2013. No horse cases of WNV infection were reported this week. Four sentinel chickens tested positive this week for antibodies to WNV in Walton County. In 2013, positive samples from 49 sentinel chickens have been received from four counties.

**SLEV activity:** No sentinel chickens tested positive for antibodies to SLEV this week. In 2013, two positive samples have been received from two counties.

**HJV activity:** One sentinel chicken tested positive for antibodies to HJV this week in Bay. In 2013, 10 positive samples have been received from four counties.

**Advisories/Alerts:** Hillsborough and Levy counties are currently under a mosquito-borne illness advisory. No other counties are currently under mosquito-borne illness advisory or alert.

## 2013 Human Case Summary\*

**EEEV Infection Acquired in Florida:** Two human cases of EEEV infection with onset in January (1) and March (1) have been reported in 2013 in Levy (1) and Hillsborough (1) County residents.

**Imported Dengue:** Forty-one cases of dengue with onset in 2013 have been reported in individuals with travel history to a dengue endemic country in the two weeks prior to onset. Countries of origin were: Angola, Barbados, Bolivia, Brazil (3), The Caribbean, Columbia (3), Costa Rica, Dominican Republic (4), Haiti (2), Honduras, Indonesia, Jamaica (4), Nigeria, Panama, Philippines, Puerto Rico (14), and Saint Martin. Counties reporting cases were: Brevard, Broward (4), Clay, Duval, Indian River, Lee, Miami-Dade (14), Orange (8), Osceola (2), Palm Beach (6), St. Lucie, and Volusia. Five of the cases were reported in non-Florida residents.

In 2013, 26 of the 41 cases of dengue reported in Florida have been serotyped by PCR. Additional serotyping and strain typing are being conducted.

**Imported Malaria:** Twenty-two cases of malaria with onset in 2013 have been reported. Countries of origin were: Benin, Democratic Republic of the Congo, Guinea, Ghana (3), Guyana (4), Haiti (5), India, Kenya, Liberia, Nigeria, Sierra Leone (2), and Solomon Islands. Counties reporting cases were: Alachua, Hillsborough (4), Lake, Lee, Miami-Dade (6), Orange (4), Palm Beach (3), Pinellas, and Seminole. One of the cases was reported in a non-Florida resident.


Fifteen cases (68%) were diagnosed with *Plasmodium falciparum*, six (27%) with *Plasmodium vivax*, and one mixed *Plasmodium falciparum/ Plasmodium vivax* (5%).

### Veterinary Cases


Two horses were reported testing positive for EEEV this week in Gilchrist/Columbia\* and Hamilton Counties.

**Veterinary WNV Disease in Florida, June 2012-2013**




**Sentinel Chickens**

The date of collection is recorded for samples collected on that day along with the total number of positives and the corresponding seroconversion rate for the week the sample was collected.


Four sentinel chickens tested positive this week for antibodies to WNV in Walton County. Six sentinel chickens tested positive for antibodies to EEEV this week in Leon, Orange, St. Johns and Walton Counties. One sentinel chicken tested positive for antibodies to HJV this week in Bay County.

### Dead Birds


The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, 7 reports representing 7 dead birds, including 1 crow, 2 raptor were received from 6 counties.



In 2013, 458 reports representing a total of 1522 dead birds (12 crow, 7 jays, 84 raptors, 15 doves) were received from 44 of Florida's 67 counties. Please note that FWC collects reports of birds that have died from a variety of causes, not only arboviruses. Dead birds should be reported to
