



Florida Arbovirus Surveillance Week 28: July 7-13, 2013

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), St. Louis encephalitis virus (SLEV), and Highlands J virus (HJV) and exotic viruses such as dengue virus (DENV) and California encephalitis group viruses (CEV). Malaria, a non-viral mosquito-borne disease is also included. During the period of July 7-13, 2013 the following arboviral activity was recorded in Florida:

DENV activity: No locally acquired dengue cases have been reported in 2013.

EEEV activity: No human cases of EEEV infection were reported this week. Five horses with EEEV infection were reported this week in Gilchrist, Hernando, and Putnam Counties. Eleven sentinel chickens tested positive for antibodies to EEEV this week in Nassau, Orange, St. Johns and Walton Counties. In 2013, positive samples from two humans, three birds, 16 equines, and 64 sentinel chickens have been received from 21 counties.

WNV activity: No human cases of WNV infection have been reported in 2013. No horse cases of WNV infection were reported this week. No sentinel chickens tested positive this week for antibodies to WNV. In 2013, positive samples from 49 sentinel chickens have been received from four counties.

SLEV activity: No sentinel chickens tested positive for antibodies to SLEV this week. In 2013, two positive samples have been received from two counties.

HJV activity: Six sentinel chickens tested positive for antibodies to HJV this week in Duval, Flagler, St. Johns and Walton Counties. In 2013, 17 positive samples have been received from seven counties.

Advisories/Alerts: Bradford, Gilchrist, Hillsborough, and Levy counties are currently under a mosquito-borne illness advisory. No other counties are currently under mosquito-borne illness advisory or alert.

2013 Human Case Summary*

EEEV Infection Acquired in Florida: Two human cases of EEEV infection with onset in January (1) and March (1) have been reported in 2013 in Levy (1) and Hillsborough (1) County residents.

Imported Dengue: Forty-three cases of dengue with onset in 2013 have been reported in individuals with travel history to a dengue endemic country in the two weeks prior to onset. Countries of origin were: Angola, Barbados, Bolivia, Brazil (3), The Caribbean, Columbia (3), Costa Rica, Dominican Republic (4), Haiti (2), Honduras, Indonesia, Jamaica (4), Nigeria, Panama, Philippines, Puerto Rico (16) and Saint Martin. Counties reporting cases were: Brevard, Broward (4), Clay, Duval, Indian River, Lee, Miami-Dade (14), Orange (9), Osceola (3), Palm Beach (6), St. Lucie and Volusia. Six of the cases were reported in non-Florida residents.

In 2013, 27 of the 43 cases of dengue reported in Florida have been serotyped by PCR. Additional serotyping and strain typing are being conducted.


Imported Malaria: Twenty-six cases of malaria with onset in 2013 have been reported. Countries of origin were: Benin, Democratic Republic of the Congo, Guinea, Ghana (3), Guyana (5), Haiti (5), India, Kenya, Liberia, Nigeria (2), Peru, Sierra Leone (2), Solomon Islands, and Uganda. Counties reporting cases were: Alachua, Broward, Hillsborough (5), Lake, Lee, Miami-Dade (6), Orange (5), Palm Beach (3), Pinellas and Seminole (2). One of the cases was reported in a non-Florida resident.


Nineteen cases (73%) were diagnosed with *Plasmodium falciparum*, six (23%) with *Plasmodium vivax*, and one mixed *Plasmodium falciparum/ Plasmodium vivax* (4%).

Veterinary Cases

Five horses were reported testing positive for EEEV this week in Gilchrist, Hernando, and Putnam Counties.


Sentinel Chickens


Eleven sentinel chickens tested positive for antibodies to EEEV this week in Nassau, Orange, St. Johns and Walton Counties. Six sentinel chickens tested positive for antibodies to HJV this week in Duval, Flagler, St. Johns, and Walton Counties.

Dead Birds



The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, 6 reports representing 11 dead birds, including 3 crows and 1 dove were received from 6 counties.

In 2013, 482 reports representing a total of 1570 dead birds (16 crow, 8 jays, 91 raptors, 18 doves) were received from 46 of Florida's 67 counties. Please note that FWC collects reports of birds that have died from a variety of causes, not only arboviruses. Dead birds should be reported to www.myfwc.com/bird/
