



## Florida Arbovirus Surveillance Week 40: October 4-10, 2015

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), and St. Louis encephalitis virus (SLEV), as well as exotic viruses such as dengue virus (DENV), chikungunya virus (CHIKV) and California encephalitis group viruses (CEV). Malaria, a non-viral mosquito-borne disease is also included. During the period of October 4-10, 2015 the following arboviral activity was recorded in Florida.

**WNV activity:** One asymptomatic blood donor was identified as WNV-positive in Hillsborough County. One horse with WNV infection was reported this week in Marion County. Thirty-four sentinel chickens tested positive for antibodies to WNV this week in Hillsborough, Indian River, Manatee, Orange, Pasco, Pinellas, Polk, Putnam, Seminole, St. John, Sumter, Volusia, and Walton Counties. In 2015, positive samples from eight humans, one blood donor, one horse, 11 mosquito pools, and 220 sentinel chickens have been received from 24 counties.

**SLEV activity:** No human cases of SLEV infection were reported this week. No sentinel chickens tested positive for antibodies to SLEV this week. In 2015, positive samples from five sentinel chickens have been received from five counties.

**EEEV activity:** No human cases of EEEV infection were reported this week. No horse with EEEV infection was reported this week. Two sentinel chickens tested positive for antibodies to EEEV this week in Alachua and Nassau Counties. In 2015, positive samples from 68 sentinel chickens, 19 horses, and one goat have been received from 22 counties.

**International Travel-Associated Dengue Fever Cases:** Four cases of dengue fever were reported this week in persons that had international travel. In 2015, 42 travel-associated cases have been reported.

**Dengue Fever Cases Acquired in Florida:** No cases of locally acquired dengue fever were reported this week. In 2015, no cases of locally acquired dengue fever have been reported.

**International Travel-Associated Chikungunya Fever Cases:** One case of chikungunya fever was reported this week in a person that had international travel. In 2015, 61 travel-associated cases have been reported.

**Chikungunya Fever Cases Acquired in Florida:** No cases of locally acquired chikungunya fever were reported this week. In 2015, no cases of locally acquired chikungunya fever have been reported.

**Advisories/Alerts:** Bay, Gadsden, Manatee, Orange, Pinellas, Polk, and Volusia Counties are currently under mosquito-borne illness advisory. Escambia, Hillsborough, and Walton Counties are currently under mosquito-borne illness alert. No other counties are currently under mosquito-borne illness advisory or alert. A CDC Health Alert Network (HAN) health advisory was issued in December 2013 for the Caribbean region announcing the first locally acquired cases of chikungunya fever in the Americas. There is a Level 1 (Watch) Travel Health Notice from the CDC for multiple countries in the Caribbean, Mexico, Central and South America, the Pacific Islands, and Senegal, related to the transmission of chikungunya. There are also similar CDC Travel Health Notices for dengue transmission in Brazil and Malaysia. ## 2015 Human Case Summary\*

**West Nile Virus Illnesses Acquired in Florida:** A total of eight human cases of WNV illness acquired in Florida have been reported in 2015; three in Escambia County (July and August), one in Hillsborough County (September), one in Pinellas County (July), one in Volusia County (July), and two in Walton County (June). One asymptomatic positive blood donor was reported from Hillsborough County (September).

**International Travel-Associated Chikungunya Fever Cases:** Sixty-one cases of chikungunya with onset in 2015 have been reported in individuals with travel history to a chikungunya endemic country or area experiencing an outbreak in the two weeks prior to onset. Countries of origin were: Bolivia, Colombia (13), Ecuador, El Salvador (3), Guatemala (2), Haiti (2), Honduras (5), India (2), Jamaica (2), Mexico (8), Nicaragua (16), Puerto Rico (3), Trinidad and Tobago, Venezuela, and Virgin Islands. Counties reporting cases were: Brevard (2), Broward (8), Collier (2), Duval (2), Escambia, Hardee, Hillsborough (3), Lake, Martin, Miami-Dade (23), Monroe, Orange (3), Osceola, Palm Beach (4), Pinellas, Sarasota, Seminole (3), and Volusia (3).

**International Travel-Associated Dengue Fever Cases:** Forty-two cases of dengue with onset in 2015 have been reported in individuals with travel history to a dengue endemic country in the two weeks prior to onset. Countries of origin were: Bangladesh, Brazil (5), Colombia, Costa Rica, Cuba (12), Dominican Republic (3), Haiti (6), Honduras, India, Jamaica, Nicaragua, Mexico, Philippines (2), Puerto Rico, Thailand, and Venezuela (4). Counties reporting cases were: Clay (2), Collier, Hernando, Hillsborough (3), Broward (5), Lee, Miami-Dade (20), Monroe (2), Orange, Palm Beach (2), St. Johns, St. Lucie (2), and Seminole. Five cases were reported in non-Florida residents. In 2015, 17 of the 42 cases of dengue reported in Florida have been serotyped by PCR. Additional serotyping and strain typing are being conducted.

**International Travel-Associated Malaria Cases:** Thirty-seven cases of malaria with onset in 2015 have been reported. Countries of origin were: Angola, Cameroon (4), Dominican Republic (2), Eritrea, Gabon, Ghana (6), Guatemala (2), Haiti (4), India (4), Malawi, Niger, Nigeria (5), South Sudan, Sudan (2), Tanzania, and Uganda. Counties reporting cases were: Broward (7), Charlotte, Collier, Duval, Escambia, Hillsborough (2), Lee (2), Manatee, Monroe, Miami-Dade (11), Orange (2), Osceola, Pinellas, Palm Beach (3), Sarasota, and Volusia. Ten of the cases were reported in non-Florida residents.


Twenty-nine cases (78%) were diagnosed with *Plasmodium falciparum*. Seven cases were diagnosed with *Plasmodium vivax* (19%). One case (3%) was diagnosed with *Plasmodium malariae*.



### Veterinary WNV Disease in Florida, October 2014-2015




## Sentinel Chickens\*


Thirty-four sentinel chickens tested positive for antibodies to WNV this week in Hillsborough, Indian River, Manatee, Orange, Pasco, Pinellas, Polk, Putnam, Seminole, St. John, Sumter, Volusia, and Walton Counties. Two sentinel chickens tested positive for antibodies to EEEV this week in Alachua, and Nassau Counties.

## Dead Birds


The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, 10 reports representing 24 dead birds, including 3 jays, and 5 raptors were received from 5 counties.


In 2015, 299 reports representing a total of 867 dead birds (44 crows, 23 jay, 70 raptors, and 28 doves) were received from 46 of Florida's 67 counties. Please note that FWC collects reports of birds that have died from a variety of causes, not only arboviruses. Dead birds should be reported to [www.myfwc.com/bird/](http://www.myfwc.com/bird/).



\*\*Case tallies included in the weekly Florida arbovirus surveillance report include confirmed and probable cases for EEE, WNV infection, SLE, dengue, chikungunya, and malaria by date of onset. Suspect cases are not included. Activity is mapped by county of exposure rather than county of residence. Case definitions being used in Florida are consistent with national criteria provided by the Council of State and Territorial Epidemiologists (CSTE) and may be viewed at: <http://www.floridahealth.gov/diseases-and-conditions/disease-reporting-and-management/disease-reporting-and-surveillance/index.html>. Case tallies reported by CDC do not include suspect cases and cases are reported by patient state of residence rather than where the exposure occurred. Data is provided by county health departments, Department of Health Bureau of Public Health Laboratories, Department of Agriculture and Consumer Services, mosquito control agencies, Florida Fish and Wildlife Conservation Commission, medical providers and veterinarians. Equine cases are provided by the Department of Agriculture and Consumer Services.
