# **Executive Summary**

The Volunteer Health Care Provider Program (VHCPP) Annual Report is provided in accordance with section 766.1115(8), Florida Statutes, to summarize contributions achieved by the program. During Fiscal Year 2019–20, 212 community and faith-based clinics and organizations reported that a total of 13,340 licensed health care professionals and 8,591 Eligibility and Referral Specialists volunteered in the program.<sup>1</sup> The facilities reported providing 421,412 health care services to eligible individuals. In addition, the facilities reported that the value of health-related goods and services provided to Florida's citizens through the program totaled more than \$300 million. Since inception of the program in 1992, the Department of Health (Department) has documented more than \$4.4 billion in donated goods and services. Appendix A summarizes an aggregated number of clinics and organizations participating in the program by county. Appendix B summarizes reported volunteers and health care service counts and the value of contributions by clinic for each county.<sup>2</sup>

# Background

Created by the Access to Health Care Act in 1992, VHCPP improves access to health care for uninsured and underserved low-income residents by providing sovereign immunity to licensed health care professionals in exchange for providing free medical and dental services to these underserved populations. These professionals primarily provide volunteer services in community and faith-based medical clinics that serve uninsured and underserved individuals. The program trains non-licensed volunteers to conduct eligibility determination and refer individuals to providers for primary or specialty care.

To be eligible for medical and dental services through VHCPP, an individual must meet one of the following criteria:

- Not have health insurance that covers the treatment being sought, and have a gross family income less than 200% of the federal poverty level.
- Be Medicaid-eligible under Florida law and meet VHCPP's income eligibility criteria. (Medicaid clients are eligible to receive services through a free clinic when there is no Medicaid provider available in the area.)

The program is administered by a supervisor at the Central Office in Tallahassee and nine regional coordinators. To establish sovereign immunity, licensed health care professionals sign contracts with the Department. Regional coordinators prepare and manage the contracts with health care professionals They also ensure compliance with sovereign immunity requirements, conduct quality assurance at the clinics and organizations where clients receive services and train non-licensed professionals in eligibility determination and referral procedures. In addition to contracting with individuals, the Department contracts with 173 medical clinics and organizations where licensed health care professionals serve eligible clients. On behalf of the Department, county health department health officers sign the contracts with licensed health care professionals participating in the program. In FY 19–20, expenditures to administer the program totaled \$499,811.

This report also includes a list of claims filed under VHCPP compiled by the Florida Department of Financial Services, Division of Risk Management, as required by section 766.1115 (7), Florida Statutes (see Appendix D). No claims have been reported since March 2012.

# **Community and Faith-Based Clinics and Organizations**

Licensed health care professionals who participate in the program provide services at clinics and medical organizations that serve underinsured and underserved individuals. During FY 2019–20, health care professionals provided services in 212 community and faith-based clinics, organizations and mobile dental units in 45 counties.

As shown in Exhibit 1 on page 2, there are community and faith-based clinics and organizations participating in the program in 43 counties. Of these, 28 counties had between one and four participating clinics and organizations, nine counties had between five and eight participants and another six counties had nine or more participants.<sup>3</sup> In addition, 24 counties do not have clinics participating. To address these shortages, the program is collaborating with the Office of Rural Health to engage in outreach activities with the state Rural Health Networks and rural health clinics to promote the program.

Dental care is an important service provided through this program. Exhibit 2 on page 3 shows that 11 of the 212 clinics and organizations participating in the program were dental mobile units that provided dental services in 10 counties.

# **Licensed Health Care Professionals**

The Department contracts with licensed health care professionals to volunteer with the Volunteer Health Care Provider Program (VHCPP). During FY 2019–20, the 13,340 licensed health care professionals participating in the program provided 421,412 health care services to eligible individuals through the VHCPP. As shown in Exhibit 3, the number of licensed health care professionals providing volunteer services has decreased by 0.3% (41) since FY 2014–15. In addition, 8,591 Eligibility and Referral Specialists volunteered to screen clients for eligibility determination and refer patients for primary and specialty care during FY 19–20.

# Value of Goods and Services

The value of health care services is self-reported by the clinics and organizations that participate in the Volunteer Health Care Provider Program (VHCPP). During FY 2019–20, all clinics and organizations participating in the program reported fiscal information. They reported a total of 879,467 donated hours at a value of approximately \$117 million. In addition, 147 of the total 212 clinics and organizations reported receiving donations of money, supplies and equipment valued at approximately \$183 million. The combined value of services and donations totaled more than \$300 million. Exhibit 4 shows an increase of 10.8% compared to FY 2014–15, when the value totaled \$271 million. Since VHCPP's inception in 1992, participating clinics have reported more than \$4.4 billion in donated goods and services.
