

Florida Arbovirus Surveillance Week 33: August 10-16, 2025

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), and St. Louis encephalitis virus (SLEV), as well as exotic viruses such as dengue virus (DENV), chikungunya virus (CHIKV), Zika virus (ZIKV), and California encephalitis group viruses (CEV). Malaria, a parasitic mosquito-borne disease is also included. During the period of August 10-16, 2025, the following arboviral activity was recorded in Florida.

WNV activity: One human case of WNV infection was reported this week in Clay County. No horses with WNV infection were reported this week. One duck tested positive for antibodies to WNV in Duval County. Nine sentinel chickens tested positive for antibodies to WNV in Alachua, Bay, Charlotte, Orange, Pinellas, Volusia and Walton counties. In 2025, positive samples from one human, five asymptomatic blood donors, one horse, one duck, and 46 sentinel chickens have been reported from 20 counties.

SLEV activity: No human cases of SLEV infection were reported this week. No sentinel chickens tested positive for antibodies to SLEV this week. In 2025, positives samples from two sentinel chickens have been reported from two counties.

EEEV activity: No human cases of EEEV infection were reported this week. No horses with EEEV infection were reported This week. Two sentinel chickens tested positive for antibodies to EEEV in Alachua and Orange counties. In 2025, positive samples from seven horses, two emus, one emu flock, one goat, and 41 sentinel chickens have been reported from 21 counties.

International Travel-Associated Dengue: Thirteen cases of dengue were reported this week in persons that had international travel. In 2025, 154 travel-associated dengue cases have been reported.

Dengue Cases Acquired in Florida: Four cases of locally acquired dengue were reported this week. In 2025, positives samples from 14 humans and two mosquito pools have been reported from three counties.

International Travel-Associated Chikungunya Fever Cases: One case of chikungunya fever was reported this week in a person that had international travel. In 2025, five cases of travel-associated chikungunya fever have been reported.

Chikungunya Fever Cases Acquired in Florida: No cases of locally acquired chikungunya fever were reported this week. In 2025, no cases of locally acquired chikungunya fever have been reported.

International Travel-Associated Oropouche Fever cases: No cases of Oropouche fever were reported this week in persons that had international travel. In 2025, no cases of travel-associated Oropouche fever have been reported.

International Travel-Associated Zika Fever Cases: No cases of Zika fever were reported this week in persons that had international travel. In 2025, no travel-associated Zika fever cases have been reported.

Zika Fever Cases Acquired in Florida: No cases of locally acquired Zika fever were reported this week. In 2025, no cases of locally acquired Zika fever have been reported.

Advisories/Alerts: Clay, Hillsborough, Lafayette, and St. Johns counties are currently under a mosquito-borne illness advisory. Brevard, Escambia, and Miami-Dade counties are currently under a mosquito-borne illness alert. No other counties are currently under a mosquito-borne illness advisory or alert.

There are currently multiple travel health notices from the Centers for Disease Control and Prevention related to mosquito-borne diseases.

2025 Human Case Summary

West Nile Virus Illness Acquired in Florida: In 2025, one human case of WNV illness acquired in Florida has been reported in Clay County (July). Five asymptomatic blood donors have been reported in Escambia (June, July), Miami-Dade (July), and St. Johns (June) counties.

2025 International Travel-Associated Chikungunya Cases: Five cases with onset in 2025 have been reported in individuals with travel history to a chikungunya-endemic area in the two weeks prior to onset. Counties reporting cases were: Broward (2), Lake, Miami-Dade, and Seminole. Countries of origin were: Bolivia, Brazil, India, Indonesia, and Sri Lanka.

2025 International Travel-Associated Dengue Cases: One hundred fifty-four cases with onset in 2025 have been reported in individuals with travel history to a dengue-endemic area in the two weeks prior to onset. Counties reporting cases were: Bay, Brevard (2), Broward (11), Clay, Collier (3), Duval (3), Escambia, Hillsborough (8), Lake (4), Lee (6), Manatee (2), Marion, Miami-Dade (85), Okeechobee (3), Orange (7), Osceola (2), Palm Beach (5), Pasco, Pinellas (3), Polk, St. Johns, St. Lucie (2), and Volusia. Nine cases were reported in non-Florida residents. In 2025, 130 cases of dengue reported in Florida have been serotyped by PCR. Please see the table below for a breakdown of cases by country of origin and serotype.

2025 Dengue Cases Acquired in Florida: In 2025, 14 cases of locally acquired dengue have been reported in Brevard (11), Hillsborough, and Miami-Dade (2) counties with onset in February, May, June, July, and August. 
2025 International Travel-Associated Malaria Cases: Thirty-four cases with onset in 2025 have been reported in individuals with travel history to a malaria-endemic area. Counties reporting cases were: Alachua, Brevard, Broward (5), Collier, Duval, Hillsborough, Lake, Leon, Manatee, Marion (2), Miami-Dade (4), Nassau (2), Orange (4), Palm Beach (4), Polk (2), St. Lucie (2), and Volusia. 

No veterinary cases were reported this week.






Sentinel Chickens



Dead Birds


The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, 14 reports representing a total of 34 dead birds, including six raptor and five doves, were received from 9 counties.


In 2025, 1072 reports representing a total of 2262 dead birds (89 crows, 42 jays, 244 raptors, 202 doves) were received from 58 of Florida's 67 counties.

Case tallies included in the weekly Florida arbovirus surveillance report include confirmed and probable cases for EEE, WNV infection, SLE, dengue, chikungunya, and malaria by date of onset. Suspect cases are not included. Activity is mapped by county of exposure rather than county of residence. Case definitions being used in Florida are consistent with national criteria provided by the Council of State and Territorial Epidemiologists (CSTE) and may be viewed at: www.floridahealth.gov/diseases-and-conditions/disease-reporting-and-management/disease-reporting-and-surveillance/index.html. Case tallies reported by CDC do not include suspect cases and cases are reported by patient state of residence rather than where the exposure occurred. Data is provided by county health departments, Department of Health Bureau of Public Health Laboratories, Department of Agriculture and Consumer Services, mosquito control agencies, Florida Fish and Wildlife Conservation Commission, medical providers and veterinarians. Equine cases are provided by the Department of Agriculture and Consumer Services.
