What is an ADA Coordinator? An ADA Coordinator is the person who can help you get an interpreter, CART, or other services required by law. ADA Coordinators cannot help you with your specific legal problem, their role is only to help you obtain access.

Florida Registry of Interpreters for the Deaf FRID is the state of Florida's chapter of the national Registry of Interpreters for the Deaf. The main goal of FRID is to create opportunities for interpreters to learn more about interpreting and transliterating, and to ensure that interpreters follow rules appropriate for their job. Florida Department of Corrections (DOC) The goal of the Department of Corrections is to keep citizens and Department employees safe, and to take care of and supervise all criminals in Florida prisons. (Prisons are managed by the DOC and are state facilities. A jail is a local facility run by a police department or sheriff's office.) The Department also helps criminals find jobs and a place to live when they finish their time in prison. The Department has sixty prisons, forty-one work/forestry camps, one treatment center, thirty work release centers and five road prisons. The Department also manages probation services. Florida Department of Children and Families (DCF) The goal of DCF is to support families. Some of the programs DCF offers try to help people recover from domestic violence, drug addiction, and homelessness. Florida State Courts System The goal of the State Courts System is to protect rights and freedoms, support and explain the law, and bring peaceful solution to conflicts. The State Courts System is made up of many different courts: The supreme court, five district courts of appeal, twenty circuit courts, and sixty-seven county courts. Florida Legal Aid/Legal Services If you have legal problems but cannot afford to pay a lawyer, you may be able to get legal help from a local legal aid office. These offices give free or low cost legal help to people with low income. Information can be found online through their websites. County Clerks of Court There is a clerk of court for each county. They are elected government employees who collect court filing fees, fines, and costs; process case files; and serve as the manager of official court records. The clerks also help the court with jury duty. By law, county clerks of court are responsible to give information and explain the legal process to people who decide to go to court without a lawyer. Florida Attorney General The Attorney General is the chief law enforcement officer for the State of Florida. Among other responsibilities, the Attorney General is responsible for protecting Florida residents from various types of fraud. The Office of Civil Rights, which investigates and punishes anyone who violates Florida civil rights, is located in the Attorney General's Office. Florida State Attorneys There are twenty state attorneys, one for each judicial circuit. They are government employees elected by Floridians. Florida Public Defenders There are twenty public defenders, one for each judicial circuit. They are government employees elected by Floridians. The public defender represents poor people in some criminal situations, as well as Baker Act and other cases. <u>http://flpda.org/</u>

Florida Department of Law Enforcement *The goal of the Florida Department of Law Enforcement is to keep Florida citizens and visitors safe. This department works with local, state, and federal criminal justice agencies to prevent, investigate, and solve crimes.* <u>http://www.fdle.state.fl.us/</u>

Florida Sheriffs *Sixty-six of Florida's sixty-seven counties have Sheriffs who are elected by the people in each county. Miami-Dade County has a different process and the Sheriff is called the Director of the Miami-Dade Police Department. Florida Department of Juvenile Justice *This department tries to prevent crime and to help young people that are involved in crime through different programs and by supporting families.* http://www.djj.state.fl.us/

Florida Department of Highway Safety & Motor Vehicles The purpose of DHSMV is to make highways safe through service, education, and enforcement. DHSMV provides driver licenses; automobile, mobile home, and boat registration and titles; help from the Florida Highway Patrol if a person is involved in a crash or a person's vehicle breaks down on the highways. http://www.flhsmv.gov/

Florida Department of Revenue, Child Support Enforcement *The Department of Revenue manages the Child Support Enforcement Program. The Department provides child support services in most Florida counties. The Florida Bar The Florida Bar has more than 86,000 members. It is the professional group that manages lawyers.
