

Florida Arbovirus Surveillance Week 31: July 29-August 4, 2018

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), and St. Louis encephalitis virus (SLEV), as well as exotic viruses such as dengue virus (DENV), chikungunya virus (CHIKV) and California encephalitis group viruses (CEV). Malaria, a parasitic mosquito-borne disease is also included. During the period of July 29-August 4, 2018, the following arboviral activity was recorded in Florida.

WNV activity: No human cases of WNV infection were reported this week. No horses with WNV infection were reported this week. Two mosquito pools tested positive for WNV this week in Sarasota County. Seven sentinel chickens tested positive for antibodies to WNV this week in Alachua, Sarasota, Sumter, and Walton counties. In 2018, positive samples from one human, one blood donor, one crow, thirteen mosquito pools, and fifty-seven sentinel chickens have been reported from twelve counties.

SLEV activity: No human cases of SLEV infection were reported this week. No sentinel chickens tested positive for antibodies to SLEV this week. In 2018, there have been no positive samples reported.

EEEV activity: One human case of EEEV infection was reported this week in Volusia County. Three horses with EEEV infection were reported this week in Marion County. Three sentinel chickens tested positive for antibodies to EEEV this week in Citrus and St. Johns counties. In 2018, positive samples from two humans, forty-seven horses, one mule, one donkey, one owl, one emu, five emu flocks, two mosquito pools, and one hundred nineteen sentinel chickens have been reported from thirty-one counties.

International Travel-Associated Dengue Fever Cases: No cases of dengue fever were reported this week in persons that had international travel. In 2018, eleven travel-associated cases have been reported.

Dengue Fever Cases Acquired in Florida: No cases of locally acquired dengue fever were reported this week. In 2018, no cases of locally acquired dengue fever have been reported.

International Travel-Associated Chikungunya Fever Cases: No cases of chikungunya fever were reported this week in persons that had international travel. In 2018, one travel-associated case has been reported.

Chikungunya Fever Cases Acquired in Florida: No cases of locally acquired chikungunya fever were reported this week. In 2018, no cases of locally acquired chikungunya fever have been reported.

International Travel-Associated Zika Fever Cases: One case of Zika fever was reported this week in a person that had international travel. In 2018, sixty cases have been reported.

Zika Fever Cases Acquired in Florida: No cases of locally acquired Zika fever were reported this week. In 2018, no cases of locally acquired Zika fever have been reported.

Advisories/Alerts: Lake, Marion, Nassau, Okeechobee, Orange, Sarasota, St. Johns, Suwannee, Taylor, Volusia, and Walton counties are currently under a mosquito-borne illness advisory. Bay and Levy counties are currently under a mosquito-borne illness alert. No other counties are currently under mosquito-borne illness advisory or alert.

There is a Level 2 (Alert) Travel Health Notice from the CDC for multiple countries in Africa, the Caribbean, Central and South America, Southeast Asia, and Pacific Islands related to Zika virus transmission and an association with poor pregnancy outcomes. Pregnant women should consider postponing travel to these areas. There is also a Level 2 Travel Health Notice for Brazil and a Level 1 Travel Health Notice in Nigeria related to the transmission of yellow fever virus. 2018 Human Case Summary*

West Nile Virus Illnesses Acquired in Florida: One human case (July) and one asymptomatic positive blood donor (June) have been reported in 2018 from Bay County.

EEEV Infection Acquired in Florida: Two human cases of Eastern equine encephalitis acquired in Florida have been reported in 2018 in Taylor (May) and Volusia (July) counties.

International Travel-Associated Chikungunya Fever Cases: One case of chikungunya fever with onset in 2018 has been reported in an individual with travel history to a chikungunya endemic country in the two weeks prior to onset. Country of origin was: Brazil. Country reporting the case was: Orange.

International Travel-Associated Dengue Fever Cases: Eleven cases of dengue fever with onset in 2018 have been reported in individuals with travel history to a dengue endemic country in the two weeks prior to onset. Countries of origin were: Cuba (6), Haiti (4), and Venezuela. Counties reporting cases were: Broward (3), Hillsborough, Lake, Lee, Miami-Dade (3), Orange, and Palm Beach. In 2018, eleven cases of dengue reported in Florida have been serotyped by PCR. Additional serotyping and strain typing are being conducted.

International Travel-Associated Zika Fever Cases: In 2018, sixty cases of Zika fever have been reported in individuals with travel history to a country or area experiencing Zika virus activity. Countries of origin were: Brazil (3), Brazil/Haiti, Brazil/Mexico, Cuba (14), Cuba/Mexico, Dominica, Dominican Republic, Guatemala (2), Guatemala/Mexico, Haiti (20), Honduras (4), Jamaica, Puerto Rico, and Venezuela (9). Counties reporting cases were: Broward (3), Collier (21), Hernando, Hillsborough, Lee, Miami-Dade (15), Orange (9), Osceola (3), Palm Beach (4), Pinellas, and Walton. Eight cases were reported in non-Florida residents. Florida is monitoring a total of forty-four pregnant women in 2018.


International Travel-Associated Malaria Cases: Thirty-four cases of malaria with onset in 2018 have been reported. Countries of origin were: Afghanistan (2), Angola, Brazil, Cameroon, Ethiopia, Ghana (3), Haiti (2), India (4), Kenya, Liberia, Nicaragua (3), Nigeria (10), Sierra Leone, and Togo (3). Counties reporting cases were: Broward (10), Duval (3), Hillsborough (4), Miami-Dade (9), Okaloosa, Orange, Palm Beach, Pasco, Polk, Sarasota, and Seminole (2). Five cases were reported in non-Florida residents.


Twenty-two cases (65%) were diagnosed with *Plasmodium falciparum*. Eleven cases (32%) were diagnosed with *Plasmodium vivax*. One case (3%) was diagnosed with *Plasmodium ovale*.

Veterinary Cases*

Three horses with EEEV infection were reported this week in Marion County.






Sentinel Chickens*




Dead Birds


The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, ten reports representing a total of 48 dead birds, including two raptors and eight doves, were received from eight counties.

In 2018, 298 reports representing a total of 785 dead birds (17 crows, 20 jays, 62 raptors, 25 doves) were received from 42 of Florida's 67 counties. Please note that FWC collects reports of birds that have died from a variety of causes, not only arboviruses. Dead birds should be reported to www.myfwc.com/bird/.

Case tallies included in the weekly Florida arbovirus surveillance report include confirmed and probable cases for EEE, WNV infection, SLE, dengue, chikungunya, and malaria by date of onset. Suspect cases are not included. Activity is mapped by county of exposure rather than county of residence. Case definitions being used in Florida are consistent with national criteria provided by the Council of State and Territorial Epidemiologists (CSTE) and may be viewed at: http://www.floridahealth.gov/diseases-and-conditions/disease-reporting-and-management/disease-reporting-and-surveillance/index.html. Case tallies reported by CDC do not include suspect cases and cases are reported by patient state of residence rather than where the exposure occurred. Data is provided by county health departments, Department of Health Bureau of Public Health Laboratories, Department of Agriculture and Consumer Services, mosquito control agencies, Florida Fish and Wildlife Conservation Commission, medical providers and veterinarians. Equine cases are provided by the Department of Agriculture and Consumer Services.
