

Florida Arbovirus Surveillance Week 43: October 21-27, 2018

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), and St. Louis encephalitis virus (SLEV), as well as exotic viruses such as dengue virus (DENV), chikungunya virus (CHIKV) and California encephalitis group viruses (CEV). Malaria, a parasitic mosquito-borne disease is also included. During the period of October 21-27, 2018, the following arboviral activity was recorded in Florida.

WNV activity: One asymptomatic blood donor was identified as WNV-positive this week in Gadsden County. No horses with WNV infection were reported this week. One red-shouldered hawk with WNV infection was reported this week in Suwannee County. One mosquito pool tested positive for WNV this week in St. Johns County. Seventy-eight sentinel chickens tested positive for antibodies to WNV this week in Alachua, Brevard, Charlotte, Citrus, Duval, Hillsborough, Indian River, Lee, Leon, Manatee, Martin, Nassau, Orange, Palm Beach, Polk, Putnam, Sarasota, St. Johns, St. Lucie, and Sumter counties. In 2018, positive samples from 17 humans, three blood donors, five horses, one zebra, one red-shouldered hawk, four crows, 28 mosquito pools, and 544 sentinel chickens have been reported from 33 counties.

SLEV activity: No human cases of SLEV infection were reported this week. No sentinel chickens tested positive for antibodies to SLEV this week. In 2018, a positive sample from one sentinel chicken has been reported from one county.

EEEV activity: No human cases of EEEV infection were reported this week. No horses with EEEV infection were reported this week. No sentinel chicken tested positive for antibodies to EEEV this week. In 2018, positive samples from three humans, 51 horses, one mule, one donkey, one owl, one emu, five emu flocks, two mosquito pools, and 144 sentinel chickens have been reported from 31 counties.

International Travel-Associated Dengue Fever Cases: Four cases of dengue fever were reported this week in persons that had international travel. In 2018, 36 travel-associated cases have been reported.

Dengue Fever Cases Acquired in Florida: No cases of locally acquired dengue fever were reported this week. In 2018, no cases of locally acquired dengue fever have been reported.

International Travel-Associated Chikungunya Fever Cases: No cases of chikungunya fever were reported this week in persons that had international travel. In 2018, three travel-associated cases have been reported.

Chikungunya Fever Cases Acquired in Florida: No cases of locally acquired chikungunya fever were reported this week. In 2018, no cases of locally acquired chikungunya fever have been reported.

International Travel-Associated Zika Fever Cases: Three cases of Zika fever were reported this week in persons that had international travel. In 2018, 85 cases have been reported.

Zika Fever Cases Acquired in Florida: No cases of locally acquired Zika fever were reported this week. In 2018, no cases of locally acquired Zika fever have been reported.

Advisories/Alerts: Charlotte, Columbia, Gadsden, Lake, Leon, Manatee, Marion, Okeechobee, Orange, Putnam, Sarasota, St. Johns, Suwannee, Taylor, Volusia, and Walton counties are currently under a mosquito-borne illness advisory. Bay, Duval, Levy, and Nassau counties are currently under a mosquito-borne illness alert. No other counties are currently under mosquito-borne illness advisory or alert.

There is a Level 2 (Alert) Travel Health Notice from the CDC for multiple countries in Africa, the Caribbean, Central and South America, Southeast Asia, and Pacific Islands related to Zika virus transmission and an association with poor pregnancy outcomes. Pregnant women should consider postponing travel to these areas. There is also a Level 2 Travel Health Notice for Brazil and a Level 1 Travel Health Notice in Nigeria related to the transmission of yellow fever virus. 2018 Human Case Summary*

West Nile Virus Illnesses Acquired in Florida: A total of 17 human cases of WNV illness acquired in Florida have been reported in 2018; four in Bay (July, September), one in Charlotte (August), seven in Duval (August, September), one in Manatee (July), two in Nassau (August), one in Putnam (October), and one in Suwannee (August) counties. Three asymptomatic positive blood donors were reported from Bay (June), Duval (August), and Gadsden (October) counties.

EEEV Infection Acquired in Florida: Three human cases of Eastern equine encephalitis acquired in Florida have been reported in 2018 in Columbia (July), Taylor (May), and Volusia (July) counties.

International Travel-Associated Chikungunya Fever Cases: Three cases of chikungunya fever with onset in 2018 have been reported in individuals with travel history to a chikungunya endemic country in the two weeks prior to onset. Country of origin was: Brazil (2) and Kenya. Counties reporting the case were: Orange, Miami-Dade, and Seminole.

International Travel-Associated Dengue Fever Cases: Thirty-six cases of dengue fever with onset in 2018 have been reported in individuals with travel history to a dengue endemic country in the two weeks prior to onset. Countries of origin were: Bangladesh, Cuba (23), Haiti (6), Jamaica, Nigeria, Philippines, Thailand, and Venezuela (2). Counties reporting cases were: Broward (7), Duval, Hillsborough (4), Lake, Lee (3), Miami-Dade (15), Monroe, Orange, and Palm Beach (3). Two cases met the criteria for severe dengue (dengue shock syndrome [DSS] or dengue hemorrhagic fever [DHF]). Those at greater risk for DSS and DHF include persons with previous dengue infection, pregnant women, infants, the elderly, and those with co-morbidities. However, severe illness can also occur in those without any of these risk factors. In 2018, 32 cases of dengue reported in Florida have been serotyped by PCR. Additional serotyping and strain typing are being conducted.

International Travel-Associated Zika Fever Cases: In 2018, 85 cases of Zika fever have been reported in individuals with travel history to a country or area experiencing Zika virus activity. Countries of origin were: Brazil (3), Brazil/Haiti, Brazil/Mexico, Colombia, Cuba (20), Cuba/Mexico, Dominica, Dominican Republic, Guatemala (2), Guatemala/Mexico, Haiti (30), Honduras (7), Jamaica (2), Puerto Rico, Turks and Caicos, and Venezuela (12). Counties reporting cases were: Broward (6), Collier (33), Hernando, Hillsborough, Lee, Miami-Dade (22), Orange (11), Osceola (3), Palm Beach (5), Pinellas, and Walton. Fifteen cases were reported in non-Florida residents. Florida is monitoring a total of 65 pregnant women in 2018.

In addition, two individuals tested in 2018 reported travel in 2016 to both Miami-Dade County and countries with areas of active Zika virus transmission. Exposure location in 2016 could not definitively be determined.


International Travel-Associated Malaria Cases: Fifty-four cases of malaria with onset in 2018 have been reported. Countries of origin were: Afghanistan (2), Angola, Benin, Brazil, Cameroon, Dominican Republic, Ethiopia, Gabon, Ghana (4), Haiti (2), India (5), Kenya, Liberia (2), Mali/Togo, Nicaragua (4), Nigeria (18), Peru, Sierra Leone, South Africa, Tanzania, Togo (3), and Venezuela. Counties reporting cases were: Broward (13), Clay, Duval (4), Escambia, Gadsden, Hillsborough (5), Miami-Dade (14), Okaloosa, Orange (3), Osceola, Palm Beach (3), Pasco, Pinellas, Polk, Sarasota, and Seminole (3). Nine cases were reported in non-Florida residents.

Thirty-four cases (63%) were diagnosed with *Plasmodium falciparum*. Fifteen cases (28%) were diagnosed with *Plasmodium vivax*. Three cases (5%) were diagnosed with *Plasmodium ovale*. Two cases (4%) were diagnosed with *Plasmodium malariae*.


Veterinary Cases*

Veterinary WNV Disease in Florida, October 2017-2018




Sentinel Chickens*



Dead Birds


The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, nine reports representing a total of 28 dead birds, including seven crows and one raptor, were received from eight counties.


In 2018, 412 reports representing a total of 1132 dead birds (34 crows, 24 jays, 75 raptors, 37 doves) were received from 46 of Florida's 67 counties. Please note that FWC collects reports of birds that have died from a variety of causes, not only arboviruses. Dead birds should be reported to www.myfwc.com/bird/.





Case tallies included in the weekly Florida arbovirus surveillance report include confirmed and probable cases for EEE, WNV infection, SLE, dengue, chikungunya, and malaria by date of onset. Suspect cases are not included. Activity is mapped by county of exposure rather than county of residence. Case definitions being used in Florida are consistent with national criteria provided by the Council of State and Territorial Epidemiologists (CSTE) and may be viewed at: http://www.floridahealth.gov/diseases-and-conditions/disease-reporting-and-management/disease-reporting-and-surveillance/index.html. Case tallies reported by CDC do not include suspect cases and cases are reported by patient state of residence rather than where the exposure occurred. Data is provided by county health departments, Department of Health Bureau of Public Health Laboratories, Department of Agriculture and Consumer Services, mosquito control agencies, Florida Fish and Wildlife Conservation Commission, medical providers and veterinarians. Equine cases are provided by the Department of Agriculture and Consumer Services.
