

# Florida Arbovirus Surveillance Week 37: September 8-14, 2019

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), and St. Louis encephalitis virus (SLEV), as well as exotic viruses such as dengue virus (DENV), chikungunya virus (CHIKV), Zika virus (ZIKV), and California encephalitis group viruses (CEV). Malaria, a parasitic mosquito-borne disease is also included. During the period of September 8-14, 2019, the following arboviral activity was recorded in Florida.

**WNV** activity: No human cases of WNV infection were reported this week. One horse with WNV infection was reported this week in Brevard County. Twelve sentinel chickens tested positive for antibodies to WNV this week in Citrus, Hillsborough, Leon, Pasco, Polk, and Walton counties. In 2019, positive samples from one human, one blood donor, two horses, one eagle, and 233 sentinel chickens have been reported from 27 counties.

**SLEV activity:** No human cases of SLEV infection were reported this week. No sentinel chickens tested positive for antibodies to SLEV this week. In 2019, no positive samples have been reported.

**EEEV activity:** No human cases of EEEV infection were reported this week. No horses with EEEV infection were reported this week. Two sentinel chickens tested positive for antibodies to EEEV this week in Leon and Sumter counties. In 2019, positive samples from 26 horses, one emu, one eagle, and 100 sentinel chickens have been reported from 30 counties.

**International Travel-Associated Dengue Fever Cases:** Thirty-two cases of dengue fever were reported this week in persons that had international travel. In 2019, 186 travel-associated cases have been reported.

**Dengue Fever Cases Acquired in Florida:** Two cases of locally acquired dengue fever were reported this week in Broward and Miami-Dade counties. In 2019, five cases of locally acquired dengue fever have been reported.

**International Travel-Associated Chikungunya Fever Cases:** No cases of chikungunya fever were reported this week in persons that had international travel. In 2019, five travel-associated cases have been reported.

Chikungunya Fever Cases Acquired in Florida: No cases of locally acquired chikungunya fever were reported this week. In 2019, no cases of locally acquired chikungunya fever have been reported.

**International Travel-Associated Zika Fever Cases:** No cases of Zika fever were reported this week in persons that had international travel. In 2019, 33 travel-associated cases have been reported.

**Zika Fever Cases Acquired in Florida:** No cases of locally acquired Zika fever were reported this week. In 2019, no cases of locally acquired Zika fever have been reported.

**Advisories/Alerts**: Bay, Broward, Calhoun, Citrus, DeSoto, Duval, Holmes, Indian River, Orange, Polk, Suwannee, and Walton counties are currently under a mosquito-borne illness advisory. Miami-Dade County is currently under a mosquito-borne illness alert. No other counties are currently under mosquito-borne illness advisory or alert.

There are no areas of ongoing, active Zika transmission in Florida. ## 2019 Human Case Summary\*

West Nile Virus Illnesses Acquired in Florida: One human case of WNV illness acquired in Florida has been reported in 2019 in Duval County (July). One asymptomatic positive blood donor has been reported in 2019 from Bay County (August).

International Travel-Associated Chikungunya Fever Cases: Five cases of chikungunya fever with onset in 2019 have been reported in individuals with travel history to a chikungunya endemic country in the two weeks prior to onset. Countries of origin were: Brazil, Haiti, India, and Thailand (2). Counties reporting cases were: Alachua, Manatee, Marion, Orange, and Palm Beach. Two cases were reported in non-Florida residents.

International Travel-Associated Dengue Fever Cases: One hundred eighty-six cases of dengue fever with onset in 2019 have been reported in individuals with travel history to a dengue endemic country in the two weeks prior to onset. Countries of origin were: Belize (2), Belize/Cuba/Honduras/Mexico, Brazil (3), Cambodia/Thailand/Vietnam, Central America/Mexico, Colombia, Colombia/Venezuela, Costa Rica (2), Cuba (116), Dominican Republic (7), El Salvador, Guatemala (3), Haiti (7), Honduras (12), India (4), India/Malaysia, Jamaica (9), Malaysia/Singapore, Mexico (2), Nicaragua (5), Philippines, Thailand (2), and Venezuela (3). Counties reporting cases were: Alachua (2), Brevard, Broward (17), Charlotte, Citrus, Duval (2), Hillsborough (12), Lake, Lee (6), Manatee, Miami-Dade (106), Orange (9), Osceola, Palm Beach (13), Pasco (3), Pinellas (2), Polk, Putnam, Sarasota (2), Seminole (2), and St. Lucie (2). Ten cases were reported in non-Florida residents. Four cases met the criteria for severe dengue (dengue shock syndrome [DSS] or dengue hemorrhagic fever [DHF]). Those at greater risk for DSS and DHF include persons with previous dengue infection, pregnant women, infants, the elderly, and those with co-morbidities. However, severe illness can also occur in those without any of these risk factors. In 2019, 142\* cases of dengue reported in Florida have been serotyped by PCR. Additional serotyping and strain typing are being conducted.

**Dengue Fever Cases Acquired in Florida:** In 2019, five cases of locally acquired dengue fever have been reported in Broward and Miami-Dade (4) counties, with onsets in March, July (2), and August (2).

International Travel-Associated Zika Fever Cases: In 2019, 33 cases of Zika fever have been reported in individuals with travel history to a country or area experiencing Zika virus activity. Countries of origin were: Brazil, Colombia (1), Cuba (6), Guatemala (5), Haiti (9), Honduras (4), Jamaica, Nicaragua, Philippines, Puerto Rico, and Venezuela (2). Counties reporting cases were: Broward (5), Collier (2), Duval, Hillsborough (2), Indian River, Lee, Miami-Dade (15), Orange (4), Palm Beach, and Sarasota. Three cases were reported in non-Florida residents. Florida is monitoring a total of 20 pregnant women in 2019.

International Travel-Associated Malaria Cases: Forty-nine cases of malaria with onset in 2019 have been reported. Countries of origin were: Afghanistan, Angola (2), Congo, Democratic Republic of the Congo (4),

Ghana (7), Guyana, India, Ivory Coast (5), Kenya (3), Liberia (2), Nigeria (14), Papua New Guinea, Sudan, Togo, Uganda (2), and Zambia (3). Counties reporting cases were: Brevard (2), Broward (4), Duval (8), Hillsborough (4), Lake (2), Miami-Dade (7), Okaloosa, Orange (6), Pasco (4), Pinellas (5), Polk (2), Seminole (3), and Volusia. Twelve cases were reported in non-Florida residents.


Forty-four cases (90%) were diagnosed with *Plasmodium falciparum*. Four cases (8%) was diagnosed with *Plasmodium vivax*. One case (2%) was diagnosed with *Plasmodium ovale*.



## Veterinary EEEV Disease in Florida, September 2018-2019




## **Sentinel Chickens\***



#### **Dead Birds**


The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, five reports representing a total of 13 dead birds, including one raptor, were received from five counties.


In 2019, 286 reports representing a total of 547 dead birds (14 crows, 11 jays, 75 raptors, and 34 doves) were received from 42 of Florida's 67 counties. Please note that FWC collects reports of birds that have died from a variety of causes, not only arboviruses. Case tallies included in the weekly Florida arbovirus surveillance report include confirmed and probable cases for EEE, WNV infection, SLE, dengue, chikungunya, and malaria by date of onset. Suspect cases are not included. Activity is mapped by county of exposure rather than county of residence. Case tallies reported by CDC do not include suspect cases and cases are reported by patient state of residence rather than where the exposure occurred. Data is provided by county health departments, Department of Health Bureau of Public Health Laboratories, Department of Agriculture and Consumer Services, mosquito control agencies, Florida Fish and Wildlife Conservation Commission, medical providers and veterinarians. Equine cases are provided by the Department of Agriculture and Consumer Services.
