

## Florida Arbovirus Surveillance Week 18: May 1-7, 2016

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), and St. Louis encephalitis virus (SLEV), as well as exotic viruses such as dengue virus (DENV), chikungunya virus (CHIKV) and California encephalitis group viruses (CEV). Malaria, a non-viral mosquito-borne disease is also included. During the period of May 1-7, 2016 the following arboviral activity was recorded in Florida.

**WNV activity:** No human cases of WNV infection were reported this week. No horses with WNV infection were reported this week. Three sentinel chickens tested positive for antibodies to WNV this week in Hillsborough, Sarasota, and Seminole Counties. In 2016, positive samples from 33 sentinel chickens have been received from seven counties.

**SLEV activity:** No human cases of SLEV infection were reported this week. No sentinel chickens tested positive for antibodies to SLEV this week. In 2016, there have been no positive samples reported.

**EEEV activity:** No human cases of EEEV infection were reported this week. No horses with EEEV infection were reported this week. Two sentinel chickens tested positive for antibodies to EEEV this week in Orange and Sarasota Counties. In 2016, positive samples from 19 sentinel chickens and one horse have been received from six counties.

**International Travel-Associated Dengue Fever Cases:** One case of dengue fever was reported this week in a person that had international travel. In 2016, 25 travel-associated cases have been reported.

**Dengue Fever Cases Acquired in Florida:** No cases of locally acquired dengue fever were reported this week. In 2016, no cases of locally acquired dengue fever have been reported.

**International Travel-Associated Chikungunya Fever Cases:** No cases of chikungunya fever were reported this week in persons that had international travel. In 2016, four travel-associated cases have been reported.

Chikungunya Fever Cases Acquired in Florida: No cases of locally acquired chikungunya fever were reported this week. In 2016, no cases of locally acquired chikungunya fever have been reported.

**International Travel-Associated Zika Fever Cases:** Eight cases of Zika fever were reported this week in persons that had international travel. In 2016, 107 travel-associated cases have been reported. No cases of locally acquired Zika fever have been reported.

Advisories/Alerts: Eighteen counties are currently under a declared public health emergency due to the identification of travel-associated Zika infections: Alachua, Brevard, Broward, Clay, Collier, Hillsborough, Lee, Martin, Miami-Dade, Orange, Osceola, Palm Beach, Pasco, Pinellas, Polk, St. Johns, Santa Rosa, and Seminole Counties. There is a Level 2 (Alert) Travel Health Notice from the CDC for multiple countries in the Caribbean, Central and South America, Mexico, Cape Verde, and Pacific Islands related to Zika virus transmission and a possible association with poor pregnancy outcomes. Pregnant women should consider postponing travel to these areas. There is a Level 1 (Watch) Travel Health Notice from the CDC for multiple countries in the Caribbean, Central and South America, and Mexico, related to the transmission of chikungunya virus. ## 2016 Human Case Summary\*

International Travel-Associated Chikungunya Fever Cases: Four cases of chikungunya with onset in 2016 have been reported in individuals with travel history to a chikungunya endemic country in the two weeks prior to onset. Countries of origin were Bahamas/Mexico, Bolivia (2), and Brazil. Counties reporting cases were Broward, Duval, Hillsborough, and Pinellas.

International Travel-Associated Dengue Fever Cases: Twenty-five cases of dengue with onset in 2016 have been reported in individuals with travel history to a dengue endemic country in the two weeks prior to onset. Countries of origin were: Brazil (3), Colombia, Costa Rica (2), Cuba (7), Dominican Republic, El Salvador, St. Barthelemy, Haiti (3), Indonesia, Jamaica, Mexico, and Venezuela (3). Counties reporting cases were: Alachua (2), Broward (5), Clay, Hillsborough (2), Miami-Dade (7), Orange (3), Pinellas, Palm Beach, Sarasota, and Seminole (2). Two cases were reported in non-Florida residents. In 2016, 19 of the 25 cases of dengue reported in Florida have been serotyped by PCR. Additional serotyping and strain typing are being conducted.


International Travel-Associated Zika Fever Cases: One hundred seven cases of Zika fever have been reported in individuals with travel history to a country or area experiencing Zika virus activity. Countries of origin were: Belize (2), Bolivia, Brazil (5), Brazil/Bolivia/Peru, Colombia (27), Costa Rica, Curacao/Guyana, Dominican Republic (13), El Salvador (4), Guyana (4), Haiti (15), Honduras (6), Honduras/Guatemala, Martinique, Nicaragua (5), Puerto Rico (5), Suriname, and Venezuela (13). Counties reporting cases were: Alachua (4), Brevard (2), Broward (15), Clay, Collier, Hillsborough (3), Lee (4), Martin, Miami-Dade (42), Orange (7), Osceola (4), Palm Beach (7), Pasco, Pinellas, Polk (3), St. Johns, Santa Rosa, and Seminole (2). Four cases were reported in non-Florida residents. One Polk County case was acquired through sexual transmission. Seven of the 107 cases involve pregnant women whose counties of residence are not included in the individual county totals to protect privacy.


**International Travel-Associated Malaria Cases:** Eight cases of malaria with onset in 2016 have been reported. Countries of origin were: Angola, Cameroon (2), Kenya, Sierra Leone, Sudan, Uganda, and Venezuela. Counties reporting cases were: Broward (2), Flagler, Hillsborough, Orange (2), Palm Beach, and Sarasota Counties. One case was reported in a non-Florida resident.

Six cases (75%) were diagnosed with *Plasmodium falciparum*. One case (13%) was diagnosed with *Plasmodium vivax*. One case (13%) was diagnosed with *Plasmodium malariae*.

# **Veterinary Cases\***

No horses with EEEV or WNV infection were reported this week.


### Sentinel Chickens\*


Three sentinel chickens tested positive for antibodies to WNV this week in Hillsborough, Sarasota, and Seminole Counties. Two sentinel chickens tested positive for antibodies to EEEV this week in Orange and Sarasota Counties.

## **Dead Birds**


The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, 12 reports representing a total of 30 dead birds, including 1 raptor were received from 7 counties.


In 2016, 224 reports representing a total of 726 dead birds (51 crows, 1 jay, 41 raptors, and 6 doves) were received from 46 of Florida's 67 counties. Please note that FWC collects reports of birds that have died from a variety of causes, not only arboviruses. Dead birds should be reported to www.myfwc.com/bird/.

\*\*Case tallies included in the weekly Florida arbovirus surveillance report include confirmed and probable cases for EEE, WNV infection, SLE, dengue, chikungunya, and malaria by date of onset. Suspect cases are not included. Activity is mapped by county of exposure rather than county of residence. Case definitions being used in Florida are consistent with national criteria provided by the Council of State and Territorial Epidemiologists (CSTE) and may be viewed at: <a href="http://www.floridahealth.gov/diseases-and-conditions/disease-reporting-and-management/disease-reporting-and-surveillance/index.html">http://www.floridahealth.gov/diseases-and-conditions/disease-reporting-and-management/disease-reporting-and-surveillance/index.html</a>. Case tallies reported by CDC do not include suspect cases and cases are reported by patient state of residence rather than where the exposure occurred.
