

## Florida Arbovirus Surveillance Week 33: August 14-20, 2016

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), and St. Louis encephalitis virus (SLEV), as well as exotic viruses such as dengue virus (DENV), chikungunya virus (CHIKV) and California encephalitis group viruses (CEV). Malaria, a parasitic mosquito-borne disease is also included. During the period of August 14-20, 2016 the following arboviral activity was recorded in Florida.

**WNV activity:** Two human cases of WNV infection were reported this week in Okaloosa and Santa Rosa Counties. No horses with WNV infection were reported this week. Fourteen sentinel chickens tested positive for antibodies to WNV this week in Bay, Brevard, Leon, Pasco, and Walton Counties. In 2016, positive samples from 71 sentinel chickens, two humans, one horse, and two mosquito pools have been received from 16 counties.

**SLEV activity:** No human cases of SLEV infection were reported this week. No sentinel chickens tested positive for antibodies to SLEV this week. In 2016, one positive sample from a sentinel chicken has been received from one county.

**EEEV activity:** No human cases of EEEV infection were reported this week. One horse with EEEV infection were reported this week in Lake County. Two sentinel chickens tested positive for antibodies to EEEV this week in Leon and Walton Counties. In 2016, positive samples from 62 sentinel chickens and 19 horses have been received from 19 counties.

**International Travel-Associated Dengue Fever Cases:** No new cases of dengue fever were reported this week in persons that had international travel. In 2016, 36 travel-associated cases have been reported.

**Dengue Fever Cases Acquired in Florida:** No cases of locally acquired dengue fever were reported this week. In 2016, one case of locally acquired dengue fever has been reported.

International Travel-Associated Chikungunya Fever Cases: No cases of chikungunya fever were reported this week. In 2016, six travel-associated cases have been reported.

**Chikungunya Fever Cases Acquired in Florida:** No cases of locally acquired chikungunya fever were reported this week. In 2016, no cases of locally acquired chikungunya fever have been reported.

**International Travel-Associated Zika Fever Cases:** Sixty-four cases of Zika fever were reported this week in persons that had international travel. In 2016, 532 travel-associated cases have been reported.

**Zika Fever Cases Acquired in Florida:** Seven cases of Zika fever were reported this week in persons that had no international travel. In 2016, 37 local cases have been reported.

Advisories/Alerts: Bay, Jefferson, Monroe, Polk, Okaloosa, Osceola, St. Johns, Santa Rosa, and Washington Counties are currently under mosquito-borne illness advisory. Thirty-five counties are currently under a declared public health emergency due to the identification of travel-associated Zika infections: Alachua, Bay, Brevard, Broward, Charlotte, Citrus, Clay, Collier, Duval, Escambia, Hernando, Highlands, Hillsborough, Lake, Lee, Leon, Manatee, Marion, Martin, Miami-Dade, Monroe, Okaloosa, Okeechobee, Orange, Osceola, Palm Beach, Pasco, Pinellas, Polk, St. Johns, St. Lucie, Santa Rosa, Sarasota, Seminole, and Volusia Counties.

Florida has confirmed local transmissions of Zika virus are occurring in two small areas in Miami-Dade County. Area One is a small, less than one-square mile area in Miami-Dade County, just north of downtown. The exact

location is within the boundaries of the following area: NW 5th Avenue to the west, US 1 to the east, NW/NE 38th Street to the north and NW/NE 20th Street to the south. The department has cleared three portions within the one-square mile as no additional people tested positive in those areas. Area Two is a less-than 1.5 square mile area in Miami Beach within the boundaries of 8th and 28th streets. There is a Level 2 (Alert) Travel Health Notice from the CDC for multiple countries in the Caribbean, Central and South America, Mexico, Cape Verde, and Pacific Islands related to Zika virus transmission and an association with poor pregnancy outcomes. Pregnant women should consider postponing travel to these areas. There is a Level 1 (Watch) Travel Health Notice from the CDC for multiple countries in the Caribbean, Central and South America, and Mexico, related to the transmission of chikungunya virus. ### 2016 Human Case Summary\*

**West Nile Virus Illnesses Acquired in Florida:** A total of two human cases of WNV illness acquired in Florida have been reported in 2016; one in Okaloosa County (July) and in Santa Rosa County (August).

**International Travel-Associated Chikungunya Fever Cases:** Six cases of chikungunya with onset in 2016 have been reported in individuals with travel history to a chikungunya endemic country in the two weeks prior to onset. Countries of origin were Bahamas/Mexico, Bolivia (2), Brazil (2), and Jamaica. Counties reporting cases were Broward, Duval, Hillsborough, Palm Beach (2), and Pinellas.

International Travel-Associated Dengue Fever Cases: Thirty-six cases of dengue with onset in 2016 have been reported in individuals with travel history to a dengue endemic country in the two weeks prior to onset. Countries of origin were: Brazil (3), Colombia (2), Costa Rica (4), Cuba (7), Dominican Republic (2), El Salvador, Ghana, Haiti (3), Honduras, Indonesia, Jamaica (4), Mexico, Puerto Rico, St. Barthelemy, Singapore, and Venezuela (3). Counties reporting cases were: Alachua (2), Brevard, Broward (7), Clay, Columbia, Hillsborough (2), Manatee, Miami-Dade (8), Monroe, Orange (4), Pinellas (2), Palm Beach (2), Sarasota, and Seminole (3). Two cases were reported in non-Florida residents. In 2016, 22 of the 31 cases of dengue reported in Florida have been serotyped by PCR. Additional serotyping and strain typing are being conducted.

**Dengue Fever Cases Acquired in Florida:** In 2016, one case of locally acquired dengue fever has been reported in Monroe County, with onset in May. This case was reported in a non-Florida resident.

**International Travel-Associated Zika Fever Cases:** Five hundred thirty-two cases of Zika fever have been reported in individuals with travel history to a country or area experiencing Zika virus activity. Countries of origin were: Anguilla, Bahamas, Barbados (2), Barbados/Dominica (2), Belize (2), Bolivia (3), Brazil (6), Brazil/Bolivia/Peru, Brazil/Caribbean, Caribbean, Colombia (35), Costa Rica, Cuba (2), Curacao/Guyana, Dominica (2), Dominican Republic (104), Dominican Republic/Puerto Rico, Ecuador, El Salvador (4), Grenada (3), Guadeloupe (2), Guatemala (6), Guyana (5), Haiti (25), Honduras (21), Honduras/Guatemala, Honduras/Mexico, Jamaica (71), Jamaica/Panama, Martinique (3), Mexico (7), Nicaragua (62), Puerto Rico (101), St. Lucia, St. Martin (2), Suriname, Trinidad and Tobago (11), Venezuela (33), and Virgin Islands (3). Counties reporting cases were: Alachua (6), Bay (3), Brevard (12), Broward (90), Charlotte, Citrus (2), Clay (3), Collier (4), Duval (7), Escambia (2), Hernando (4), Highlands, Hillsborough (14), Lake (3), Lee (8), Leon (2), Manatee (2), Marion (2), Martin (2), Miami-Dade (153), Monroe, Okaloosa (2), Okeechobee, Orange (53),

Osceola (20), Palm Beach (30), Pasco (6), Pinellas (9), Polk (16), St. Johns (3), St. Lucie (5), Santa Rosa, Sarasota, Seminole (18), and Volusia (7). Twenty-four cases were reported in non-Florida residents. One Polk County case was acquired through sexual transmission. Thirty-six of the 532 cases involve pregnant women whose counties of residence are not included in the individual county totals to protect privacy. Florida has been monitoring pregnant women with evidence of Zika virus infection regardless of symptoms since January. Including the 36 pregnant cases mentioned, Florida is monitoring a total of 69 pregnant women.

**Zika Virus Infections Acquired in Florida:** In 2016, thirty-seven locally acquired Zika virus infections have been reported by Miami-Dade (34), Broward (2), and Palm Beach (1) Counties. In addition, three cases were reported in non-Florida residents. Most infections (25) were linked to a single focal area in Miami-Dade.


International Travel-Associated Malaria Cases: Thirty-one cases of malaria with onset in 2016 have been reported. Countries of origin were: Africa (2), Angola, Benin, Cameroon (2), Colombia, Democratic Republic of the Congo (2), Dominican Republic, Haiti (3), Honduras, India, Kenya, Nigeria (7), Sierra Leone (2), South Africa, Sudan, Uganda (2), and Venezuela (2). Counties reporting cases were: Alachua, Brevard, Broward (5), Duval (2), Flagler, Gadsden, Hernando, Hillsborough (3), Leon, Miami-Dade (6), Orange (4), Palm Beach, St. Lucie (2), Sarasota Counties, and Volusia. Three cases were reported in non-Florida residents.


Twenty-five cases (81%) were diagnosed with *Plasmodium falciparum*. Five cases (16%) were diagnosed with *Plasmodium vivax*. One case (3%) was diagnosed with *Plasmodium malariae*.

One horse with EEEV infection was reported this week in Lake County.






Sentinel Chickens\*




**Mosquito Pools** 


The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, 7 reports representing a total of 14 dead birds, including 1 crow and 1 raptor were received from 7 counties.

In 2016, 321 reports representing a total of 1018 dead birds (58 crows, 3 jays, 63 raptors, and 12 doves) were received from 47 of Florida's 67 counties. Please note that FWC collects reports of birds that have died from a variety of causes, not only arboviruses. Dead birds should be reported to <u>www.myfwc.com/bird/</u>.

\*\*Case tallies included in the weekly Florida arbovirus surveillance report include confirmed and probable cases for EEE, WNV infection, SLE, dengue, chikungunya, and malaria by date of onset. Suspect cases are not included. Activity is mapped by county of exposure rather than county of residence. Case definitions being used in Florida are consistent with national criteria provided by the Council of State and Territorial Epidemiologists (CSTE) and may be viewed at: http://www.floridahealth.gov/diseases-and-conditions/disease-reporting-and-management/disease-reporting-andsurveillance/index.html. Case tallies reported by CDC do not include suspect cases and cases are reported by patient state of residence rather than where the exposure occurred. Data is provided by county health departments, Department of Health Bureau of Public Health Laboratories, Department of Agriculture and Consumer Services, mosquito control agencies, Florida Fish and Wildlife Conservation Commission, medical providers and veterinarians. Equine cases are provided by the Department of Agriculture and Consumer Services.
