

# Florida Arbovirus Surveillance Week 4: January 25-31, 2015

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), and St. Louis encephalitis virus (SLEV), as well as exotic viruses such as dengue virus (DENV), chikungunya virus (CHIKV) and California encephalitis group viruses (CEV). Malaria, a non-viral mosquito-borne disease is also included. During the period of January 25-31, 2015 the following arboviral activity was recorded in Florida.

**WNV** activity: No human cases of WNV were reported this week. No horses with WNV infection were reported this week. No sentinel chickens tested positive for antibodies to WNV this week. In 2015, there have been no positive samples reported.

**SLEV activity:** No human cases of SLEV were reported this week. No sentinel chickens tested positive for antibodies to SLEV this week. In 2015, there have been no positive samples reported.

**EEEV activity:** No human cases of EEEV were reported this week. No horses with EEEV infection were reported this week. No sentinel chickens tested positive for antibodies to EEEV this week. In 2015, positive samples from four sentinel chickens have been received from one county.

**International Travel-Associated Dengue Fever Cases:** One new cases of dengue fever was reported this week in persons that had international travel. In 2015, one travel-associated case has been reported.

**Dengue Fever Cases Acquired in Florida:** No cases of locally acquired dengue fever were reported this week. In 2015, no cases of locally acquired dengue fever have been reported.

**International Travel-Associated Chikungunya Fever Cases:** Three cases of chikungunya fever were reported this week in persons that had international travel. In 2015, five travel-associated cases have been reported.

**Chikungunya Fever Cases Acquired in Florida:** No cases of locally acquired chikungunya fever were reported this week. In 2015, no cases of locally acquired chikungunya fever have been reported.

Advisories/Alerts: No counties are currently under mosquito-borne illness advisory or alert. A CDC Health Alert Network (HAN) health advisory was issued in December for the Caribbean region announcing the first locally acquired cases of chikungunya fever in the Americas. There is a Level 1 (Watch) Travel Health Notice from the CDC for multiple countries in the Caribbean related to the continued transmission of chikungunya which was updated January 13, 2015. http://wwwnc.cdc.gov/travel/notices/watch/chikungunya-caribbean

## 2015 Human Case Summary\*

International Travel-Associated Chikungunya Fever Cases: Five cases of chikungunya with onset in 2015 have been reported in individuals with travel history to a chikungunya endemic country or area experiencing an outbreak in the two weeks prior to onset. Countries of origin were: Jamaica, Nicaragua, Puerto Rico, Trinidad, and Venezuela. Counties reporting cases were: Brevard, Broward, Hillsborough, Miami-Dade, and Pinellas.

**International Travel-Associated Dengue Fever Cases:** One case of dengue with onset in 2015 has been reported in an individual with travel history to a dengue endemic country in the two weeks prior to onset. Country of origin was: Philippines. County reporting case was: Miami-Dade. The case was reported in a non-Florida resident.


**International Travel-Associated Malaria Cases:** Three cases of malaria with onset in 2015 have been reported. Countries of origin were: Cameroon, Haiti, and India. Counties reporting cases were: Broward (2) and Miami-Dade. One of the cases was reported in a non-Florida resident.

Two cases (67%) were diagnosed with *Plasmodium falciparum*. One case was diagnosed with *Plasmodium vivax* (33%).



No horses with EEEV or WNV infection were reported this week.








# **Sentinel Chickens**

The table below is for the reporting of confirmatory laboratory results from this week. Some of the samples were collected at earlier dates. The date of collection is recorded for samples collected on that day along with the total number of positives and the corresponding seroconversion rate for the week the sample was collected.


One sentinel chicken tested positive for antibodies to HJV this week in Walton County (state total of 1 for 2015).

#### **Dead Birds**

The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, 7 reports representing 19 dead birds, including 3 raptors, were received from 4 counties.

In 2015, 28 reports representing a total of 73 dead birds (16 crows, 0 jays, 7 raptors, and 0 doves) were received from 15 of Florida's 67 counties. Please note that FWC collects reports of birds that have died from a variety of causes, not only arboviruses. \*\*Case tallies included in the weekly Florida arbovirus surveillance report include confirmed and probable cases for EEE, WNV infection, SLE, dengue, and malaria by date of onset. Suspect cases are not included. Activity is mapped by county of exposure rather than county of residence. Equine cases are provided by the Department of Agriculture and Consumer Services.
