



# STATE OF FLORIDA BOARD OF PODIATRIC MEDICINE

PETITION FOR DECLARATORY STATEMENT OF ROBERT G. SMITH, DPM

#### **FINAL ORDER**

THIS MATTER came before the Board of Podiatric Medicine ("Board") pursuant to Section 120.565, Florida Statutes ("FS"), at a duly-noticed public meeting held telephonically on January 4, 2011, for consideration of the above-referenced Petition for Declaratory Statement filed November 22, 2010 by Robert G. Smith, DPM ("Petitioner"). The Notice of the Petition for Declaratory Statement was published on December 17, 2010, in Volume 36, No. 50, of the Florida Administrative Weekly. No comments by interested persons were received. Petitioner was present via telephone at the meeting and not represented by counsel. The Board was represented by Charlyne M. "Khai" Patterson, Assistant Attorney General. Having considered the petition, the Board makes the following findings and conclusions:

### **FINDINGS OF FACT**

- 1. Petitioner is a licensed podiatric physician in the state of Florida.
- 2. Section 461.003(5), FS, defines the practice of podiatric medicine, in part, as "the diagnosis or medical, surgical, palliative, and mechanical treatment of ailments of the human foot and leg. The surgical treatment of ailments of the human foot and leg shall be limited anatomically to that part below the anterior tibial tubercle."
- 3. Petitioner seeks the Board's interpretation of Section 461.003(5), FS, regarding whether the practice of offering a tetanus booster while treating chronic, non-

healing lower extremity wounds is within the scope of practice set forth in the aforementioned statute.

### **CONCLUSIONS OF LAW**

- 4. The Board has jurisdiction over this matter pursuant to Section 120.565, FS.
- 5. The Board answers the question in the affirmative, finding that the practice of offering a tetanus booster while treating chronic, non-healing lower extremity wounds is within the scope of practice for a podiatric physician in Florida.

Good Morning Florida Board of Podiatry Members:

I would like to request a declaratory statement regarding FS 461.003-5 the practice of podiatric medicine. I treat lower extremity wounds as well as act as a consult for other clinicians for lower extremity wound care. During consultation and treatments I inquire from the clinician or the patient if their tetanus immunization status is current as part of the standard of care as it applies to the treatment of chronic non-healing lower extremity wounds. In the past I have referred the patient to their primary care provider or the health department to receive a Td booster vaccine. I would like to request a declaratory statement from the board of podiatry medicine if I may offer and administer Td boosters to patients who may need this vaccine.
