- Add Rulemaking Authority and Law Implemented section of the rule.
- Change the delinquent fee for renewal to \$95.

The Council voted to accept the recommendations from JAPC and proposed to publish a notice of change for rules 64B8-41.001, 64B8-42.001 and 64B8-42.002 to clarify and add the Rulemaking Authority and Law Implemented sections and to change 64B8-41.001(9) to reduce the delinquent renewal fee to \$95.

Ms. Cooper made a motion to send amended changes to the Board of Medicine for approval Ms. Shank seconded the motion, which carried 5/0.

Ms. Cooper moved that the proposed rule amendment would not have an adverse impact on small businesses. Ms. Gammon seconded the motion, which carried 5/0.

Ms. Cooper moved that the proposed rule amendment would not be likely to directly or indirectly increase regulatory cost to any entity (including government) in excess of \$200,000 in the aggregate in Florida within 1 year after the implementation of the rule. Ms. Cooper moved that the rule amendments to rule 64B8-42.001 would not be likely to directly or indirectly increase regulatory cost to any entity (including government) in excess of \$1,000,000 in the aggregate in Florida within 5 year after the implementation of the rule.
