Ms. Buritica applied for licensure by examination. Her application was presented to the Council for review of her education and experience.

After discussion, Ms. Buritica voluntarily waived the requirement of *Section 120.60(1), Florida Statutes,* that states applications for licensure be approved or denied within ninety days after receipt of a completed application.

The Council accepted the voluntary waiver and to allow Ms. Buriticia time to supply additional and documentation and explanation of the 900 hours of supervised experience.

#### TAB 4Sabrina Stanley (Examination with Waiver)

Ms. Stanley was present.

Ms. Stanley applied for licensure by examination. Her application was presented to the Council for review of her education and experience and exam score.

Ms. Stanley requested the council to allow her to waive retaking the registered dietetics examination and accept her exam scores from 1996 to regain licensure.

After discussion, the Council determined that while *Subsection 468.509(3), Florida Statutes*, specifically allows for a waiver of the examination requirement for Registered Dietitians, neither the statute nor the rule contain any other provisions that would authorize the Council to waive the requirement that applicants for licensure take the Registration Examination for Dietitians after being certified as eligible for examination by the Council.

Ms. Rarback made a motion to deny Ms. Stanley's application for waive of the examination. Ms. Shank seconded the motion, which carried 4/0.

Ms. Rarback made a motion to approve Ms. Stanley's application for licensure by examination. Ms. Gammon seconded the motion, which carried 4/0.
