

Electronic Death Record System

- 97% of Florida death records are filed using the Electronic Death Record System (EDRS).
- The electronic Florida death record was implemented between October 2011 & October 2012.
- EDRS records are available for analysis one day after they successfully pass online edits.

Electronic Death Record System Workflow



Florida Death Records

- Certificates can be altered or amended only through the Bureau of Vital Statistics.
- Once demographic information is entered into the system, it takes about 30 days for causes of death to be added to the records.
- Out-of-state death certificates are sent to Jacksonville from other states and added to the death records as they are received.



Death Data Products

FloridaCHARTS Death Query System & the FloridaCHARTS Infant Death Query System

- Provide standard reports with counts and/or rates
- User may create custom reports using a "drag-and-drop" feature
- Provides options for downloading, filtering, and sorting data

- Updated weekly

Confidentiality



- Section 382.008, Florida Statutes states that all information related to cause of death in all death records are confidential.
- Persons accessing Florida's death data must sign an approved Data Use Agreement and agree not to share the data with anyone and to only use the data for the purpose specified in the agreement.
- Persons who sign the Agreement should only release aggregate data.
- Any breaches of confidentiality can be treated as a 3rd degree felony.

Death Codebook

- The death codebook provides details about each field in the deathmaster and deathstat files:
 - Field name
 - Data type (int, smallint, datetime, char, or varchar) and length
 - Item number on the death certificate
 - The range of years data for the field was collected
 - The availability of the field in the master, stat, or repository files
 - A brief definition of what the field represents
 - A description of what appears in the fields (names, numeric codes, dates, etc.)

Resident vs. Recorded Deaths

 To query deaths that occurred to residents of Florida (resident deaths):

 To query deaths that occurred in Florida to both in-state and out-of-state residents (recorded deaths):

County of death

Age Fields

Three fields, in combination, can be used to query a decedent's age:

- AGE: Numeric age (1-135 or 999)
- AGE_TYPE: Age unit (literal field: years, months, days, hours, minutes, unknown)
- AGE_CODE: 0=years, 2=months, 4=days, 5=hours,
 6=minutes, 9=unknown



Age Fields

 Example 1: To query deaths where the decedent was 35 years old

```
AGE = 35 and AGE_TYPE = 'years' or
AGE = 35 and AGE_CODE = '0'
```

Example 2: To query all infant deaths

```
AGE_CODE in ('2', '4', '5', '6') or
AGE_TYPE in ('months', 'days', 'hours', 'minutes')
```

Race Fields

Beginning in 2005, the Florida Death Certificate allowed for selection of multiple races.



15 Separate Race Fields: White, Black, American Indian/Alaskan Native, Chinese, Japanese, Hawaiian, Filipino, Korean, Other Races, Vietnamese, Asian Indian, Asian Other, Guamanian/Chamorro, Samoan, Pacific Islander

- There are 4 calculated fields in Florida's death data:
 - COMPUTED_AGE
 - CALCULATEDRACE
 - CALCULATEDHISP
 - INFANT_DEATH_TYPE

COMPUTED_AGE

- Allows for easy querying of the age fields
- 0-135 years, with children under 1 year of age coded to age 0
- INFANT_DEATH_TYPE can be used with COMPUTED_AGE to determine if a death record with COMPUTED_AGE 0 (zero) is either a neonatal or postneonatal death

CALCULATEDRACE: combines the 15 separate race fields into one coded field. Codes for Multi-Race and Unknown are also included:

01 = White

02 = Black

03 = American Indian/Alaskan Native

04 = Chinese

05 = Japanese

06 = Hawaiian

07 = Filipino

08 = Korean

09 = Other Races

10 = Vietnamese

11 = Asian Indian

12 = Asian Other

13 = Guam

14 = Samoan

15 = Pacific Islander

20 = More than One Race

99 = Unknown

 CALCULATEDHISP: combine the 8 separate ethnicity fields into one coded field

00=Not Hispanic and Not Haitian

01=Mexican

02=Puerto Rican

03=Cuban

05=Other or Unknown Hispanic

06=Haitian

09=Not classifiable

Beginning with 2011 data, ethnicities previously classified as code '04-Central/South American' were aggregated into '05-Other or Unknown Hispanic'.

County Fields

- Most County Code fields use numeric codes 11 to 77 to represent Florida's 67 counties:
 - RESID_COUNTY_CODE
 - FAC_COUNTY_CODE
 - LINK_BIR_STATE_CODE
 - OLD_INJURY_COUNTY
- One County Code field, CHDRESCOUNTY, uses numeric codes 01-67

Cause of Death Fields

Currently, ICD-10 is used to code Florida Deaths

- ICD_CODE underlying cause of death
- DEATHGROUP_MONTHLY 113 causes of death
- DEATHGROUP_INFANT 130 causes of infant death
- DEATHGROUP_ANNUAL 358 causes of death
- ACME Immediate and contributing causes of death in the order as listed on the death certificate
- TRANSAX Immediate and contributing causes of death reordered in a nosological sequence

OLD_TYPE_OF_PLACE

- Has experienced changes since 1970
 - 1970-2004: 1=Hospital: Inpatient 2=Hospital:
 Outpatient/ER 3=Hospital: DOA 4=Hospital: Status unknown 5=Nursing home 8=Other Specified 9=Not classifiable/Unknown
 - 1970-1986: 6=Other Institute, 7=Other Institute
 - 1987-2004: 6=Residence, 7=Other specified place
- Beginning in 2005, is now the PLACE_DEATH_CODE field

Other Old Fields

- OLD_EDUCATION_CODE is now EDUCATION_CODE
- OLD_INJURY_CITY (a code field) is now INJURY_CITY (a literal field)
- OLD_INJURY_PLACE is now INJURY_PLACE_CODE
- OLD_MANNER_DEATH is now MANNER_DEATH_CODE
- OLD_INJURY_COUNTY does not have a corresponding "new" injury county field.

Linking Death to Birth Records

- Create Birth Extract File
 - Select all Births from a particular calendar year (e.g. Event_Year = 2008).
- Create Infant Death Extract File
 - Select all Infant Deaths (age_code = 2, 4, 5, or 6) associated with a birth occurring in Florida (Birth_State_Code = 10) from the same calendar year [e.g. Link_Bir_DOB_Year in (2008, 2009); some infants born in one calendar year may die during the following calendar year].
- Match the Death_SFN field on the Birth record to the State_File_Number (or the Event_Year concatenated with Certnumber) on the Death record; *OR* match the Birth_SFN field on the Death record to the State_File_Number (or the Event_Year concatenated with Certnumber) on the Birth record.
