## Children's Medical Services Health Plan Transition Information

WellCare has partnered with the Florida Department of Health (DOH) to offer the **Children's Medical Services Health Plan (CMS Health Plan)** as of **February 1**<sup>st</sup>!

During the transition, we are required to ensure continuity of care.

- You should not cancel appointments with current CMS Health Plan patients. We will honor ongoing treatment that was authorized prior to February 1st, for up to 180 days.
- You will be paid. You should continue providing services that were previously authorized, regardless of whether you are participating in our CMS Health Plan network. We will use information provided by DOH to identify whether a member was previously receiving services. We will pay for these previously authorized services for up to 180 days.
- You will be paid promptly. We will follow all timely claims payment contractual requirements.
- **Prescriptions will be honored.** CMS Health Plan members can continue to receive their prescriptions through their current provider, for up to 180 days, until their prescriptions can be transferred to a provider in our network.

If you are a participating provider and would like to request an authorization, you may do so **online** through our portal at <a href="https://provider.wellcare.com/">https://provider.wellcare.com/</a> with your secure login. **Web submissions** are faster and if the procedure requested meets clinical criteria you will be provided an approval that can be printed for easy reference.
